The next ballot, an informal one, was cast for Street Commissioner with the following result. L. W. Wigley 2 votes and Henry Meier 4 votes. When, upon motion the ballot was made formal and Henry Meier declared duly elected.

Board then proceeded to vote by informal ballot for Village Marshall, which resulted as follows. W. M. Hawley 1 vote, Frank Schoppe 1 vote and John Meier 4 votes. The next ballot, a formal one, resulted as follows. Frank Schoppe 2 votes and John Meier 4 votes. Whereupon John Meier was declared duly elected.

Board then proceeded to vote for Village attorney, with the following result - C. H. Austin 6 votes.

W. Austin Esq. be instructed to make use of all legal facilities at his Command, to enforce said laws and Ordinances. 1st by Collecting Judgement and Costs now outstanding and unsatisfied, or by enforcing the penalty provided by law in case of nonpayment.

2nd. by vigorously prosecuting all violations of said laws and Ordinances whenever there is sufficient evidence to render conviction probable.
