The meeting was called to order at 8:07 P.M.

Mr. Robert Mueller, 13 Brinker Road, was welcomed as a new member of the Commission. He replaces Mr. Albert Lockett who resigned from the Commission in December. Mr. Cassell gave public thanks for Mr. Lockett's service to the Village.

The matter of Mr. Lucke's subdivision on Dundee Lane was considered. Mr. Younger reported the findings of the study committee. (Younger, Moseley, Hansen) Upon inspection of the property, the committee concluded that lots of approximately two acres each would be more suitable than the one acressor to proposed by Mr. Lucke. Accordingly, a sketch of a suggested revised plan was sent to Mr. Lucke's attorney, Mr. Platt. Mr. Younger expressed concern about drainage facilities (a ditch and an underground tile) on the property and the Commission agreed with Mr. Younger's recommendation for lower density in the subdivision. The Commission concluded that it would accept a compromise of something less than five acres and more than one acre sites.

Mr. and Mrs. Mizock presented a preliminary plat for a subdivision on the northeast corner of Spring Creek and Braeburn Roads. After a discussion of the drainage problem in the area, the Commission passed the following motion: "The plat is approved in principal, subject to conformance with all Village ordinances and subject to certification by the Village Engineer."

A schedule for the study of the BACOG plan was outlined. A series of public meetings eill be held at the Village Hall at 9:00 A.M. on Saturday, January 24 and Saturday, January 31. A third meeting will be held on Saturday, February 7, at 9:00 A.M. if deliberations are not completed on January 31. It was moved and seconded that a public hearing on the BACOG plan will be held on February 9 at 8:00 P.M. at the Village Hall and the secretary should see that proper notice of this is published in the newspapers. Motion carried.

Finally, Mr. Alberts, Mr. Galloway and Mr. Younger volunteered to form a committee to check certain discrepancies on the BACOG map.

The meeting was adjourned at 9:30 P.M.
