RESOLUTION FOR PUBLIC HEARING
ON AMENDMENT TO OFFICIAL
VILLAGE PLAN OF BARRINGTON HILLS

WHEREAS, the Barrington Area Council of Governments has recently approved and adopted the "Comprehensive Plan - Barrington Area Council of Governments" and desires that it be adopted by member villages of BACOG or adopted for inclusion in their existing Official Plans; and

WHEREAS, the President and Board of Trustees of the Village of Barrington Hills, Cook, Lake, Mc Henry and Kane Counties, Illinois desire to schedule a public hearing on said BACOG Plan and any resulting amendments to the existing Barrington Hills Plan before the Plan Commission, pursuant to statute in such case made and provided;

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees that the Barrington Hills Plan Commission be and it hereby is requested to hold a public hearing before it, pursuant to Section 11-12-7 of the Illinois Municipal Code, on February 28, 1976 at the Barrington Hills Village Hall, 112 Algonquin Road, Barrington Hills, at 9:00 o'clock A.M., on the BACOG Plan and any resulting amendment proposals to the existing Barrington Hills Plan adopted August 27, 1973 by Ordinance No. 73-8, and to promptly report to the President and Board of Trustees such pertinent information as shall have been derived from said hearing, together with the recommendations

of the Plan Commission, to the President and Board of Trustees.

BE IT FURTHER RESOLVED that the Clerk of the Village be and hereby is directed to cause notice of said hearing to be published in a newspaper of general circulation in that portion of Cook, Lake, Mc Henry and Kane Counties in which the Village of Barrington Hills and the contiguous unincorporated territory within one and one-half miles of the limits of said village are located, said notice to be substantially in the following form, not less than fifteen (15) days prior to the date thereof:

Notice is hereby given that on February
28, 1976 at 9:00 o'clock A.M., a public hearing will be held by the Barrington Hills Plan Commission at the Barrington Hills Village Hall, 112 Algonquin Road, Barrington Hills, Illinois, upon the direction of the President and Board of Trustees of said Village, to hear written or oral statements by any person interested in support of or opposition to an amendment to the Barrington Hills Official Plan approved August 27, 1973 (including the Official Map and the Road Network Map)

by approval and adoption of the "Comprehensive Plan - Barrington Area Council of Governments" in whole or in part or any modification thereof.

Said amendment upon adoption will be effective within the corporate limits of the Village of Barrington Hills and in contiguous unincorporated territory one and one-half (1-1/2) miles beyond such limits.

Any person interested may examine a copy of said BACOG Comprehensive Plan, including maps, in the office of the Village Clerk at the Village Hall prior to the public hearing.
