The meeting was called to order at 8:16 p.m. Minutes of June 14, 1976 were approved as written.

There being no further old business to come before the Commission, it adjourned sine die at 8:20 p.m.

The new board was called to order at 8:21 p.m. Mr. Cassell was nominated for Chairman and, upon the nominations being closed, Cassell was elected Chairman.

Mr. Galloway was nominated as Vice Chairman and unanimously elected.

It was moved and passed that the Secretary of the Commission serve without compensation other than being reimbursed for out-of-pocket expenses such as postage.

Mrs. Garre was elected Secretary

The second Monday of each month was adopted as the day of regular meetings to be held at the Village Hall, beginning at 8:00 p.m.

The policies in effect during the past year were adopted as the policies of the Commission.

Mrs. Ulich presented the final plat of the Hill Acres subdivision for approval. It appearing that all requirements had been met, it was moved and seconded for approval by the Plan Commission and transmitted to the Trustees. The motion carried unanimously.

The Committee on Fees discussed in great detail proposed Village filing fees. As each filing would require work by the Village Engineer, Village Attorney and other personnel, it was felt the present fees were inadequate. It was moved by Mr. Douglass that a filing fee should be \$250 for one lot and \$100 for each additional lot in a development. Mr. Train seconded the motion and it carried unanimously.

The Committee on Private Roads discussed their preliminary report. No action was taken.

The Committee on Peripheral Zoning deferred their report until next month.

It was the consensus of the Commission that the Village President, Trustees and Clerk be supplied with copies of the minutes of the Plan Commission.

The meeting was adjourned at 9:58 p.m.
