## MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES VILLAGE OF BARRINGTON HILLS Cook County, Illinois June 16, 1958

The regular meeting of the Board of Trustees of the Village of Barrington Hills was held at 8 PM, Monday evening,

June 16th, at the Countryside School. At the time the roll was called, the Trustees present were Mrs. Bard, Mr. Grace, Mr. Motter, and Mr. Stresen-Reuter. Mr. Caesar and Mr. Goltra were absent although Mr. Goltra arrived while the meeting was in progress.

Mr. Dallstream arrived during the meeting. Mr. Canby, Attorney, and Mr. Olson, Building Superintendent were also present, Mr. Hartmann, Treasurer, was absent.

Mr. E. S. Wyman, Penny Road, attended the meeting in order to express regret on behalf of himself and many of his neighbors that objections filed by others will prohibit annexation of that

area to Barrington Hills because of lack of contiguity to the Village.

Mr. Goltra arrived at the meeting, while the Trustees were studying the map drawn by Wight & Company, of the Village and the surrounding area. Arrangements were made for the proper Village officers to sign the map July 18th so that it can be filed with the Official Village Plan.
