## RESOLUTION ON BUILDING AND ZONING FEES

BE IT RESOLVED, that, pursuant to Section 4 of the Building Ordinance, the President and Board of Trustees of the Village of Barrington Hills, do hereby adopt and establish the following fees which shall be charged for permits for certain buildings, structures or work regulated by said Building Ordinance.

## MINUTES OF THE MEETING OF THE BOARD OF VILLAGE OF BARRINGTON HILLS June 25, 1957

A special meeting of the Board of Trustees of Barrington

Hills was held Monday evening, June 25, 1957 at Countryside School.

The tax levy will in great part be determined by the size of the Village when the levy is considered. The Board expressed the determination to keep the actual levy very light.
