

RESOLUTION OPPOSING THE RE-
ZONING OF CERTAIN REAL ESTATE
IN LAKE COUNTY, COMMONLY KNOWN
AS THE ROAKE PROPERTY

BE IT RESOLVED by the Board of Trustees of the Village of Barrington Hills, Illinois that:

WHEREAS, it has come to the attention of the Board of Trustees of the Village of Barrington Hills, Illinois that the LaSalle National Bank, as trustee, has filed a suit in the Circuit Court of Lake County against said County in Case No. 70058 to have the zoning ordinances of said County declared invalid as to the following described property:

That part of the Southwest $\frac{1}{4}$ of Section 27, Township 43 North, Range 9, East of the Third Principal Meridian, described as follows: Commencing at a point in the South line of said Southwest $\frac{1}{4}$ 1769 feet East of the Southwest corner thereof, running thence East along said South line to the Southeast corner of said Southwest $\frac{1}{4}$, the 1258.7 feet to the Southwesterly line of the right-of-way of the Chicago and Northwestern Railway Company, thence Northwesterly along said Southwesterly line 1093.5 feet, thence Southerly 1893 feet to the place of beginning in Lake County, Illinois,

and;

WHEREAS, said property is adjacent to and contiguous with the Village of Barrington Hills, and;

WHEREAS, the Village of Barrington Hills is not a party to said suit, but desires to reaffirm its position supporting the defendant in said cause in its effort to maintain the present zoning.

NOW, THEREFORE, BE IT RESOLVED by the President and the Board of Trustees of the Village of Barrington Hills that the attempt to reclassify the above-described property be and is hereby protested by said Board of Trustees and;

BE IT FURTHER RESOLVED that the Village of Barrington Hills reaffirms its support of the defendant in maintaining the present zoning classification which is the highest and best use which said property can be put to.
