I have just completed the last of three conferences with our Village Engineers and State of Illinois, Division of Highways. All conferences have been held subsequent to the attached copy of a letter from Consoer, Townsend and Associates.

I concur with the recommendation of the fourth paragraph of the above mentioned letter. I would appreciate your scheduling this count as soon after school opens as possible and that full or peak pedestrian and vehicle traffic is established. When the date for this count is assigned, please advise me immediately so I can contact Mr. Pagels, the P. T. A. and parents of students attending Middle School.

Verbal assurance has been given me by Mr. March and Mr. Kowalski of the State of Illinois, Division of Highways, that they will approve signalization of this intersection under "Revised Memorandum No. 37", based on future use of this intersection if we fail to qualify under the requirements of the Manual of Uniform Traffic Control Devices".

However, there is a known factor about questionable qualification and that is why I want to discuss this count with you and have the date of the count well in advance.

The Board is vitally concerned about this intersection because the safety of the present and future use of this crossing by students usually under the ages of fourteen and of course the heavy use of Northwest Highway by vehicle traffic. We know from past and present experience this is a vulnerable point for an accident involving a vehicle and pedestrian.

Dear Mr. Heninger:

We have examined the traffic volume counts taken by the Village at the intersection of Northwest Hwy. and Eastern Ave. and wish to answer the question asked in your letter of July 25, 1968.

According to the provisions in Revised Memorandum No. 37, your traffic and pedestrian volumes indicate that traffic signals are warranted. We are advised, however, by Mr. Kowalski of the Chicago office of the State Highway Department that their judgment on proposed traffic signals is based on the warrants specified in the "Manual of Uniform Traffic Control Devices" and that according to your count these warrants are not met.

In reviewing your traffic counts, we note that only a two-hour count was made, one hour in the morning and one hour in the afternoon. These counts indicate that possibly warrants in the aforementioned Manual would be met if the Village had taken a 14-hour count. A 12-hour minimum count must be made when determinations are made on the basis of the Manual, but it is felt that a 14-hour count in this case could possibly supply more information from which sufficient data may be obtained to indicate traffic signals are warranted.

We, therefore, recommend a 14-hour count be made between the hours of 6:00 A.M. and 8:00 P.M. on a weekday, and forms to be used in making the traffic and pedestrian counts are enclosed. A clear day should be selected. All motor vehicles should be counted. At the end of each hour the traffic count totals should be posted in the proper spaces on the form; for example, traffic from the north on Eastern Ave., the traffic count totals at 7:00 A.M. for right turns, straight ahead and

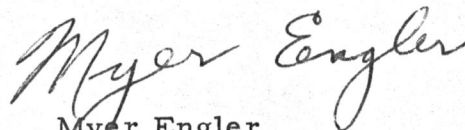
left turns should be recorded in the spaces opposite the line 6-7; at 8:00 A.M. the totals should be noted opposite the line 7-8, etc. Likewise, and at the same times, the totals should be posted for traffic coming from the other directions. All pedestrians crossing the intersection from all directions should also be counted simultaneously.

The forms should then be completed by filling in the lines showing day, date, hours, intersection, city, state, weather, counted by and remarks, and the completed forms should be submitted to this office for review and summary. We will then furnish the required data to the Traffic Department of the Chicago office of the Illinois Division of Highways as required by that office.

It probably would be advisable to make this count in September after the school season starts in order to get a maximum count.

Incidentally, Mr. Ziejewski's letter to you of July 17, 1968 indicated serious problems may result if the intersection is signalized due to the location of the C&NW Railway crossing about 100 feet south of Northwest Hwy. (U.S. 14). Similar installations exist in Arlington Heights, Mount Prospect and Des Plaines where intersections with Northwest Hwy. are adjacent to C&NW crossings. We are aware of the possible need for a railroad pre-emptor in connection with installing signals at Northwest Hwy. and Eastern, as this is required by the Manual where intersections are in close proximity to railroad crossings. It is, therefore, our opinion that if the results of the aforementioned traffic count show a warrant for traffic signals at Northwest Hwy. and Eastern, the intersection will be approved by the State for signalization. Mr. Kowalski indicated this approval in our discussion with him regarding this matter.

SUBDIVISION ORDINANCE WHERE UNDERGROUND IS REQUIRED

Public Utilities

(a) Easements shall be provided for utility service, including storm water drainage where necessary. They shall be ten feet wide and be established where practicable at the rear of each lot and along such other lot lines as to provide continuity of alignment from block to block.

(b) All utility distribution lines for telephones and electric service to be installed shall be placed underground within easements or dedicated public ways. The installation of such facilities shall be made in compliance with applicable orders, rules and regulations of the Illinois Commerce Commission now or hereafter effective, and the owner or subdivider of any property to be served from such underground installations shall be responsible for compliance with the rules and regulations, now and hereafter effective and filed with said Commission pursuant to the Illinois Public Utilities Act, of any public utility whose services will be required with respect to the provision of such underground facilities.

The following Bills passed by the Reconvened Session of the 75th General Assembly have been approved by Governor Samuel Shapiro and are now law.

As certified copies of these bills are received from the Secretary of State's Office, copies will be sent to your municipal attorney.

- Senate Bill 2000 - Authorizes municipalities to appoint part time or auxiliary policemen. The Governor vetoed House Bill 2662, which was the House version. Effective immediately. ✓
- Senate Bill 2101 - Amends an Act in relation to the construction of statutes to provide that the time within which any Act covered by this statute shall be computed by excluding Saturdays, Sundays and holidays if they are the last days. Effective immediately.
- House Bill 2609 - Provides that a city or village owning or operating an electric or gas utility plant may issue revenue bonds for improvements bearing interest of not to exceed six per cent. Effective immediately.
- House Bill 2663 - Amends the Municipal Code to authorize the establishment of a curfew in all or part of a municipality. The Act provides the procedure for a mayor or village president to exercise extraordinary emergency powers by executive order. Effective immediately.
- House Bill 2810 - Reaffirms legislative intent in the repeal of Chapter 24, Section 1-4-3. Municipal liability for mob action. Effective immediately.
- House Bill 2837 - Empowers municipalities to enact fair housing ordinances. Effective immediately.
- House Bill 2886 - This Bill provides that a peace officer, having identified himself as a peace officer, may stop a person in a public place for a reasonable period of time when an officer reasonably infers from the circumstances that the person is committing, is about to commit or has committed an offense as defined in Section 102-15 of the Code of Criminal Procedures of 1963. The officer may demand the name and address of the person and an explanation of his actions. Such detention and temporary questioning will be conducted in the vicinity of where the person was stopped.

✓ A---Proposal to Form Library District: Notice has been received and signed by the Village President, which indicates that the Board of Directors of the Barrington Public Library intends to pass a Resolution that will initiate the creation of a Barrington Library District identical in area with the Village of Barrington corporation. Creation of a Library District would facilitate annexation of areas now outside the village boundaries to the Library service area.

✓ B---Waste Water Treatment Plant Expansion Approval: Lake County Regional Planning Commission, in letter dated August 23, 1968 to the Northeastern Illinois Planning Commission, which is reviewing the Barrington project, has given its approval (see copy of letter).

✓ C---Part Time or Special Police Law: Senate Bill 20000, recently passed by the Illinois Legislature, has been signed by Governor Shapiro. The new law permits the appointment of part time or auxiliary police officers by the Village of Barrington. The Illinois Municipal League is forwarding a copy of the law to the legal consultant. The Village Board may wish to abolish the office of marshal and deputy marshalls and return to the former arrangement of Special Police within the limitations of the new Law.

✓ D---Bid Opening Announced for Panker Restaurant: According to Dodge Construction News of August 20, 1968, bids are to be opened August 28 by involved parties for the construction of the Panker Building at the northeastern corner of Cook and Railroad Streets. The estimated cost for the business and apartment structure is \$400,000.

✓ E---Liquor License Suspension: The time for a five-day suspension of Class D liquor license held by Steven and Robert Mitana, at the previous village board meeting given as Sept. 2 to 6 inclusive, has been changed in the Suspension Order of the Local Liquor Control Commissioner, to Sept. 9 through 13, 1968, inclusive, to allow the Licensee the necessary legal time of 20 days from date of Suspension Order should he desire to appeal to the State Liquor Control Commission.

✓ F---Illinois Municipal League Annual Conference: The Illinois Municipal League will hold its annual conference in Peoria on Oct. 12, 13, 14 and 15, 1968. Village President Blanke and Mrs. Blanke have made their registration and will stay at the Pere Marquette Hotel. President Blanke is a member of the League's Legislative Policy Committee and of the Conference Resolutions Committee. Attorney Braithwaite and Village Manager R. D. Heninger have indicated that they will attend the conference. Since the regular village board meeting is scheduled for a conference day, Oct. 14, 1968, it may be that the Board of Trustees desires to postpone said meeting date, say to Tuesday, Oct. 15 or Wednesday, Oct. 16 to insure a quorum attendance. It has been expressed that village trustees ought to attend the League conference at Peoria.



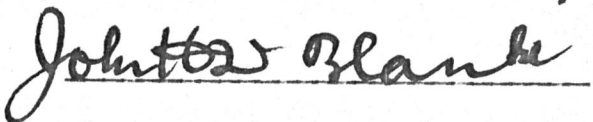

Dear Mr. Fitzgerald:

We are in receipt of the application of the Village of Barrington for a Federal Grant for sewage treatment works (NIPC project #086). We understand this to be an application for expansion and improvement of present treatment facilities for the Village.

As you know, Lake County has no adopted plans for sewage disposal on a County-wide basis.

Since 1962 the County has had a plan for sewage disposal which has not been adopted. This plan along with the plans of other public agencies is under consideration and revision at this time. We expect to have an adopted plan in the near future.

In comparing Barrington's proposed improvement with the County's plans we find that they are not in agreement. Ultimately, the County is planning for one large treatment plant on the Fox River serving the southwestern portion of Lake County. Along with this, we would like to see the abandonment of small municipal and private treatment plants. Ultimately, this will result in a higher level of service to the people in this area and will provide greater stream pollution control than would be possible with several small plants.

Unfortunately, the County is not in a position to advance the southwestern project at this time. In view of the urgency of improving the quality of treatment in the Barrington plant we feel that the application should be approved. We also like to point out that the improvement is based on a very short (10 years) design. We

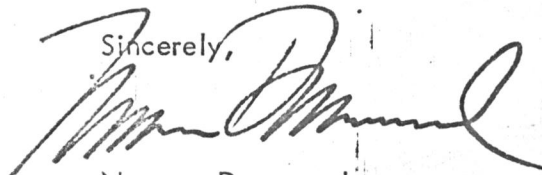

AN ORDINANCE AMENDING THE PROVISIONS OF  
SECTION 14.1001 OF THE MUNICIPAL CODE  
OF BARRINGTON OF 1957  
(VILLAGE CODE AMENDMENT)

ORDINANCE NO. \_\_\_\_\_

BE IT ORDAINED by the President and Board of Trustees of  
the Village of Barrington, Cook and Lake Counties, Illinois,  
that:

SECTION 1: Section 14.1001 of the Municipal Code of  
Barrington of 1957, as amended, is hereby further amended to  
read as follows:

"14.1001 License required.) It shall be unlawful  
to engage in a business of tree removal, tree trimming,  
tree spraying or tree treatment in the Village  
without first having obtained a license therefor.  
The annual fee for such license shall be TEN DOLLARS  
and application shall be made in compliance with  
the general provisions of the municipal code of  
Barrington relating to licenses and permits. No  
such license shall be issued to anyone not having  
a license from the state as a tree expert."

SECTION 2: This Ordinance shall be in full force and  
effect from and after its passage, approval and publication  
as provided by law.

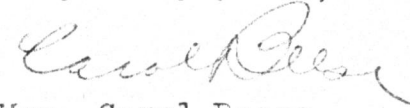

WHEREAS, the question of enacting the variation, hereinafter provided for, to the Zoning Ordinance of the Village of Barrington, was referred to the Zoning Board of Appeals of this Village to hold a public hearing thereon, and;

Our proposed program for grouting and pressure sealing should alleviate item No. 3 somewhat.

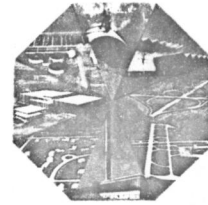

Pursuant to the request of the Board, we have investigated, analyzed and report herein on the condition of the existing sanitary sewers in the vicinity of Russell Street at Summit Street. The authorization for this report was deemed necessary after a request for rezoning of adjacent property was presented to the Board. We are advised that residents in the area have been experiencing periodical basement flooding during times of high intensity rainfall.

The closed circuit TV inspection made by National Power Rodding Corporation indicates that the sanitary trunk sewer in Summit Street from Russell Street northerly to Main Street is in satisfactory condition. Although there are several points in the sewer that seem to be questionable as far as ground water infiltration is concerned and despite the fact that the sewer has settled in places, we are of the opinion that the sewer is structurally stable.

Observations by members of our staff during a recent storm revealed the following pertinent points:

1. Dye which was placed in a flowing gutter at the intersection of Spring Street and Russell Street was observed flowing in the sanitary sewer at this intersection, and this indicated a cross-connection between the storm and sanitary systems somewhere in this location. Its exact location, however, is unknown.

2. The flap gate valve in the sanitary sewer manhole at the intersection of Russell Street and Summit Street was in an open position which could possibly permit the cross-connection to operate in reverse and thus result in storm water backup into the sanitary sewer system.
3. The entire 12" sanitary trunk sewer in Summit Street northerly from Russell Street was surcharged. This would indicate an abnormal amount of storm water entering into the sanitary sewer system.
4. It was observed that the vast majority of houses on Summit Street have downspouts connected to underground piping. ✓

Of the above points, No. 4 seems to be highly suspect. The sanitary sewers in Summit Street, as in some of the older parts of the Village, were originally constructed as combined storm and sanitary sewers. This would seem to indicate the strong possibility that when the storm drainage systems were installed the downspouts were not disconnected from the footing drains, which more than likely lead directly into the sanitary sewer service.

We are of the opinion, which has been expressed many times over the years, that a great deal of the storm water entering the sanitary system can be eliminated by initiating a Village-wide program of disconnecting downspouts and sealing the underground drains. We strongly recommend that downspouts be directed onto splash blocks to provide overland flow to the existing ditches, gutters and eventually to the storm sewer system.

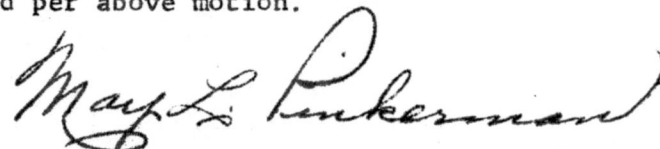

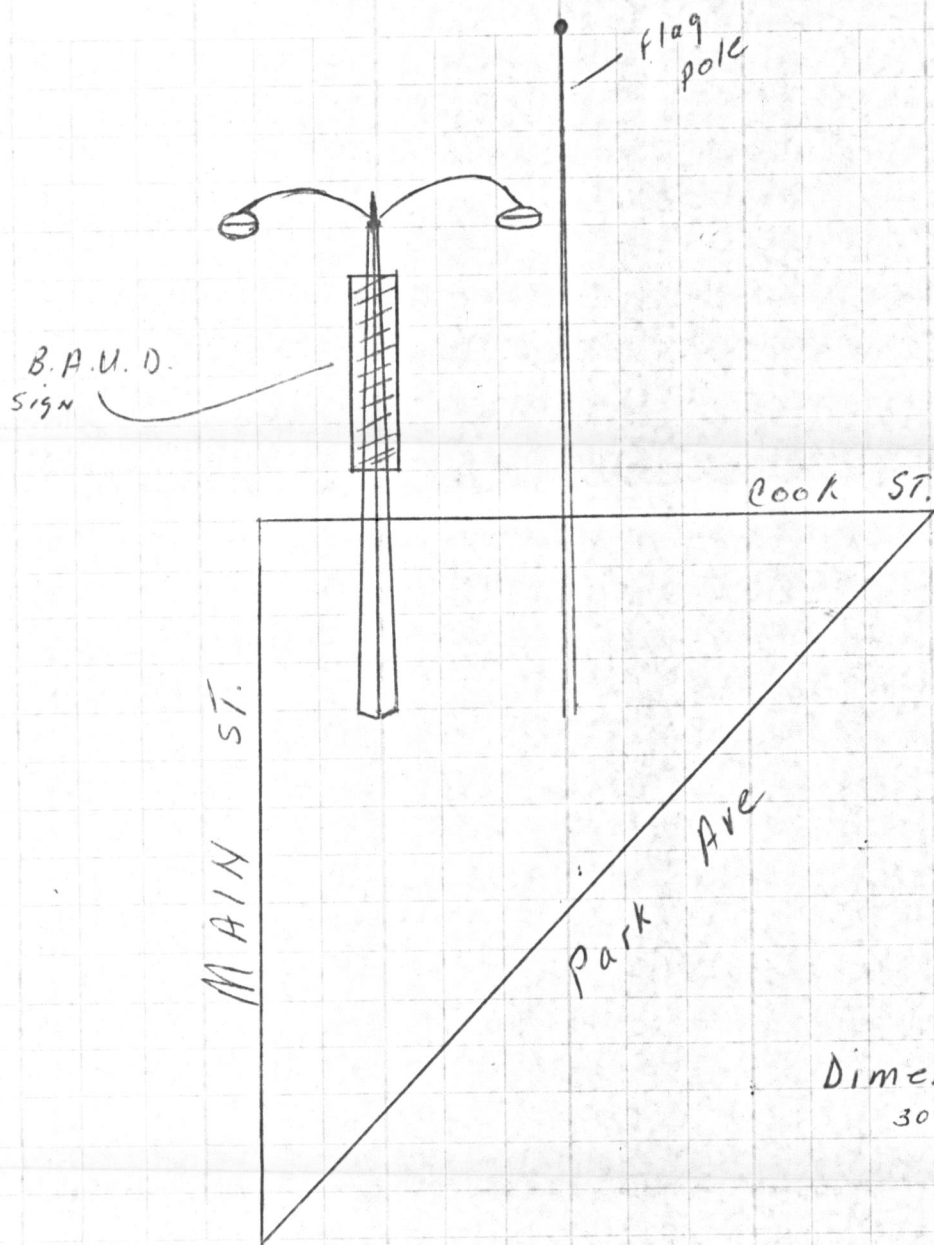

Dear John:

I know you have had other compliants from the residents of our area in the Village about the blockage which exists of the creek between the Northwest Highway and the E. J. & E. RR, but I would like to add my voice to the other protests you have received.

As you know our home is adjacent to this creek and we have plantings, air conditioning equipment and other items situated near the creek which can be endangered by a rise in the water level above normal in addition to problems that could be created for the basement of our home. Thus the abnormal and sudden rise of the creek during the last violent rainstorm caused us some apprehension and were the storm an extended one it could have caused us damage.

So I visited the blockage area today (August 10th) and found that in constructing the garage foundation walls as close to the creek as the builder did, he caused a large amount of clay material, tons of it, to close off the west half of the creek so that the passage way has been reduced to one half of the passage way at the bridge on Elm Road. It seems to me that since you folks issued the building permit to this outside developer you owe it to us taxpayers to make him restore the channel to its normal and historical width in order to ease our minds of the danger of damage to our places along the creek. If you can't accomplish this by an order you can certainly have that order enforced by having your police close down construction operations until your order has been carried out.

So, John, it is my hope that you get this problem solved because a real extended period of violent rain as we have had from time to time over the past years could result in some damage claims to the Village from property owners over here who may suffer from flooded basements and other types of damage.

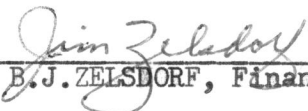

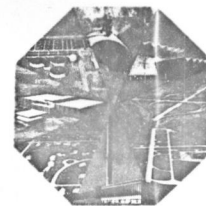

Pursuant to your letter request of August 2, 1968, we have reviewed the revisions submitted by Wight Consulting Engineers for providing an alternate method of storm water disposal at the intersection of Cornell Ave. with Barrington Rd. The project plans that were approved by the Board of Trustees included the installation of a 60" internal diameter storm water culvert north and south across this intersection on the east side of Barrington Rd. The revised plans have changed this proposed construction to an 18" internal diameter storm water culvert from the south, draining into a 36" internal diameter culvert which goes under the roadway and then connects to an existing box culvert at a point approximately 150 feet north of said Cornell Ave. We understand that this change has been requested by the Illinois Division of Highways, District 10.

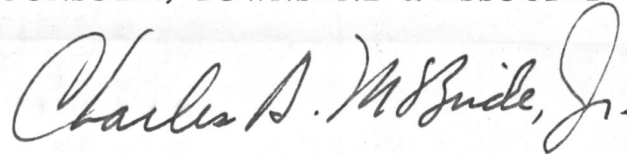
During our original plan review we concurred with the Consulting Engineers' recommendations for the installation of a 60" internal diameter culvert pipe at this location. In our opinion, this size was sufficient to drain the entire tributary area, completely developed, coming to this point from the southeast, said area being in excess of 100 acres. The proposed revision provides for a much smaller diameter storm water sewer to drain the same area. We are of the opinion that the effect of this will be that at some time in the future, when either partial or full development of the Southgate area has taken place, the storm water runoff from the fully developed area will be of such magnitude that it will not be conveyed by this smaller diameter pipe. Depending on the character and extent of development in this watershed, certain areas could suffer inundation to varying degrees.

We, therefore, recommend that this problem be referred to your legal consultant for an opinion on Village liability if future inundation should occur. On a strictly engineering basis, we do not recommend approval of this revision.

Gentlemen:

We have reviewed the material submitted to us by Mr. R. D. Heninger, Village Manager, under letter dated July 15, 1968, regarding the installation of watermain through the peat area on Cook St. We do not disagree with the proposed method of protecting the watermain from corrosive chemicals in the soil by the installation of magnesium anodes. However, prior to approval of the criteria determined by the cathodic protection organization, we would like a chance to review their material.

Although your proposed method of joining the pipe with Dresser couplings will give more resistance to the pipe pulling apart than a standard "push-on" type of joint, we still feel that this will be insufficient to overcome the suspected bad soil conditions. The structural integrity of the proposed watermain installation through this peat area is extremely important. Your letter of July 3, 1968, to Mr. Heninger, does not, in our opinion, satisfy the basic question mentioned in our letter of May 6 to you, "can the watermain be constructed through this area of unstable soil conditions in a manner which will insure a normal life expectancy with a minimum amount of future maintenance?" Several months ago we requested that you arrange to have a competent soils specialist make soil borings in the area to determine the exact nature and extent of the subsurface soil conditions. To date, we have not received this information. Our experience with construction of underground facilities in unstable soil conditions dictates that we must hold firm to our position as stated in our letter of May 6.

May we take the liberty of pointing out that this watermain will be the singular source of supply for the proposed Southgate Development until such time as a loop system is completed for the area. This one fact, in our opinion, would indicate that every possible precaution must be utilized for the installation of this watermain for the continued successful operation of water users in this development.

If you feel that the information requested above cannot be supplied to this office, may we again suggest that you investigate an alternate route for this installation.

WHEREAS Member Municipalities are so located in relation to each other that it is to the advantage of each such participant to extend aid to the others in respect to police services, and

WHEREAS it is recognized that in certain situations the use of police officers to perform police duties outside of the territorial limits of the municipality where such officers are legally employed may be desirable and necessary in order to preserve and protect the health, safety and welfare and morals of the public, and

WHEREAS participants herein deem mutual aid police services to be in the best interest of the municipality,

NOW THEREFORE IT IS MUTUALLY AGREED between the parties as follows:

1. Authorization. Each member municipality does hereby authorize and direct its police chief or the officer commanding in his absence to render and request mutual police aid to and from other member municipalities to the extent of available personnel and equipment not required for adequate protection of the municipality rendering aid. The judgment of the police chief or officer commanding in his absence, of each municipality rendering aid, as to the amount of personnel and equipment available, shall be final.

2. Power and Authority. Police officers who shall be commanded by their superior authority to maintain the peace or perform police duties outside the territorial limits of the city or village which regularly employs such officers, shall be under the direction and authority of one person designated by all police chiefs of participating municipalities, such person shall in turn be under the direction and authority of the local commanding police officer of the municipality to which they are called to perform police or peace duties, and shall be peace officers thereof; they shall have all powers and authority of police and peace officers as provided by law, including the power of arrest.

3. Compensation. Mutual aid police service shall be rendered without charge to a member municipality; provided, however, that as a result of having furnished aid, should the assisting municipality be required to seek assistance from another nonmember municipality, which imposes a charge for same, then in that event, the municipality originally seeking such aid shall reimburse the assisting municipality in the amount equal to the charge imposed upon the assisting municipality by the municipality assisting it.

4. Liability. All wage and disability payments, pension and workmen's compensation claims, damage to equipment and clothing, and medical expense shall be paid by the City or Village regularly employing such police officer. In addition to the foregoing, each City or Village regularly employing such police officer shall be liable to its police officer pursuant to the provisions of Section 1-4-6 of the Illinois Municipal Code.

5. Waiver. Every participant herein waives as to each and every other participant hereto, any and all claims against the other participant for compensation for any loss, damage, personal injury or death, that shall arise in consequence of the performance under this Agreement. No participant hereto shall, under any circumstances, be held liable for any loss or damage by reason of its failure to effectively combat or handle any police problem in the territory of the other party.

6. Rules and Regulations. The police chiefs of the member municipalities shall establish uniform rules and regulations for giving and receiving aid, which shall be subject to the approval of each governing body. A copy thereof shall be filed with the clerk of each member municipality. The rules and regulations may be revised and amended from time to time by the police chiefs upon their unanimous agreement, subject to the approval of each governing body, and a copy of each revision or amendment shall be filed with the clerk of each member municipality.

7. Effective Date of Agreement. The clerk of each member municipality shall furnish a certified copy of its resolution approving mutual aid police service to each of the member municipalities. Each resolution shall become effective as and between municipalities who exchange identical resolutions upon the date of such

exchange. The adoption and filing of the resolutions shall constitute an agreement between all member municipalities for mutual aid police service.

8. Termination. The agreement evidenced by the filing of certified copies of resolutions with the clerk of each municipality shall remain in full force and effect until such time as a municipality files with other member municipalities a certified copy of a resolution terminating this agreement, which date of termination shall not be less than thirty (30) days after the date of filing a certified copy of such resolution with the clerk of each member municipality.

Dear President and Members:

The Barrington Chamber of Commerce is represented here this evening for what we feel is the general welfare of this community. The Chamber, as you know, is composed of business, industry, and professional men and women earning their livelihood in Barrington. What happens to Barrington is of great importance to them, as it is to all other citizens of our community. The problems of our area are mutual problems of both property owners, businessmen, and renters. We must work together to solve these problems.

Right now, as each of you knows, we are confronted with a critical need for expanded parking facilities. Recently expansion of meters into some residential areas was started to help solve this problem. Some of the residents in these areas have formally objected to the Village Board about this matter.

Looking at the problem objectively, we realize that metered parking in front of one's residence could be objectionable, but let's consider a few additional facts.

These areas are all adjacent to or contiguous to our central business area. The probabilities are that this will be the next extension of our growing business community. In time these homes will probably be razed for further business development and off-street parking. While the current proposal to install parking meters might appear to downgrade the area, in the long run it should greatly enhance the total value of these properties.

Let's look at what the business community means to the village in the way of revenue and thus, reduced taxes to property owners:

1. The 3/4% sales tax revenue is estimated to be \$200,000 in 1968-69 compared to \$126,000 in 1966-67 and \$170,000 in 1967-68. The \$200,000 equals 44% of Corporate fund revenues and 20% of total estimated revenues including

billings for services such as sewer and water. Certainly without this, our village taxes would soar. So we need to protect this source of income.

2. Without additional parking, the sales tax revenue will not grow at the same rate as our population or the village budget and thus will become a smaller per cent of total revenues. Our fear is that inadequate parking will drive prospective businesses to other communities, thus depriving us of not only the sales tax, but also real estate and personal property taxes.

We must cooperate with one another to correct problems that a growing community brings. (That old phrase) - In unity there is strength.

The business community is here to serve you. We are not trying to hurt but to help our village prosper and grow into the kind of American community we like. There are times that certain unselfish sacrifices must be made by each one of us toward building a good, balanced community.

The Board of Directors of the Barrington Home Owners Association at a meeting held June 27, 1968, discussed and considered the installation of parking meters in the residential areas surrounding the business district.

There appear to be many disadvantages in this program, some of which are:

The obstacle of snow removal, except after business hours, which could present a problem after a full day of snowfall, with cars parked for eight hours during the day.

The inability of the owner and occupant of the premises, before which a meter has been installed, to park his own car.

The increased hazard of fire equipment operation by making one-lane streets out of some streets contiguous to the business district.

The imposition of unfair discrimination in the use of residential property frontage of owners and occupants of homes, in certain areas only, for public parking.

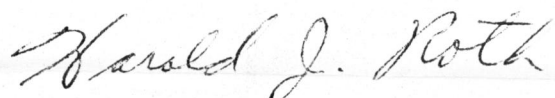
It has been indicated to us that this parking extension program is primarily for the accommodation of employees of businesses in the downtown Barrington area. In some cases it would also be convenient for commuters to park at these meters.

Merely making an objection and voicing criticism does not help the Board solve the problem in which we are all involved. We therefore suggest, through your efforts and the combined efforts of other organizations, that we work with the Village Board under its direction in developing a program for off-street parking.

We shall be very happy to cooperate to the fullest extent, and will appreciate the opportunity to do so.

MINUTES OF MEETING OF PRESIDENT & BOARD OF TRUSTEES HELD  
JULY 22, 1968 at 8.00 P.M.

MEETING CALLED TO ORDER by Trustee Paul J. Shultz who asked pleasure of Board since President Blanke was in Washington. MOTION Trustee Voss that Trustee Shultz be appointed President Pro tem; 2nd Trustee Hollister. Ayes.

ROLL CALL: Present were Trustees Paul J. Shultz, J. Frank Wyatt, Frederick J. Voss, James F. Hollister, Earl M. Schwemm. (Trustee Capulli arrived later) Also present: May L. Pinkerman, Village Clerk; R. D. Heninger, Village Manager; Leroy Tornquist, Attorney, representing Attorney Braithwaite.

INQUIRIES INVITED FROM AUDIENCE: Mr. George Dietrich, 308 Grove Ave. reviewed installation of parking meter posts in his area matter adding that prior to that there had been a 2-hour parking sign there which was removed; requested replacement of sign in the 300 block on Grove Ave. He added the same cars are parking there every day; was advised Village Manager and Chief of Police are working on survey and recommendations to Board; Manager will check the above information. Trustee Voss suggested ordinance on 2-hour parking be checked and enforced by Police Dept. Trustee Hollister suggested sign be replaced here and elsewhere in town where necessary old signs be replaced.

EDWARD M. HATTON, 348 Beverly Rd. stated he was representing himself and had been requested by an officer of the Home Owners Assoc. to inquire about status of improving hazardous conditions in undeveloped area of Barrington Meadows. Manager Heninger reported matter now in hands of Attorney for Village with pictures of the dirt piles, shack, etc.; legal recommendations awaited. It was asked if we could move in and do the work (by Trustee Voss.) Atty. Tornquist advised first it would have to be declared a nuisance and stated Atty. Braithwaite is working on it. Manager Heninger has written both "supposed" owners at which time did not know the ownership was in litigation. President Protem Shultz advised the Attorneys will follow thru on this and answer expected from Atty. Braithwaite upon his return to office Thursday.

FRANK PEDERSON, 731 Grove Ave.: asked if Village had ordinance on cats? President Protem Shultz suggested the Police Dept. be contacted to have animal impounded if necessary. Manager Heninger advised there have been many attempts in Springfield to get legislation on cats but did not think any had gone thru. Trustee Voss suggested research on this to find if cats could or should be innoculated.

Mr. Pederson reported on a repair shop on Grove Ave. where they are still repairing buses. Manager Heninger stated he had spoken to Chief Muscarello on this, the file will show it was investigated. Mr. Pederson stated repair work goes on there daily and he continues to get calls from area residents. Manager Heninger said he was advised the bus operations were just oil changes being made. Mr. Pederson added he had observed buses without wheels in the yard being worked on.

TRUSTEE CAPULLI ARRIVED AT THIS POINT.

Manager Heninger was requested to have Chief of Police investigate further, have violations noted and originate a letter to the owner warning him that zoning does not permit this type of activity and, if necessary, take action. It was suggested operations be checked several times a day for several days.

Also, Mr. Pederson stated he found many cars parked incorrectly on hills - as a driving instructor he is aware of State laws on this & noted this is not enforced.

HAROLD LIPOFSKY. 203 W. Lincoln Ave. read letter from Chamber of Commerce of 7-22; filed original with Village Clerk, re extending of parking meters into residential areas that abut business district. Trustee Capulli asked if 2-hr. parking, if



enforced, would work out? Would not approve 5-hr. meters there; when parking lots are fully used he might be willing to take another look at it for longer parking periods. Matter under study by Village Manager, Chief of Police and Planners. 2-hr. parking enforced vs meters was discussed. Mr. Lipofsky felt enforced parking would be good. Copies of letter to be sent to Trustees.

HAROLD ROTH, 619 Bryant Ave. stated Barrington Home Owners Assoc. feel they have been and are being infringed upon with meters being thought of in residential areas. The Association has offered and again offers to help in solving these matters. President Protem Shultz stated all suggestions and ideas will be pooled and evaluated. Copies of earlier letter filed by BHOA to be sent Trustees.

RALPH TOPPLE, 422 N. Hough St. inquired re status of his complaint against Miller Motor Service, Inc. Manager has written to Attorney on this and Atty. Tornquist stated they have prepared forms to be used in the violations of either State or Village laws that can be signed by private citizens. Mr. Topple stated there would be no problem getting them signed and he would personally so do. It was asked if the Company had been approached to clean up area - letters sent but no response received.

FOX POINT UNIT #7 SANITARY SEWER EXTENSION: Manager Heninger reviewed his recommendation of 7-19-68. MOTION Trustee Wyatt to (1) authorize Consoer, Townsend & Assoc. to review plans and specs relative to the installation of sanitary sewers to serve Unit #7, Fox Point Subdivision in Village of Barrington, subject to deposit of \$10,423.03 in escrow in accordance with a letter dated 7-16-68 from Village Engineers, Consoer, Townsend & Assoc. & (2) to authorize Village Manager to execute permit applications to State of Illinois Sanitary Water Board to install Sanitary Sewer to service Unit #7 Fox Point Subdivision, Barrington, Illinois; 2nd Trustee Hollister. Roll call-Ayes:Capulli,Shultz,Wyatt,Voss,Hollister,Schwemm.

SHORT HILLS SUB. IMPROVEMENTS: Manager Heninger stated plans have been examined by Consoer, Townsend & Assoc. and recommended for approval. Mr. Harold Morgan, developer, spoke about street lighting and it was decided gas lights would be acceptable. Mr. Morgan said he felt responsible for the west half of Forest Drive with Glenacres (Mr. Lageschulte) being responsible for east half and felt half escrow for that road should be put up by Mr. Lageschulte; also that half for part of Shady Lane and the cal du sac would be Morgan responsibility. Roll call-Ayes:Capulli,Shultz,Wyatt,Voss,Hollister,Schwemm. Village Manager was asked to contact Mr. Lageschulte on this by Trustee Voss. Mr. Morgan thanked the Board for all courtesies extended and commended Manager Heninger for his assistance.

PUBLIC SAFETY BLDG. OUTSIDE IMPROVEMENTS: Manager Heninger reported bids were opened July 19th; only one received from Eric Bolander Constr. Co. Libertyville, in amount \$33,019.00 with cashier's check attached in amt. \$3500. Mr. McBride distributed copies of bid sheet and his letter of 7-22-68 advising this could be readvertised and another type base could be specified which might draw more bids. Discussion on whether or not bidder could be invited in for consultation, also, since job has been advertised already would it be possible to negotiate with private contractors ourselves? Atty. Tornquist to check Statutes on this. MOTION Trustee Voss that the bid of Eric Bolander Constr. Co. of Libertyville, Ill. be rejected and that their bid deposit check be returned; 2nd Trustee Hollister. Ayes. MOTION Trustee Voss to authorize Consoer, Townsend & Assoc. to prepare bidding notice for Village Clerk to advertise for bids for the Public Safety Bldg. parking Lot Improvements No. 67-280 for August 1st, if possible, and if not, August 8th with bid opening time to be one week; 2nd Trustee Hollister. Ayes.

SCAVENGER SERVICE CONTRACT: President Pro tem Shultz asked for comments. Manager Heninger reported he had been in contact with Barrington Trucking Co. on several matters including this contract; among the items that have come up is the fact there are 240 water customers not getting any type of scavenger service and he felt ordinance should be checked into as should the entire matter. Suggested by Trustee Wyatt that perhaps this could be handled or paid for by a tax levy rather than under present method - while we might be doing that it may be necessary to extend contract for one year if Board should agree. It was felt there are some things going on that are not satisfactory. Trustee Voss suggested Manager contact other Villages on what they do and come up with a report. Discussion on whether or not it could be covered by a tax thereby giving service for whole town. It was suggested (1) to get specs so it does cover entire town & (2) can we pay for it by special tax? It was noted there are other services in town besides the one and two family units under contract that include multiple family, business, commercial, industrial, etc. Trustee Wyatt suggested Manager contact Skokie for their method since their system is considered very good. Question: can we get this review done in time to handle contract & take whatever steps we want to for future? During discussion mention was made of possibly cancelling contract and preparing plans and specs for bidding. Also suggested tax - how would it be levied? Atty. Tornquist mentioned on set valuation of property which was questioned as to fairness. Manager Heninger stated he would prepare a report.

SIGNALIZATION ON U.S. 14 at EASTERN AVE.: "Informational" from Manager Heninger discussed; Dist. #10 will not allow signals at this point; it was understood approval was previously given by the State and Manager feels they should reconsider their recent decision, suggesting meeting between Mr. March, Dist. Eng., Board members, Members of School Dist. #4, Mr. Pagels, Principal Middle School, Parent-Teachers Assoc., plus any other organizations wishing to attend. Manager was asked by President Pro tem Shultz to plan such a meeting. MOTION Trustee Wyatt that Village Manager be and hereby is authorized to set up meeting as indicated in his letter of 7-22-68 of all people listed therein and notify all parties involved to attend such meeting; 2nd Trustee Hollister. Ayes. Further discussion on a possible Resolution or a trip to Springfield if found necessary. Mr. R. Crumrine stated he has pictures showing activity at this crossing and was asked to bring them to such a meeting.

Invitation again extended to audience to bring any matters before Board. (No response heard.)

TRUSTEE SCHWEMM: stated, as a new Trustee, he is impressed with the fine documents received from the various departments and copies of letters, etc. that keep Board members so well informed; believes community as a whole has no idea of the good communications between departments and officials.

As a Board member and a citizen he would like to see pride taken in the outward appearance of our town noting some improvements were made in the parking lot he mentioned last meeting; felt owner of property in the center of town where the former Country Cupboard stood should be contacted about cutting weeds there.

TRUSTEE HOLLISTER: Nothing to report at this time.

TRUSTEE VOSS: felt letter from Henry Schneider, signmaker, contained very good suggestions and MOTIONED that a copy of letter from Mr. Schneider of 7-7-68, regarding proposed sign ordinance, be transmitted to Village Attorney with directions that he include in proposed ordinance recommendations set forth in letter; 2nd Trustee Wyatt. Ayes.

AUDIT REPORT to be received in August.

MICRO-FILTERS: Trustee Voss advised Mr. McBride he had invited a representative to visit Mr. Brask at Consoer, Townsend & Assoc. offices-probably tomorrow.

SPECIAL PURPOSE FUND MEMO: Discussion had.

TAX LEVY ORDINANCE: Trustee Capulli suggested that on P.2 the subtotal under "Municipal Buildings" be changed to \$13,000.

FIRE EQUIPMENT: Trustee Wyatt stated his understanding was question of whether this item should be considered another year rather than this year. Trustee Voss: If it goes in this year it will be 2 years before we get money and we should get started. Manager noted it is in the Appropriation Ordinance and Budget and further explained it would provide for \$27,000. each year and in 3 years of same action we would have \$80,000. for purchase of desired equipment recommended by Fire Dept.

TRUSTEE SHULTZ referred to Page 5 of the Levy Ordinance - item #430 - for discussion. Asked if Board should meet to review Tax Levy Ordinance for any reason? It seemed felt not unless specifically desired. Suggested deferring motion on this for further study. Trustee Voss felt it should be discussed before passage is ready. Matter deferred until next meeting.

TRUSTEE WYATT: handed two newspaper articles to Village Manager concerning Police Departments and suggested matter be taken up with Police Commission for further study; Village Manager will review this.

TRUSTEE CAPULLI: Motioned to adjourn - withdrawn.

TRUSTEE VOSS: suggested perhaps if on Wednesday night a happy result happens we should be prepared to call a special meeting if necessary.

TRUSTEE SHULTZ: reminded there are 2 ordinances pending (1) Teenage Center and (2) Amendment to Multiple Housing.

TRUSTEE HOLLISTER: asked Board and Village Manager to stay for few minutes to discuss a property acquisition matter.

MEETING ADJOURNED at 9.50 P.M. on MOTION Trustee Wyatt; 2nd Trustee Hollister. Ayes.

RE: REGULATION OF DOMESTIC CATS

The Illinois Statutes require dogs to be inoculated against rabies every calendar year, but do not require the inoculation of cats. Any municipality, however, has the power to control and regulate "other animals", which means any animal other than dogs which may be affected by rabies. Dr. Brewer of the Anti-Cruelty Society informed me that cats can have rabies, but he is not personally aware of any municipality which, by ordinance, requires the inoculation of domestic cats.

Under the express authority given by Statute, the Village has power to control and regulate cats and, therefore, may pass an ordinance requiring cats to have rabies shots.

MEMORANDUM

TO: VILLAGE MANAGER, VILLAGE OF BARRINGTON  
DATE: July 9, 1968  
RE: MINIMUM HOUSING STANDARDS

The Municipal Code of Barrington does not contain a definition of habitable dwelling. However, it does define the term "dangerous building" in Section 19.201 as follows:

"The term "dangerous building" is hereby defined to mean . . . (a) any building, . . . which is dangerous to the public health because of its condition, and which may cause or aid in the spread of disease, . . . (b) any building . . . which, because of faulty construction, age, lack of proper repair or other cause is especially liable to fire and constitutes or creates a fire hazard; (c) any buildings, . . . which by reason of faulty construction or any other cause, is liable to cause injury or damage by collapsing . . . (d) any building, . . . which because of its condition or because of lack of door or windows is available to and frequented by male factors or disorderly persons who are not lawful occupants of such structure.

Any such dangerous building in the Village is hereby declared to be a nuisance."

Under the provisions of Chapter 19 Article II it is unlawful to maintain a "dangerous building." If the building commissioner, fire marshal or health officer is of the opinion that any building or structure in the Village is a dangerous building he shall file a

written statement to that effect with the Village Board. This Section further provides for notice and abatement for any violation. The penalty for a violation shall be not less than \$1.00 nor more than \$100.00 for each offense and a separate offense shall be deemed committed on each day on which a violation occurs or continues.

Article VIII of the Municipal Code provides for the minimum planning and construction requirements for residential buildings within the Village. However, it would appear that this Section gives the Village protection for defects in new construction rather than existing construction.

Section 22.101 provides that it is unlawful to occupy any residence unless such residence is equiped with an adequate sewerage disposal facilities. If such premises abut on a street, easement or public way in which is located a municipal sanitary sewer such premises must be connected with that sewer.

Sections 23.101 and 24.104 provide that no septic tank or no water shall be provided for a residence in which the plumbing does not comply with the ordinances of the Village of Barrington,

The State of Illinois provides that it is unlawful to install any septic tank for an individual dwelling have a liquid capacity of less than 500 gallons. Violation of this Section is a misdemeanor.

If the buildings with which the Village is concerned are old and dilapidated, perhaps they would fall within the definition of "a dangerous building." The provisions for enforcement of Chapter 19, Article II should be initiated. If the buildings in question are not provided with adequate sewer facilities it is clear that this would constitute a violation of Section 22.101 or Section 23.101 of the Municipal Code.

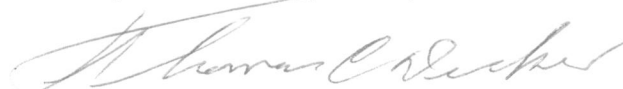

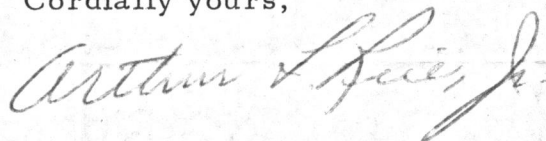

Re: Ambulance Service for Barrington Area

Gentlemen:

First, I would like to take this opportunity to formally thank each of you who attended our July 10 meeting and express appreciation for the enthusiasm demonstrated to work together to ensure Barrington of future ambulance service. I would also like to bring you up-to-date on progress since that date.

We have had two meetings, with a third scheduled in the near future. At the first two we:

1. Formed a committee of 5 and elected a chairman -

Orrin Nash - Chairman  
Roy Klepper  
Bill Braithwaite  
Robley Heninger  
Keith Pierson

2. Interviewed two additional ambulance services and asked for their proposals.
3. Explored the possibilities available for government subsidies to private ambulance services. A cursory examination indicates that subsidies would be possible from villages but difficulties might be encountered in use of township monies. Both avenues are being pursued.
4. Determined that a government-operated service would be much more expensive than one privately operated. This conclusion is confirmed in an article written by Capt. John M. Waters, U.S.C.G., assigned to the U.S. Dept. of Transportation and doing a study on transfer of injured on the public highways.
5. Made estimates of the area and population to be served. Could each of the Village Presidents provide Orrin Nash or me with the number of people within their village? Our present thinking is that any subsidies should be allocated on a per capita basis. Your thoughts or comments would be appreciated.

Dear Mr. Pierson:

Your letter dated August 5 relating to improved ambulance service in the Barrington area has been read. You have made excellent progress since the meeting held July 10 in the First National Bank Building. The ambulance service committee which you appointed subsequent to the July 10 meeting certainly is working vigorously in planning the foundation for the much needed private ambulance service for the area indicated in your letter.

The program of area wide ambulance service was discussed weeks ago at a meeting of the Board of Trustees of our Village of Barrington. Since your August 5 letter indicates so well the progress that has been made in establishing an approved type of ambulance service I am supplying a copy of your letter to each of our Village Trustees.

The Barrington Chamber of Commerce deserves community-wide support in its efforts to establish a fully approved Barrington Area Ambulance Service.

The official census made about two years ago shows for the Village of Barrington a population of 6525. However, the estimate for current population is between 7250 and 7500. A special census is to be conducted sometime in 1968 under direction of our village manager.

As to a subsidy from taxing bodies of the Barrington area to support the establishment of the planned ambulance service, there could be a legal problem or two. It may be more appropos to consider a private subscription; I recall that some years ago the Barrington Volunteer Fire Department purchased an emergency vehicle by asking donations; the second vehicle was purchased with surplus funds of the Barrington Centennial Program.

The person knocking was the nephew of Josephine Gear who lived in an apartment across the hall from mine at 424 Dundee Avenue, Barrington. Her nephew explained that she seemed to have lost consciousness and that he could not get her to respond.

The nephew called Delta Ambulance Service and I called a doctor. The ambulance was there within ten minutes. I am not sure of the chain of events, but I know that the men from the ambulance company asked the nephew to call the Fire Department for oxygen. I assume the Fire Department notified the Police -- at any rate, both were there within a very few minutes.

The men from Delta worked with assurance and great speed in an effort to revive Mrs. Gear. I presume the members of the Fire Department helped them upon their arrival. The police took over in a very calm and efficient manner.

The response to our calls were immediate and the work of all three units -- the Delta men, Police and Fire Department -- was most commendable. No one could see this action without being very appreciative of the work they did and without feeling a comforting sense of security in knowing that Barrington has this type of public service for its protection.



STENOGRAPHIC REPORT of a Public Hearing held before the Zoning Board of Appeals of the Village of Barrington, in the Fire Department Hall of the Village, on July 24, 1968, at 8:15 PM, on the petition of Kennedy Development Company. Meeting having been duly published.

The petitioner was not present or represented. No public audience was in attendance. Mr. James F. Hollister, Village Trustee was present. Mr. Beinhoff acted as Chairman for the meeting.

MR. BEINHOFF: The meeting will come to order. The secretary will read the petition.

Mr. Lines advised that this meeting was being held to consider the petition of the Kennedy Development Company asking for a variation in the size of a proposed sign 4 ft. x 8 ft. to be erected at Cold Spring and Lake-Cook Roads, directing buyers to the existing Fox Point model homes. This to be a temporary sign until such time as the homes are sold.

MR. LINES: Why doesn't the Village allow a model home sign that could be moved from place to place within their own development until fully occupied and sold?

MR. BEINHOFF: As the sign ordinance now stands it is necessary to get a permit to have a sign in a residential area.

MR. HOLLISTER: I personally think you have a good idea. A sign now is for six months, then the developers have to ask for another variation, pay \$50.00, there is the cost of advertising the meeting, and the time of you men on the Board. We are just creating more problems. I came here for the purpose of getting some opinions from you.

MR. BEINHOFF: I am of the opinion that developers of new subdivisions need signs in order to sell their homes and some schedule could be drawn-up by the Village to allow the Village Manager and the Building Commissioner to use discretion on the basis of the schedule, and permit such signs until the development is completed. We are here to grant relief from injustices to those who have to follow the strict letter of the law.

MR. SEEGER: I do not think we should be here every few weeks for this purpose.

MR. CHURCH: I recommend to the Village Board that some action should be taken to automatically grant these variations, if the Building Commissioner and Village Manager feel the signs are attractive and of reasonable size.

MR. SEEGER: I move that the plea of the petitioner be granted for the requested sign variation. Seconded by Mr. Church. All votes Aye - motion carried.

MR. BEINHOFF: Before adjourning the meeting, we are open for suggestions or recommendations for the Village Board for the future.

Discussions were made regarding the feasibility of authorizing the Village Manager and Building Commissioner to issue permits for signs on residential developments for directions, model homes and other information, without calling a special hearing of the Board.


We would urge your immediate consideration for the purchase of the Wichman property located at the corner of Hough and Station Streets for several reasons:

RE: SIGN ORDINANCE AMENDMENTS

Pursuant to your request that the suggestions of Mr. Henry Schneider of Schneider Sign Service be included in the amendment to the Sign Ordinance, we enclose a re-drafted document. The following changes have been made:

1. "Exterior" plywood is specified rather than "marine" plywood, in Section 1 of the Ordinance.
2. One-half inch plywood is specified rather than five-eighths inch, again in Section 1.
3. The date for conformance has been changed to October 31 from October 1, due to the delays in enactment of the Ordinance.

Mr. Schneider also raised the question of excepting from the ordinance "for sale" signs. Section 19.1112 of the existing Sign Ordinance, which is not being amended, provides that the Sign Ordinance has no application to "non-illuminated real estate signs not exceeding eight (8) square feet in area which advertise the sale, rental or lease of the premises upon which said signs are located only."

Another matter which has arisen since the amendment was originally drafted is whether you wish to ban rotating signs and other signs that move. Such rotating signs, usually brightly colored, are used by some gasoline stations.

The present Ordinance bans signs which are illuminated in whole or in part by flashing lights or intermittent lights and bans revolving lights and revolving beacons.

ORDINANCE AMENDING SIGN ORDINANCE  
(VILLAGE CODE AMENDMENT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois that:

SECTION 1: Section 19.1110 of Chapter 19 of the Municipal Code of Barrington of 1957 is hereby amended to read as follows:

"19.1110. Strength and Incombustible Material. All signs and other advertising structures shall be designed and constructed to withstand a wind pressure of not less than forty (40) pounds per square foot of area; and shall be constructed to receive dead loads as required in the Building Code or other ordinances.

"All signs shall be constructed of:

- (a) exterior plywood of at least 1/2 inch thickness, or,
- (b) solid wood of at least 3/4 inch thickness, or,
- (c) incombustible materials.

"Nothing in this Section shall apply to a temporary sign as defined in this Article which is erected for a period of ten days or less on behalf of a school, church, civic group or municipal corporation.

"Any sign now in existence which does not conform to the requirements of this Section shall be removed or be made to conform by not later than October 31, 1968."

SECTION 2: Section 19.1116 of Chapter 19 of the Municipal Code of Barrington of 1957 is hereby amended by changing the descriptive caption of said Section to read "Lights, Reflectors, Movement, Glare and Pennants" and there is hereby added to said Section

a new paragraph, at the end thereof, as follows:

"It shall be unlawful for any person to erect or maintain any pennant or flag (other than official flags of federal, state or local governments), or any sign which revolves, rotates or otherwise moves, in whole or in part."

SECTION 3: This Ordinance shall be in full force and effect from and after its passage, approval and publication, as provided by law.



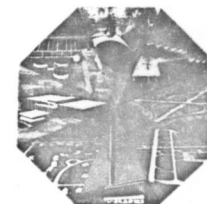
