

VACATION OF PART OF PLAT

Now comes The First National Bank and Trust Company of Barrington, Barrington, Illinois, a national banking association, as trustee under the provisions of a Trust Agreement dated the 5th day of April, 1960, known as Trust No. 15, the owner of record of the real estate hereinafter described, declares that such part of the plat of subdivision known as Owner's Subdivision of Sundry Lots in Walbaum's Addition to Barrington, according to plat thereof registered with the office of Registrar of Deeds of Cook County, Illinois as document No. 580312 as is hereafter described is vacated:

Lot A of Owner's Subdivision of Sundry Lots in Walbaum's Addition to Barrington of part of the west half of the northeast quarter of Section 1, Township 42 North, Range 9, East of the Third Principal Meridian, Cook County, Illinois, except that part of said Lot A described as follows:

Beginning at the southeast corner of said Lot, thence northwesterly along the southwesterly line of said Lot, 146.32 feet to the southwest corner thereof;

thence north along the west line of said Lot to the southwest corner of Lot 15 of Block 1 of vacated Walbaum's Addition to Barrington;

thence east along the south line of said Lot 15 to the east line of said Lot A;

thence south along the east line of said Lot A to the southeast corner of said Lot A, being the point of beginning.

Said property is restored to a subdivision consisting of Lots 9 through 15, inclusive, of Block 1 of Walbaum's Addition to Barrington of part of the west half of the northeast quarter of Section 1, Town-

Map 42 North, Range 9, East of the Third Principal Meridian, Cook County, Illinois.
