Dear Mr. Sayles:

Yesterday I received your letter dated October 30, 1968 in which you state to the President and Board of Trustees of the Village of Barrington as follows:

"Gentlemen: I wish to withdraw my application for liquor license in Barrington. The application was made by W. S. Sayles Enterprises, Inc. Thank you for the courtesy extended to me in the past. Yours very truly. (signed) W. S. Sayles."

Mr. Sayles: I am disappointed in the fact that you found it advisable to withdraw your application for a liquor license, which application, dated April 22, 1968, came to me on April 26, 1968.

You had also made a preliminary application earlier in the year, about February to our Village Manager.

Both sets of application are in my Liquor Control Commissioner file and shall be held there until such time that you may ask for their return to you or wish to renew your application.

As you of course know, there was no Liquor License Fee attached to your application so there is no money to be remitted to you.

It is remembered that one day in March or early April you and Mr. Draper visited in my office. I felt then that you appeared to be a person qualified for a Liquor License, which feeling was supported by the data which you submitted. You realize of course that no liquor license could be issued until a building would be ready for such use. And license space would have to be made available in our Liquor Ordinances.

Dundee Avenue Improvement---Resolution

On Friday afternoon, Nov. 1, 1968, your Village President inspected afoot the recently made improvements on Dundee Avenue extending from Main Street (Lake-Cook Road) to Hawthorne Road (Routes 59 and 63).

The engineers and contractors active on the project performed well in design and construction of widening and black-topping operations. Driveways, shoulders and street approaches were improved and restored satisfactorily.

However, some maintenance work by the village's Public Works Department is required until such time that backfill and sodding has become firmed. Attention is called particularly to the following locations:

Tower Road approach on east side of Dundee Road
Sodding on west side of Dundee Road south of Tower Road
Sodding on east side of Dundee Road between Station S¹. and Lake-Cook Road

It is suggested that the resident engineer make an inspection of shoulders and approaches along Dundee Road and effect the necessary maintenance work.

Recommendation to Village Trustees:

That a Resolution be passed thanking the State Highway Department and the Cook County Highway Department for the assistance and cooperation they have afforded in effecting the much needed improvement of Dundee Ave. and that copies of such Resolution be forwarded by the Village Manager to the respective parties.

Re.: MFT Program Meeting Scheduled Nov. 13 or 14

Dear Sir:

In response to your inquiry dated October 16, 1968, and the October 28 follow-up, I as President of the Village of Barrington 1961-1969 (and Village Trustee 1934 to 1961) submit for your consideration personally the following questions:

1. How can the municipality's share of MFT fund be applied to pay local traffic police for who have to patrol the periodic heavy flow of motor vehicles on state controlled highways ?
- 2, To what extent may MFT fund be used in constructing new sidewalks and in repairing existing sidewalks along state-controlled highways within the municipality?
3. Are MFT funds obtainable to assist a municipality in the construction of storm sewers on local streets other than state-controlled highways?
4. Why can the municipality's share of MFT funds Not be paid to the municipality immediately upon collection by the State on a so-called "blank Check" basis, as is done in the collection of Sales Tax?
5. What is the basic procedure you require to be followed by a municipality in applying for the use of its share of MFT funds and to what extent may such funds be used under present rules? Could you supply at your conference for distribution to the audience a diagram outlining the procedure?

Our Village Manager and I are planning to attend the meeting, whether it be on Nov. 13 or 14. Give us the date after the Nov. 5 election.



VARIATION ORDINANCE

(YOUNT FORD SALES, INC., 650 WEST NORTHWEST HIGHWAY)

ORDINANCE NO. _____

WHEREAS, the question of enacting the variation, hereinafter provided for, to the Zoning Ordinance of the Village of Barrington, upon the application of Yount Ford Sales, Inc., was referred to the Zoning Board of Appeals of this Village to hold a public hearing thereon; and

WHEREAS, said Zoning Board of Appeals held a public hearing after due publication of notice; and

WHEREAS, the said Zoning Board of Appeals has made recommendations and has submitted findings of fact to the Corporate Authorities of this Village; and

WHEREAS, it appears that there are practical difficulties and particular hardships resulting from the application of the strict letter of the Zoning Ordinance to the property in question;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois, that:

SECTION 1: The Corporate Authorities find that the statements in the preamble to this Ordinance are true.

SECTION 2: A variation in the application of the Zoning Ordinance and the Sign Ordinance of this municipality to the property known as 650 West Northwest Highway, in this municipality is hereby granted to allow a ground sign, the main portion of which shall not exceed 6 ft. x 19 ft. in size and the top of which shall be not more than 8 ft. above the roof line of the building under construction. The main portion of the sign shall face approximately East and West and shall be approximately

perpendicular to the sales agency building being erected on the premises.



RE: AMENDMENT TO VILLAGE CODE TO ALLOW THE TREASURER TO
ESTABLISH ACCOUNTS FOR THE DISBURSEMENT OF MONEY

Pursuant to the request of the Village Manager and the Finance Director, we enclose an Ordinance which allows the Village Treasurer to have such disbursement accounts as are convenient to him, provided that such accounts at all times comply with State law and Village ordinances.

We understand that this request arises by reason of the new accounting machine and that the Village Treasurer wishes to have one disbursement account and one payroll account, rather than a separate fund for each Village account.

We felt that rather than specifically provide for these two accounts it would be better to allow flexibility. For example, an ordinance which specified accounts would have to include a reference to a separate account for special assessment funds, as State Statute and your Ordinances require that special assessment money be held in a separate fund.

The Ordinance is in proper legal form for passage.



(a) All existing regular fares up to fifty cents (\$.50) will be increased five cents (\$.05).

(b) All existing regular fares fifty cents (\$.50) or over will be increased ten cents (\$.10).

(c) All school fares will be increased two and one-half cents (\$.025) per ride or per ticket.

(d) Commutation fares will not be available where the one-way fare is thirty cents (\$.30) or less and the percentage monetary savings on such fares will be reduced to five per cent (5%).

(e) Children fares which are covered by Rule 2 of M.P. Ill.C.C. No. 32 will increase proportionately since they are predicated on one-half the adult fare.

No other changes in fares, rules, or regulations are contemplated by the tariff and in all other respects it will be the same as Tariff M.P. Ill.C.C. No. 32.

(3) Petitioner's last fare increase was approved by the Commission in Docket No. 53097 issued on April 12, 1967. Said fares, rules and regulations were published on April 13, 1967 to be effective April 19, 1967.



RE: SCAVENGER SERVICE CONTRACT

After consultation with the Manager, whose prior experience has been invaluable, we jointly refer the following policy questions for decision by the Village Board, to allow announcement for bids on the new contract:

1. Will the Village continue to allow families "having a sanitary method of disposing of garbage" to elect once a month service for cans and bottles? (Section 1 of Ordinance No. 689). See also Section 5 of that Ordinance, allowing disposition by "gas incinerators or other similar equipment properly installed" and disposals.
2. Should the present free twice per week service to churches and Village owned buildings (Section 3 of Ordinance No. 689) be extended to schools, libraries and park district facilities?
 - a) Should the Village service include emptying of all business area sidewalk and parking lot refuse containers?
3. Shall the Village continue to limit the number of scavenger licenses to one? (Ordinance No. 711, Section 14.901 of the Village Code). The present scavenger's license, issued to Barrington Trucking Company, expires on April 30, 1969, pursuant to Village Code Section 10.107. Therefore, if a new scavenger is the successful contract bidder, it will be necessary to provide for two licenses for four months, in any event.

However, the important policy questions are whether to limit service for commercial-industrial establishments to one scavenger and whether to set the prices for such service if more than one scavenger is allowed.

4. Shall the Village require, for residential areas, "continuous pickup" of debris at the curb. The present scavenger contract (Section 7) provides for twice a year clean up of household trash, excluding brush, earth and building materials. The concept of "continuous pickup" is that subscribers to twice a week garbage removal could have such trash (specifically including furniture and newspapers) picked up at the curb at the time of their garbage pickup.
 - a) Should "continuous pickup" include brush, grass clippings and building materials, within certain size limitations and subject to loose materials being boxed or packaged?
 - b) Will the semi-annual clean up still be desired?
5. Should there be a special Christmas Tree pickup, as in some municipalities which apparently do not have the annual "Twelfth Night" bonfire of Barrington?
6. Does the Village wish to provide for possible future taxation for garbage disposal of up to the 10¢ rate allowed by Statute? The present maximum revenue from such tax would be about \$35,000 per year. No referendum is required for such tax. This tax could be supplemented by charges to individual uses, which might be desirable where some taxpayers, especially commercial-industrial establishments, have large quantities of refuse.

Take Police Off Typewriter Beat

GOOD BUSINESSMEN know clerical busywork can rob their employes of full efficiency, forcing them to take time from their primary tasks.

This is just as true in the Waukegan police department as it is in a business. Police must be free to spend their time performing their appointed tasks, not in making out reports on what they have done.

Policemen aren't hired to be typists, yet they now spend up to two hours a shift beating typewriters rather than working their beats, says Chief John Della Valle.

Chief Della Valle has suggested either hiring typists or buying dictaphones to take down police reports. The idea is a good one used in many other police departments around the country.

Waukegan policemen last year typed 60,000 reports, using time which could have been spent on patrol away from the station. If these man-hours were given to typists, our police force would be able to spend more time doing what it was hired to do.

Cost of the program was estimated at \$24,000 by Mayor Robert Sabonjian, who suggested the finance committee be consulted. We feel his estimate is

reasonably close to the actual cost, and \$24,000 for more man-hours patrolling our city, and for increased efficiency and accuracy in paperwork, is a fair price.

Chief Della Valle estimates 1.5 hours are spent making out reports by each policeman each day. That is almost one day per week a policeman spends on paperwork.

Figuring average police salaries and discounting overtime and vacations, that time represents from \$70,000 to \$90,000 in police salaries each year. That is why we say \$24,000 for typists is a bargain.

Moreover, four typists could help immeasurably in the Bureau of Investigation and Juvenile Department where paperwork is also a problem.

WE SUPPORT Chief Della Valle in his efforts to continue past strides in keeping Waukegan's police department efficient and up to date, and we urge the finance committee and the City Council to give his proposal favorable consideration.

We want our police to have the time to do their jobs, not restricted by the secondary need to have reports on what they have done.

United Fund Services In Jeopardy

UNLESS THE United Fund of North Lake County is able to raise approximately \$30,000 more in the next two weeks, many Lake Countians who seek United Fund services in 1969 will not receive them.

United Fund officials estimate that when all pledges have been collected only \$663,323 of the \$690,457 goal will have been reached. And that estimate is a maximum figure, for there is always a percentage of pledges which are not made good.

It is apparent that unless those businesses and individuals who have not yet made their fund donations significantly increase their gifts, United Fund participants and those who use their services will suffer.

When one stops to consider the wide range of community services — from educational training for the retarded to counseling for the mentally depressed — are hanging in the balance, we can only urge Lake County residents to dig deeper into their pockets.

In 1965, after 19 straight fund drives had failed to achieve their goals,

the tables were turned and the next three drives were successful. Aside from the generosity of Lake County residents, one of the reasons for recent successes is the careful watch over budgetary requests.

Budgets are pared to the minimums and services are carefully analyzed before a participating agency gets its fund request approved. This year \$99,000 was trimmed from initial budget requests before the final fund drive goal was set.

Despite this care, and the low administrative fund costs, the drive is not going well this year. United Fund officials are worried, and so are we.

THE OFFICIAL closing deadline was Nov. 1, and although money has usually continued to come in for the next two weeks, the picture does not look good.

Let's all dig just a little deeper in these next two weeks so that Lake County can post its fourth successful fund drive, and open the door to help, hope and happiness for those in need.



MEETING CALLED TO ORDER by President John H. D. Blanke at 8 P.M. Present at roll call: Trustees Paul J. Shultz, J. Frank Wyatt, James F. Hollister, Earl M. Schwemm, David R. Capulli, Trustee and J. William Braithwaite, Legal Consultant arrived later. Also present: May L. Pinkerman, Village Clerk; Robley D. Heninger, Village Manager; B. J. Zelsdorf Finance Director.

PRAYER by Rev. Alfred E. Bishop, The Village Church of Barrington.

MINUTES of 10-14-68 approved on MOTION Trustee Wyatt; 2nd Trustee Shultz. Ayes.

INQUIRIES FROM AUDIENCE: Harold Roth, President of and on behalf of Barrington Home Owners Assoc. invited the President and Board of Trustees to their 9th annual meeting 8 P.M. Nov. 7, 1968 in the Learning Center, Middle School. Village Manager Heninger to speak on Progress of Barrington; letter to follow. Invitation extended also to all citizens of Barrington.

Mrs. G. Lindskog asked to be heard when Item #8 of Agenda comes up.

HUMAN RELATIONS COMMISSION - Resignation: Letter of 10-15-68 from John Papadakis stated he resigned due to moving from Village. MOTION Trustee Wyatt to accept resignation; 2nd Trustee Shultz. Ayes.

Appointment: Letter of 10-23-68 from Corliss D. Anderson, Chairman of Commission recommended appointment of Mr. George Hager, 125 Grant St. Barrington, to replace Mr. Papadakis; President so recommended to Board. MOTION Trustee Shultz to appoint Mr. George Hager to fill vacancy on the Human Relations Commission; 2nd Trustee Schwemm. Ayes.

TREE PLANTING ROUTE 14: Letter of commendation received from Mr. T.C. Kittredge on fine work done by members of Boy Scout Troops 21 & 183. MOTION Trustee Shultz that letter of appreciation be sent to Scout Troops 21 & 183 for help in planting trees by the community on Route 14; 2nd Trustee Wyatt. Ayes. Trustee Schwemm suggested perhaps Village Manager would send such a letter of appreciation to Mrs. Kuffel who, with her committee, had done a terrific job on this project.

SPECIAL POLICE vs MARSHALS & DEPUTIES: President noted discussion had on this at the Illinois Mun. League Conference. MOTION Trustee Wyatt that Village Manager be authorized to take this up with Legal Consultant for an ordinance; 2nd Trustee Shultz. Ayes.

LAKE COUNTY MUNICIPAL LEAGUE: President reports this League reactivated & briefed on meeting of 10-17-68. Discussion had on last paragraph of President's report re recording equipment relating to water supply, pressure, etc. in Mundelein Police Dept. and operation of ours related by Chief Muscarello. Manager to check further on this.

CIVIL DEFENSE ADVISORY COUNCIL: MOTION Trustee Wyatt to concur in appointment recommended by President of Roy Crumrine, Bldg. Inspector, to Civil Defense Advisory Council; 2nd Trustee Shultz. Ayes.

INTERMUNICIPAL POLICE AID: Letter of 10-24-68 from Mayor Daniel Congreve, Mt. Prospect, received by President thanking Barrington for recent assistance given by newly formed special police group in helping them handle a crowd of 10,000 people. President Blanke will acknowledge. Trustee Shultz suggested this letter be filed into the record of this meeting and that a copy be given the Press. Chief Muscarello added a letter had been received from Park Ridge also and copies will be distributed.

ILLINOIS MUNICIPAL LEAGUE CONFERENCE: Held in Peoria Oct. 12 thru 15th. Copies of President's report distributed tonight.

LIST OF BILLS: Short discussion. MOTION Trustee Wyatt that bills be paid from funds indicated; 2nd Trustee Hollister. Roll call-Ayes: Capulli, Shultz, Wyatt, Hollister, Schwemm.

MUNICIPAL CLERK TRAINING INSTITUTE: MOTION Trustee Schwemm that Village Clerk Pinkerman be authorized to attend the first Institute to be held Nov. 22nd & 23rd, 1968, at University of Illinois, Urbana Campus, and estimated cost of \$110. be approved; 2nd Trustee Hollister. Roll call-Ayes: Capulli, Shultz, Wyatt, Hollister, Schwemm.

"CON-CON": Letter received from Arthur E. Fosslund, Pres. Village of Winthrop Harbor on this matter. Trustee Wyatt suggested this did not require action at this time since Board is on record.

FREUND BROS PET.. ON OVERHANG VARIATION: President noted Zoning Board had recommended this be granted. Mrs. G. Lindskog presented her remarks on their feelings about violations and concessions. She was advised matter under discussion tonight was the overhang and not the residential lot. President further noted that at public hearing Attorney for the Lindskogs stated they withdrew their objections to overhang. It was noted there is now a matter in court. Trustee Wyatt questioned Atty. Ruth for Petitioner as to why the overhang was built and he replied he understood there was a misunderstanding or oversight in regard to the blueprints and there had been discussions with former Building Inspector and State Highway Dept. After further discussion MOTION Trustee Wyatt to concur in recommendations of the Zoning Board of Appeals with respect to the petition of Freund Bros. Inc. for a variation on existing overhang for their building on lots 13 & 14 in Block 13 of Arthur T. McIntosh & Co. Northwest Highway addition to Barrington and that a copy of ordinance be forwarded to the State of Illinois in Elgin when passed; 2nd Trustee Capulli. Roll call-Ayes: Capulli, Shultz, Wyatt, Hollister, Schwemm.

ZONING MAP: Letter from Plan Commission of 10-21-68 suggested current zoning map be corrected at which time the Park Dist. annexation of approx. 80 A. could be added. Discussion on future procedure to be followed in updating maps during which it was suggested it should be reviewed legally by Attorney and perhaps others before printing. MOTION Trustee Wyatt that Village Manager take this matter up with Village Attorney, have zoning map corrected and reissued and at the same time discuss prices in view of the fact there were errors on the part of the planners; 2nd Trustee Hollister. ZONING ORDINANCE AMENDMENT - Bedrooms: After short discussion MOTION Trustee Wyatt that the comments from the Plan Commission, along with the proposed ordinance, be referred to the Village Attorney for the purpose of preparing an ordinance to be presented to this Board; 2nd Trustee Shultz. WANN PETITION - PLAN COMMISSION: Plan Commission letter of 10-25-68 re their previous suggestions on traffic/property acquisition and current request from R. Wann for re-zoning noted. Manager Heninger had received a call from Atty. Truninger, for Mr. Wann, requesting hearing not be scheduled before 30 days. It was suggested Village Clerk so notify Plan Commission. (Later: Manager discussed this with Mr. Hartlaub 10-29-68AM) A meeting to follow this one (to be a closed one) on property acquisition-agreed.

ORDINANCE 1043-UNDERTAKING ESTAB. AS SPECIAL USE: President requested ordinance be reconsidered. SO MOVED by Trustee Wyatt; 2nd Trustee Hollister. Roll call-Ayes: Capulli, Shultz, Wyatt, Hollister, Schwemm.

MOTION TO REPEAL ORD. 1043 by Trustee Wyatt; 2nd Trustee Hollister. Roll call-Ayes: Capulli, Shultz, Wyatt, Hollister, Schwemm.

MOTION to ADOPT new ordinance submitted with respect to Undertaking Establishments as a Special Use; 2nd Trustee Shultz. Roll call-Ayes: Capulli, Shultz, Wyatt, Hollister, Schwemm. #1043-1.

Question: if a resident of Village lists his home with a real estate agent - he comes within provisions of the ordinance? It was stated by Atty. Braithwaite that this is correct. MOTION Trustee Shultz for passage of this ordinance; 2nd Trustee Wyatt. President asked about publication as called for on Page 10; to be in pamphlet form but not as a legal in newspaper. DRAPER MATTER: Status report - Atty. Braithwaite reported he had discussed this with attorney for petitioner and all necessary documents are not yet ready; will notify President when they are in order with material, and when to have on agenda.

PARKING LOT #2: Manager discussed this and noted it could be authorized for signatures. Contractor is working on his own on this project. Attorney recommended there be a waiver of subsection C of paragraph 3 of sect. 1B of contract - Builders risk insurance. MOTION Trustee Wyatt so to do; 2nd Trustee Hollister. 2nd GAS TANK INSTALLATION: Manager Heninger read letter from Legal Consultant on this which matter was brought up so a second tank might be installed for Ethyl gas, feeling that if price could be held for 3 years we would be fortunate. Trustee Wyatt reminded this matter came up previously and asked with whom title would remain? Discussion on this and how gas would be dispensed. MOTION Trustee Schwemm to grant contract for period of 3 years and authorize acceptance of gas tank from the Sinclair Refining Co.;2nd Trustee Shultz. Roll call-Ayes:Capulli,Shultz,Wyatt, Hollister, Schwemm.

BOB & BETTY PARKING LOT: No report at this time.

DUNDEE AVE. IMPROVEMENTS: Manager announced final inspection to be made by State & County Nov. 1st. If anyone has any complaints he would like them before Friday. President noted a hole north of Russell St. on east side that needed filling.

B.A.D.C. Letter to President from Trustee Voss on phases 1 & 2 noted. MOTION Trustee Wyatt that this be referred to Manager for study before next meeting and copies be distributed to Trustees;2nd Trustee Hollister. Ayes.

SPECIAL POLICE-MARSHALS: (cont'd) Atty.Braithwaite recommended no action at this time since a question is being raised by the Assoc. of Chiefs of Police on validity. Marshal Pillman concurred. MOTION Trustee Wyatt to accept above recommendation of the Attorney and take no further action at this time;2nd Trustee Shultz. Ayes.

NORTH & MAIN STS:Trustee Schwemm suggested traffic approaching Main be observed; suggested parking on perhaps one side of street only; President mentioned meters. Also, where traffic leaves Northwest Highway and enters Hillside Ave. there is a big drop-off; Manager suggested perhaps some newly acquired railings could be installed there.

LEAF MACHINE: Trustee Wyatt asked if this is being used this year. Manager stated he had been informed it is out daily. Trustee Hollister noted he had observed a 3-man crew on this machine and reminded that when purchased it was stated only a 2-man crew would be required. Asked this be checked out.

110 E. STATION ST. PARKING LOT: Discussion on when meters will be installed there.

MAINTENANCE MEN: Manager Heninger reported there would be an ad in local paper this week seeking 4 maintenance men and he will be glad to interview anyone interested in this type of work.

BARTON-ASCHMAN: Manager Heninger read letter from Mr. Barton who is seeking an appointment for meeting with Board for discussion of his report with Board and Plan Commission; Manager desires this meeting as soon as possible. Friday, Nov. 1st was suggested and Manager will check this with Mr. Barton and notify Board and Commission members if it can be arranged.

Gentlemen:

On October 29, 1968 I was advised by the Village Prosecutor that through an arrest made by the Carpentersville Police, a 17 year old student of the high school had been arrested for possession of narcotics. His automobile was searched and narcotics were found in the automobile and equipment for utilizing marijuana plants was found in the trunk. The automobile had been parked at the high school parking lot for several days and two youths under 16 also were apprehended as they were found sitting in the parked automobile.

I insisted that no names be supplied to me and assured the prosecutor that he and the Police Department would have the full cooperation of the Village Board in publicizing and prosecuting the alleged offenders.

A further arrest was made this weekend on Northwest Highway, arising out of a minor traffic incident.

Yesterday, Lt. Hemmingson gave me a draft press release which, after certain amendments, I approved. A copy of the final release is enclosed. Lt. Hemmingson later reported to me that Mr. Robinson of the Barrington paper refused to publish the names, upon direct orders of the owner of the paper. It apparently was mentioned that the owner was a close friend of one of the families.

Upon further investigation it appeared that the States Attorney's office, Lt. Hemmingson and an expert in youth work with whom I talked, all favored publication of the names as being in the public interest.


I then telephoned John Rockwood, the owner of the newspaper and gave him the background and reasons for desiring publication, pointing out that a Court will in all likelihood be lenient and the only real deterrent value may come from publication of names. I also made it clear to him that, as a policy decision was reached before any names were known, the Village would expect to issue the press release, with names, to the Chicago papers.

Mr. Rockwood then decided that the names would not be published but that the story would indicate that names were available to any one telephoning the newspaper. He indicated that he would discuss the matter with Rev. Olson, who is, I believe, President of the Ministerial Association.

He and Mr. Heninger separately discussed the matter with Rev. Olson and he referred them to the entire Ministerial Association. The Manager advises me that he met with the Ministerial Association today and that that organization favors full publicity if it is the policy of the Village to publish the names of all persons arrested, youths or adults.

I wanted you to have this background and information, as some of you may receive telephone calls on the matter. I assume that the Police Department will proceed with a news release to the Chicago newspapers, especially the Northwest Zone of the Tribune. I will suggest to the Police Department changes to the news release to improve its form.

On October 29th Jeffery Smith, age 17, of 206 Biltmore Dr., North Barrington, was arrested by Lieut. Ronald Hemmingson of the Barrington Police Dept. for possession of narcotics at the Barrington Consolidated High School. Also two juveniles, ages 15, were arrested on a narcotics charge and turned over to the Juvenile authorities.

At 3:20 AM Sunday morning, November 3, Philip Bash, age 17, of Oakdene Rd., Barrington Hills, was arrested by Off. Wm Friedl of the Barrington Police Department for the possession of narcotics; for possession of open liquor, and Curfew violation. Also arrested with young Bash was Roger Hunter, age 17, of 9007 Gardner Rd., Fox River Grove; Douglas Kumins, age 17, of 239 Butternut, Barrington Hills; and Keith Mandabach, age 17, 715 South St., Barrington; the latter 3 arrested for Curfew violation only. Two 16 yr. old girls were turned over to the Juvenile authorities for the violation of curfew.

Investigation is still proceeding on both investigations. Information was received from one of the above investigations that lead the Police Department to the discovery of 15 acres of Marijuana, which has been destroyed.

Chief Muscarello of the Barrington Police Department stated that the cases will be prosecuted to the fullest extent of the law. Conviction on the narcotics charge carries a penalty of imprisonment in the penitentiary from 2 to 10 yrs. and a \$5,000 fine.

I have recently completed three sessions with the village board on a petition for variance in the sign ordinance. I appreciate the time the board devoted to hearing my arguments for the variance but I was somewhat disappointed in the attitude of several members of the board that in my opinion was detrimental to all of the new car dealers in Barrington.


I wish to call attention to the members of the board that each time a \$3000.00 automobile is sold in Barrington, the village treasury receives \$22.50 less the state collection charge in municipal tax. In the past nine and one half years I have collected and remitted \$100,877.00 in municipal tax. Most of this was collected when the tax was at a lower rate than present. In addition, I have paid over \$6000.00 per year in real estate and personal tax with the village receiving much of the benefit of this tax. The village of Barrington has reaped a far greater reward for my efforts than I.

It should be noted that motions on my petition were almost a carbon copy of the request made by the North Barrington Assn. in a letter sent to the board and signed by Mr. Rice. Other members did little to effect a more favorable motion.

Collectively the auto dealers of Barrington make a huge financial contribution to the treasury of our village. I believe it would be in the best interest of this community if the village board would be more concerned and helpful in the future efforts of our dealer group.

Again, I thank the members for devoting so much time to my petition.

Civic Leaders Debate

[Municipal problems and issues were discussed by officials of cities and towns in a conference last week of the Illinois Municipal league in Peoria. This is the second article dealing with some of the issues.]

Controversy over appointment of auxiliary police to help keep law and order in the suburbs flared anew last week at meetings of the Illinois Municipal league in Peoria.

A routine meeting for reports on new legislation developed into a shouting match, with members of boards of police and fire commissioners attacking the auxiliary plan, and corporate attorneys defending it.

Robert DiLeonardi, attorney for Des Plaines, said new legislation enacted by the Illinois General assembly last July gives municipalities the authority to continue the auxiliary

units, which had been jeopardized by recent court decisions.

Aids in Time of Disorder

He said the legislation spells out that the auxiliaries will not be members of regular police departments, but simply aids appointed by mayors and village presidents to direct traffic or assist in times of disorder and natural disasters.

Melvin Glink, attorney for several municipalities, said natural disasters alone show the need for such forces. He said many municipalities can't afford to have large police departments and have depended on the reserve units for help.

Members of boards of police and fire commissioners criticized provisions in the legislation for the auxiliary forces to be appointed by mayors and village presidents. They said that the police and fire commission law

of special police should be re-established by ordinance, which was suggested at the conference as evident from Tribune article.

was enacted to take policemen out of politics by vesting their appointments in nonpolitical bodies, and that the new legislation opens the door to potential corruption.

Association Is Repeal-Minded

The representatives of the Illinois Association of Fire and Police Boards, which has been a longtime auxiliary police, were declared out of order at the league general meeting.

They pledged in a separate meeting earlier in the day, however, to seek the repeal of the new legislation.

Walter Wellman of Lyons, attorney for the association, called the new state law "hasty legislation" and said it may be challenged in the courts.

Wellman, who filed the previous court suit contesting appointment of auxiliary units, said the new legisla-

tion raises more questions than it answers. He cited as an example the section that requires municipalities to provide for training of auxiliary police but doesn't say what the training should be.

'Everyone Wants A Badge'

He also questioned: "What's the status of the appointees? What if one gets shot? What protection will their families have? Are they officers or employes of the municipality?"

"Part-time policemen, marshals, or deputy marshals—It's all one and the same," he declared. "Everyone wants to wear a badge. It's a shame, with the disorders today, we don't have qualified personnel to cope with them."

DiLeonardi and other corporate attorneys advised municipalities continuing auxiliary police or creating new units to adopt ordinances com-

plying with the new legislation. He noted that many municipalities continued to have auxiliary units during the litigation but called them marshals and deputy marshals.

Recommends Careful Action

DiLeonardi said the new legislation clarifies that wages of auxiliary police are not subject to the minimum wages set for regular police. He suggested the ordinances be enacted on a roll call vote of the city council or village board since expenditures of money would be involved, and that appointments be done in writing at a regular meeting.

Steven Sargent, new executive director for the league, said the league will make available a model ordinance for communities.

Lake County Municipal League In Action

The Lake County Municipal League is again in action. A meeting was held Thursday evening, October 17, 1968 in the Court Room at Mundelein, with Village President Richard Foss serving as temporary chairman.

The League was organized in 1958 and had adapted a set of by-laws adapted early in 1959. Monthly meetings of the Lake County Municipal League discontinued about three years ago. Recently it was decided by a score of Lake County mayors and village presidents that activities of the league should be resumed.

At the October 17 meeting the by-laws of 1959 were read and considered still acceptable. Under the by-laws the League meets every third Thursday evening of each month in the year. Every municipality in the county is entitled to have the mayor or president as delegate, with an alternate named by him. Dues have been \$25.00 per municipality per year. Approximately \$232 is in the league treasury. Mayor W. B. Dunbar, of Zion, is treasurer.

There are 46 municipalities in Lake County, each entitled to membership under the by-laws. The next meeting of the league is scheduled for Thursday, Nov. ~~21, 1968~~, again in the Court Room at Mundelein.
21, 1968

At the Oct. 17 meeting the Lake County Municipal League, which was attended by approximately 15 mayors and village presidents, voted almost unanimously to endorse the Con-Con (Constitutional Convention) ballot.

Subsequent to the meeting, Village President Foss gave the membership a guided tour through the Mundelein police station which has many interesting features, including indoor police car space for unloading prisoners, and indicating and recording equipment for the municipal water works, which shows the depth of water in the village wells, as well as water pressure in the mains and other data.

As an elected Village official, I have been attempting to weight the advantages and disadvantages of "Con-Con". While there are some good reasons for a constitutional convention, the following are some of the major reasons which have led me to believe that it is not in the best public interest:

1. We presently have the Gateway Amendment, whereby we can change any article of our constitution by amendment, without tearing the whole thing apart.
2. A new constitution could, quite conceivably, establish many more appointive regional governments, thus reducing the authority of City and Village officials to govern themselves, and it would also tend to remove elected officials from local control.
3. A new Illinois constitution could be written to permit a payroll and/or a progressive income tax which could make it much more difficult for cities to obtain any added revenue from their communities taxpayers, because they can afford only so much tax.
4. The voters of the State of New York voted for "Con-Con", and the delegates spent 11 million dollars writing a new constitution. When the voters saw what the State officials were offering them, they said No, and defeated it badly at the polls. The State of Maryland voters rejected "Con-Con" 3-to-2.

I believe, it would be quite difficult to find qualified individuals who would be willing to take time from their homes and business, and spend six months or so in Springfield for \$25.00 or \$30.00 a day. Since it is possible the legislature could be in session, and our elected officials could not attend, who then would be delegates? - A group of individuals who know little or nothing about state government? - Persons on special interests payrolls to make sure their special interest gets written into any new state constitutions? A venture like this is certainly not worth \$10,000,000 of state money, when the state is forced to borrow from the motor fuel tax fund just to pay normal state expenses.

I would appreciate any of you advising me of your thoughts, because I believe a new state constitution is a very important question.
