5) <u>Public Hearing – to Obtain Input on the Municipal Tentative Plan of Operation and</u> <u>Governance for the Village's Electrical Aggregation Program for Residents and</u> <u>Small Businesses of the Village of Deer Park\*</u>

President Kellermann provided a brief summary of the recent activities with regards to the Deer Park's proposed Electrical Aggregation Program. At this time, President Kellermann opened the hearing to the public for comment at 6:14 p.m.

#### **Public Comments:**

**Deborah Barry of 412 Bramble Lane**, asked if it was the Board's intention to work in concert with other communities. President Kellermann cited the leadership role of BACOG and the Southeast Lake County Mayor's Council on this matter. Ms. Barry suggested contacting Highland Park.

It was noted that residents and/or businesses will have the right to opt out of the program. President Kellermann noted that there is a clause in the agreement that the rate can never be higher than ComEd's current rate for supply.

Ms. Barry asked who would be responsible for the costs of notifications regarding the program. Attorney Bateman indicated that the consultant would be responsible, and the supplier that the Village elects will be sending out opt-out notices. Attorney Bateman further explained the opt-in/out process.

Ms. Barry asked if there has been any discussion with ComEd about putting electrical lines underground. President Kellermann indicated there has not been such discussion. Attorney Bateman addressed Ms. Barry's question regarding putting electrical lines underground.

**Roger Hankin of 20856 Swansway Road,** expressed his concerns and thanked the Board.

Larry Winkelman of 21540 Inglenook, expressed concerns with the cost of the program and suggested reverse program options.

There was general discussion regarding the ComEd "smart grid" program.

With no further comments, President Kellermann closed the public hearing 6:55 p.m.

President Kellermann thanked the audience for their comments and announced another public hearing on June 25<sup>th</sup> at 7:00 p.m. at Vehe Barn. President Kellermann further explained the bidding process for the program.

Ms. Barry suggested that the Village send out a CTY Message to announce the next public hearing on June 25th. President Kellermann noted a CTY Message would be sent prior to the next Special Board Meeting on June 25<sup>th</sup>.
