MINUTES OF THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF LAKE BARRINGTON HELD FEBRUARY 6, 1962

1. Type, Date and Place of Meeting.

The regular meeting of the Board of Trustees for the month of February was held on Tuesday, February 6, 1962, at the residence of the Village President as provided by ordinance.

2. Call to Order.

President Hubschman, being temporarily absent from the Village, the Village Clerk, at 8:00 P.M. called the roll to determine if a quorum was present. On roll call, the following were:

It was then moved by Trustee Johnson and seconded by Trustee Nelson that Trustee Tucker be elected to act as President pro tem. The Village Clerk called for a vote, and on roll call the vote was:

3. Presentation and Approval of Minutes.

The minutes of the regular meeting held January 2, 1962, were presented by the Village Clerk for approval. It was moved by Trustee Johnson and seconded by Trustee Wienecke that the minutes of said meeting be approved as presented and that all action taken and all business transacted at said meeting be ratified and confirmed in all respects and that the reading of said minutes be dispensed with as all members of the Board of Trustees had heretofore received copies thereof.

6. Special Use for Machine Shop on McGraw Farm.

It was brought to the attention of the Board that the machine shop on the McGraw Farm was moved. A motion was made by Trustee Johnson and seconded by Trustee Wienecke to bring the ordinance previously considered, granting a special use for the machine shop before the Board and dispose of it as representing a moot question. The President pro tem called for a vote and on roll call, the vote was:

It was moved by Trustee Wienecke and seconded by Trustee Nelson that the settlement of the law suit be accepted on this basis in the case of "Village of Lake Barrington vs. Kelsey, et.al.", as shown in the stipulation presented at the open Board Meeting. His attorney told Mr. Huszagh that he had advised his client to go through with the annexation of his property to the Village but that his client told him he would take no action at this time.

12. Barrington Harbor Estates Subdivision.

It was moved by Trustee Nelson and seconded by Trustee Johnson that the Board of Trustees authorize President pro tem Tucker to sign the final plat of the resubdivision of the Barrington Harbor Estates Subdivision upon receipt of the applicable application fee.
