## Type, Date and Place of Meeting.

The regular meeting of the Board of Trustees for the month of March was held on Tuesday, March 7, 1961 at the residence of the Village President as provided by ordinance.

## Call to Order.

President Hubschman being absent from the village, it was moved at 8 p.m. by Trustee Schleifer and seconded by Trustee Wienecke that Trustee Tucker be elected President Pro Tem of the meeting. On roll call vote, the vote was:

Yeas: Trustees Bartlett, Johnson, Schleifer, Nelson and Wienecke.
Nays: None.
The motion was declared carried and Trustee Tucker elected President Pro Tem.

The President Pro Tem called the meeting to order at 8:15 p.m. On roll call by the Village Clerk the following members were:

## Minutes of Previous Meeting.

The Village Clerk read the minutes of the regular meeting of the Board held February 7, 1961. It was moved by Trustee Wienecke and seconded by Trustee Schleifer to accept the minutes as read. After stating the motion and after discussion, the President Pro Tem called for a vote, and on roll call the vote was:

Ayes: Trustees Bartlett, Johnson, Schleifer, Nelson, Wienecke and President Pro Tem Tucker.
Nays: None.
Public Service Electric Franchise.
President Pro Tem Tucker introduced Public Service Representatives Mr. C. Rezny and Mr. R. Steitz who presented the Board with another copy of their francise for all new villages and two letters which the Village Clerk read to the Board. It was moved by Trustee Bartlett and seconded by Trustee Schleifer that Electric Ordinance \#26 be passed as presented. After stating the motion and after disucssion, the President Pro Tem called for a vote, and on roll call the vote was:

Ordinance \# 27. Annexation of Karel Property.
The President Pro Tem requested the Village Clerk to read the petition for annexation previously filed with the Village Clerk signed by Mr. and Mrs. Karel. At the direction of the President Pro Tem an ordinance entitled "An Ordinance Annexing Contiguous Territory on Petition of Owners of Record" was presented and read by the Village clerk. It was moved by Trustee Nelson and seconded by Trustee Schleifer that the Ordinance be passed as Ordinance No. 27.
