CORRESPONDENCE Invitation from BADC (Barrington Area Development Council) to attend public meeting April 16, 8:00 pm Barrington United Methodist Church regarding proposed MIC (Mobile Intensive Care) program. President Hubschman requested Ethel Jacobson and any interested persons to attend and report back.

Letter from Art Rice, Jr., BADC stating MIC referendum for Barrington village scheduled May 18, 1974. Mr. Bob Balgemann, Barrington-Courier clarified cost: 10ϕ per \$100 assessed valuation for Barrington village residents and a possible 15ϕ per \$100 assessed valuation for Countryside Fire District residents.

Letter from Mr. W. A. Moldermaker, of Chapman & Cutler, who resides at 127 Cherry Hill, regarding intended use of entire hospital parcel. Questioned legality of 54 foot proposed height. Stated the unlimited hospital related facility use clause, negates the effectiveness of the 2 acre site covenant. Trustee Leyhane directed to send copy Moldermaker's letter to Reverend Umbeck for comments and request a personal appearance at a near future Lake Barrington village meeting.

Trustee Tucker inquired if Dictaphone Fire & Burglar Alarm Systems could be presented to Village board, in absence of unified fire district covering our village. Trustees Krueger and Erzberger felt commercial sales enterprise not board business.

MATCHPOINT President Bubschman read the "Written Protest of Proposed Rezoning" submitted by Mr. & Mrs. Woods and Mr. & Mrs. McMullen. Eva Schwartzman read summary of the Plan Commissions Recommendations. Mr. Jerry Kelly presented a survey "for or against the tennis club site" which he felt covered 85-90% of village residents and stated 2/3 did not object. Mr. Lockwood indicated surveys could be conducted to achieve any desired result. Mr. Bob Broda, Country Squire, stated surveyist erroneously inferred survey initiated by village board. Mrs. McMullen disagreed with findings attributed to adjacent residents. Henry Utik, soil engineer, reported a satisfactory 6 hole percolation test and stressed the septic field would be on virgin soil. Two non-village residents (from Wheeling and Bensonville) indicated their approval.

Input at a forthcoming public hearing on a Lake Barrington Comprehensive Plan is requested. A Phase 2 booklet - Lake Barrington Goals is being compiled.

Trustee Krueger requested printed occupancy forms be supplied to Building Inspector Lou Landow for issuance upon his building code compliance satisfaction. Eva Schwartzman to draft proper forms.

Trustee Tucker requested additional village insurance, an Umbrella Policy as proposed by 1st of Barrington, Hartford Insurance Co.for a \$185.00 premium.
