

MINUTES OF THE MEETING OF
THE BOARD OF TRUSTEES OF THE
VILLAGE OF LAKE BARRINGTON
HELD APRIL 6, 1971

The regular meeting of the Board of Trustees of the Village of Lake Barrington was held on Tuesday, April 6, 1971, at Sales Analysis Institute, Kelsdy Road, Barrington, Illinois, as provided by ordinance. On roll call the following answered:
