1. Type, Date and Place of Meeting.

5. Treasurer's Annual Report.

We had also received a partial payment in the amount of \$1,000 for the 1961 Village Real Estate Tax. He brought to the Village Board's attention that no monies had been received since for the Road and Bridge Tax and the final payment for the Village Real Estate Tax was still due. It was moved by Trustee Johnson and seconded by Trustee Nelson that the Village Attorney be directed to inquire of the various tax funds and the amount of tax funds due us. On roll call, the vote was:
