The motion carried and the minutes approved .

A bill from T. A. Copple & Co. for \$76.20 was presented for payment. Also, a bill from P. F. Pettibone & Co. for permit signs and books in the amount of \$15.50. A motion was made by Trustee Tucker and seconded by Trustee Schleifer to pay bills as presented. On roll call the vote was:

The Village Clerk read the minutes of the Planning Commission held July 1, 1965 and their letter of recommendation. A motion was made by Trustee Nelson and seconded by Trustee Schleifer to approve the Neri Farm Plat. On roll call the vote was:

A motion was made by Trustee Wienecke and seconded by Trustee Nelson to approve the Bartkett's Barrington Country Estates Plat. On roll call the vote was:

A motion was made by Trustee Wienecke and seconded by Trustee Schleifer to approve Bartlett's Northwest Barrington Industrial Subdivision Plat. On roll call the vote Was: (Trustee Johnson arrived at \$:30 P.M.)

Trustee Bartlett abstained from voting.

A motion was made by Trustee Schleifer and seconded by Trustee Wienecke to pass Ordinance of Annexation as Ordinance # 65-04. On roll call the vote was:

Trustee Bartlett abstained from voting.

The motion carried.

A motion was made by Trustee Nelson and seconded by Trustee Wienecke to correct the record showing the correct vote on the annexation of Ordinance #65-0-4. On roll call the vote was:

A motion was made by Trustee Bartlett and seconded by Trustee Nelson to adopt the same appropriation Ordinance as used in the year 1964-1965. An ordinance was drafted and numbered 65-0-5 and on roll call the vote was:

The motion carried and Ordinance # 65-0-5 adopted.
