

MINUTES OF THE REGULAR MEETING
OF THE BOARD OF TRUSTEES OF THE
VILLAGE OF LAKE BARRINGTON HELD
MAY 2, 1967

The regular meeting of the Board of Trustees of the Village of Lake Barrington was held on Tuesday, May 2, 1967, at Sales Analysis Institute, Kelsey Road, Barrington, Illinois, as provided by ordinance. On roll call the following answered:

The Village Clerk read the minutes of the April 4, 1967, meeting and a motion was made by Trustee Nelson and seconded by Trustee Meiners to approve the minutes as read. On roll call the vote was:
