

MINUTES OF THE REGULAR MEETING
OF THE BOARD OF TRUSTEES OF
THE VILLAGE OF LAKE BARRINGTON
HELD ON JULY 11, 1967

The regular meeting of the Board of Trustees of the Village of Lake Barrington was held on Tuesday, July 11, 1967, at Sales Analysis Institute, Kelsey Road, Barrington, Illinois, as provided by ordinance. On roll call the following answered:

Also present was Eva Schwartzman, attorney.

A motion was made by Trustee Wienecke, and seconded by Trustee Schleifer to appoint Trustee Tucker as President ~~Protem~~ in the absence of Jorgen Hubschman. On roll call the vote was:

Motion carried and Tucker appointed President ~~Protem~~.

The village clerk read the minutes of the regular adjourned meeting held June 20, 1967, and a motion was made by Trustee Schleifer and seconded by Trustee Wienecke to approve the minutes as read. On roll call the vote was:

The motion carried and the minutes approved as read.

The village clerk presented bills for payment from the following: Barrington Press \$7.00, Ralph Topple \$61.50 for policing, Island Lake Service Center for snow plowing \$37.50. A motion was made by Trustee Wienecke and seconded by Trustee Nelson to approve the bills for payment. On roll call the vote was:

The motion carried and the bills approved for payment.

A motion was made by Trustee Wienecke and seconded by Trustee Schleifer to pass Municipal Retailers' Occupation Tax Ordinance, Ordinance # 67-0-4. On roll call the vote was:

The motion carried and Ordinance # 67-0-4 passed.

A motion was made by Trustee Nelson and seconded by Trustee Schleifer to pass Municipal Service Occupation Tax Ordinance, Ordinance # 67-0-5. On roll call the vote was:

The motion carried and Ordinance # 67-0-5 passed.
