The village clerk read the minutes of the regular meeting held September 3, 1968, and a motion was made by Trustee Nelson and seconded by Trustee Wienecke to approve the minutes as read. On roll call the vote was:

The treasurer's report was read by the Village Clerk. A motion was made by Trustee Schleifer and seconded by Trustee Nelson to approve the treasurer's report as given and filed with the village clerk. On roll call the vote was:

Eva Schwartzman presented ordinance on licenses to the board for action. A motion was made by Trustee Tucker and seconded by Trustee Meiners to pass License Ordinance as Ordinance # 68-0-3. On roll call the vote was:

The motion carried and Ordinance # 68-0-3 passed.
