A motion was made by Trustee Spicer and seconded by Trustee Tucker to adopt Ordinance # 73-0-6 as read. On roll call the vote was:

The adjourned regular meeting of the Board of Trustees of the Village of Lake Barrington was held on Tuesday, May 15, 1973 at §:00 P.M. at Communication Analysis Institute, Kelsey Road, Barrington, Illinois. On roll call the following answered:

Trustee Tucker gave a report on the opening of the bids for village road resurfacing. The following are bids opened with prices for doing the village roads that qualify for Motor Fuel Tax funds: Liberty Asphalt \$15,580.50; Skokie Valley Asphalt \$16,710.90; H.T.Curran Const. \$16,816.26; Peter Baker & Son Co. \$17,357.96. Wight Consulting Engineers, Inc. reviewed the bids and recommended that the low bidder, Liberty Asphalt Products, Inc. be awarded the contract in the amount of \$15,580.50. Liberty Asphalt also said it would do the roads that did not qualify for MFT funds at the same rate. This would amount to \$15,932.12. This amount would have to be paid from the general fund. A motion was made by Trustee Spicer and seconded by Trustee Lehayne to award the contract to Liberty Asphalt Co. for the resurfacing of the MFT roads and also the balance of the village roads to be paid from the general fund. On roll call the vote was:
