Mr. Roy Peavey gave the treasurer's report and filed it with the village clerk. A motion was made by Trustee Tucker and seconded by Trustee Krueger to approve the treasurer's report as given. On roll call the vote was:

The motion carried and the treasurer's report approved as read.

The village clerk presented the board with several questionaires from various agencies requesting information and village policies. A motion was made by Trustee Erzberger and seconded by Trustee Leyhane to forward the questionaires to the Planning Board for their recommendation. On roll call the vote was:

A motion was made by Trustee Leyhane and seconded by Trustee Erzberger to pay the bills as presented. On roll call the vote was:

The motion carried and Ordinance # 73-0-9 passed.

A motion was made by Trustee Leyhane and seconded by Trustee Krueger to authorize Eva Schwartzman to draft a Resolution objecting to the petition of the village of Barrington to the Environmental Protection Agency for additional sewer permits. On roll call the vote was:

This sum represents monies received January 1, 1973 thru June 30, 1973. On roll call the vote was:
