Mr. Cal Jacobson gave the treasurer's report and filed it with the village clerk. A motion was made by Trustee O'Connor and seconded by Trustee Krueger to approve the treasurer's report as given. On roll call the vote was:

The motion carried and the treasurer's report approved as read.

The village clerk presented the Board with bills from the following: Town of Cuba-Road and Bridge Fund, \$252.00; Louie Landau, \$277.00; Lake Barrington Park District, \$195.31; Wight Consulting Engineers, \$36.00, \$54.00, \$45.00 and \$193.00. A motion was made by Trustee Spicer and seconded by Trustee Krueger to pay the bills as presented. On roll call the vote was:

The motion carried and the bills approved for payment.

The Board discussed the possibility of requiring a cash bond when applying for a building permit to assure the planting of grass on sides of roads to prevent c ulvert and drainage ditch erosion during construction. It was decided to table the discussion until the full board was present.
