The village clerk read a letter received from Mr. Bauer of the First National Bank of Barrington informing the Village that the late Emil Wienecke, a pioneer trustee of the Village until 1973, had left his estate in trust for his wife and upon her death, it is to pass on to the Village as a memorial for he and his wife. Mr. O'Connor volunteered to be a committee of one to send a letter to Mr. Bauer and express the appreciation of the Village.

A motion was made by Trustee Tucker and seconded by Trustee Leyhane to omit the January meeting because several members of the Village would be out of town due to the holidays. On roll call the vote was:
