Minutes of Board of Trustees' Meeting

September 17, 1979

The regular rescheduled meeting of the Board of Trustees of the Village of Lake Barrington was held on Monday, September 17, 1979 at 8 p.m. in the Lake Barrington Village Hall, Kelsey Road, Barrington, Illinois as provided for by ordinance. On roll call, the following answered:

A motion was made by Trustee Rebmann and seconded by Trustee Carroll to accept the Treasurer's report for the month ending August 31, 1979. On roll call, the vote was:

A motion was made by Trustee Rebmann and seconded by Trustee Krueger to pay the bills as presented. On roll call, the vote was:

The motion carried.

The Building Commissioner reported that he had checked a complaint re a water problem in Lake Barrington Shores due to placement of a downspout. The developer will check the placement.

Plan Commission Chairman Dalitsch reported on a meeting with Camiros, Ltd., a comprehensive planning firm. The Board's consensus was to request a proposal from the planning firm. Chairman Dalitsch also asked that the Board consider staying in the Soil and Water Conservation District in that the Plan Commission utilizes reports from the District and has on occasion asked and received advice from district staff.

Mr. Parker, North Barrington Area Association, asked for an appointee to fill a vacancy on the NBAA board. He suggested that someone from the Lake Barrington Shores development would be a good choice.

Mr. Andy Johnson, Lake Barrington Shores, submitted a petition signed by 199

residents of Lake Barrington Shores asking the Board of Trustees to vote "no" to BACOG membership for the Village.

Mrs. Ethel Jacobson, Flint Lake resident, urged the Board to consider the effect of not being a member of BACOG on such questions as the 208 water quality program and the Route 14 relocation plans.

A motion was made by Trustee Rebmann and seconded by Trustee Krueger to adopt a resolution that the Village of Lake Barrington join the Barrington Area Council of Governments. On roll call, the vote was:

Trustee Carroll reported that according to a recent State of Illinois Attorney General's opinion, the Village is required to have a licensed plumber perform plumbing inspections. It was agreed that Trustee Carroll invite Ernie Rice to the next meeting.

A motion was made by Trustee O'Connor and seconded by Trustee Rebmann to accept the Report of the Plan Commission re amendments to the Zoning Ordinance re sign regulations and animal control regulations. On roll call, the vote was:

A motion was made by Trustee O'Connor and seconded by Trustee Rebmann to pass Ordinance No. 79-0-11, an Ordinance for the Regulation of Signs. On roll call, the vote was:

The motion carried.

A motion was made by Trustee O'Connor and seconded by Trustee Krueger to pass Ordinance No. 79-0-12, an Ordinance amending the text of the Zoming Ordinance adopting regulations regarding the keeping of animals. On roll call, the vote was:

Yeas: Trustees O'Connor, Krueger, Rebmann, Smith and Carroll

The motion carried.

A motion was made by Trustee O'Connor and seconded by Trustee Krueger to pass Ordinance No. 79-0-13, an Ordinance amending the text of the Zoning Ordinance adopting regulations for signs. On roll call, the vote was:

Yeas: Trustees O'Connor, Krueger, Smith, Carroll and Rebmann

Nays: None

The motion carried.

It was the consensus of the Board, after discussion, to remain in the Lake County Soil and Water Conservation District.

Mr. Jack Lageschulte, Old Colony Builders, Inc., stated that he has been asked by Lake County and the Wauconda School District to make changes in road grades and cul de sac radius after final plat approval. After discussion, he will determine cul de sac measurements in other subdivisions in Wauconda Township and will appear at the next meeting.

Mrs. Shirley Kruse presented a letter explaining a proposed child care-nursery school facility on Hillside Drive. Attorney Springer will check into the fee structure and determine if a special use permit is necessary. Mrs. Kruse requested that the special use hearing fee be waived or reduced.

A letter, which was received from all Alice Lane residents regarding signage, lighting, speed limits and drainage at the intersection of Alice Lane and Kelsey Road, was discussed. The village clerk was directed to send copies of the letter to the Lake County Highway Department for their consideration and also to forward a copy to the Cuba Township Road Commissioner.

Mr. Lageschulte, in re to Alice Lane Extension, inquired what other steps he could undertake to bring about action on the tentative plat of the subdivision. The Board reiterated that proper authorization would be needed from various governmental bodies, ie IDOT's Division of Waterways and the Illinois EPA.
