May 5, 1980

A motion was made by Trustee Carroll and seconded by Trustee Smith to approve the minutes of the meeting of April 7, 1980 as distributed. On roll call, the vote was unanimous.

The motion carried.

Trustee Krueger reported that the village is receiving shared police patrols through Cuba Township but that the funding for the service looks questionable at the township level. A special town meeting is scheduled to discuss the matter.

The matter of installation of a light at the Rt. 59 entrance to Lake Barrington Shores was discussed. It was the consensus of the Board of Trustees that the letter from the Lake Barrington Community Homeowners Association complies with the prior requirements of the Board and, therefore, the application for installation of the light should be submitted to Commonwealth Edison Company.

Trustee O'Connor volunteered to contact the Lake County Health Department to request that tests be made of several wells in the industrial area.

A motion was made by Trustee Krueger and seconded by Trustee Carroll that the Village accept the proposal of the auditing firm of Friedman, Eisenstein, Raemer and Schwartz at a cost of \$1,400.00 to audit the village's records. On roll call the vote was:
