Trustee Krumlinde moved to approve the Treasurer's report - seconded by Trustee Schulke -

Treasurer Gerry commented on the audit report submitted by Putta & Kelsey, which had been circulated to the trustees for review. He indicated there is a typographical error in Exhibit "A" - cash in bank should be \$380.26 instead of \$280.26, which will be corrected. Trustee Jablonski moved to accept the audit report - seconded by Trustee Schulke - and passed unanimously. The President declared the motion carried.

<u>VILLAGE CLERK:</u> The clerk presented invoices for approval totaling \$3,570.76. After discussion Trustee Krumlinde moved to approve payment - seconded by Trustee Schulke -

By roll: AYES - Trustees Davis, Forrest, Gross, Jablonski, Krumlinde and Schulke NAYS: None ABSENT: None

The President declared the motion carried.

**POLICE:** Chief Roy E. Svacha reported complaints and incidents processed as follows:

5 Vehicle accidents 4 Incidents of vandalism 4 Suspicious cars Noise complaint Vagrants

2 reckless driving incidents Vehicles on Golf Course Suspicious phone calls Dog bite Wild animal creating nuisance/threat 2 dog complaints Shooting Dangerous unmarked open pit Family trouble 2 Burglary in progress calls 2 Burglaries.

HEALTH OFFICER: The president reported he had been advised there are a few complaints under investigation with the Department of Health and Mr. Paul Levin, Professional Sanitary Engineer.

Mr. DePue, Scoutmaster, will again be contacted relative to having the boy scouts clear debris from the creek as a conservation project. The project had been deferred due to high water.

ROADS: Supt. C. M. Newgent reported -

1. Two bids were received in answer to our advertisement -

(a - one was technically deficient as no bid check was attached.

(b - Both bids were in the area of \$40,000.

Since this is not within the Village means Mr. Newgent reported he had talked with the consulting engineers about putting in a fence. They are reluctant to do that because if they put in a fence and later fill, it will be necessary to relocate the fence at additional cost. Mr. Newgent indicated the matter will be explored further to see if some alternative improvement work can be done at a lesser cost. He recommended board action to reject the two bids. Trustee Forrest so moved - seconded by Trustee Gross and passed unanimously.

2. Mr. Newgent indicated the cold patching is just about finished and the roads are in fair shape going into the winter.

Plans for a snow plowing contract are under way and should be concluded in the next couple of weeks.

Motor Fuel Tax work has all been completed, but all of the paper work has not been finished.

BUILDING OFFICER: The President reported the Building Officer has a few cases which have been referred to Mr. Paul Levin for determination and finalization. There is one case - and possibly two cases - of sites that are almost impossible for a septic system of the type generally installed in our community. There is need for ditching in some of the areas and this will be reviewed by the Trustees Committee on Roads for consideration in one of their programs.

### PARKS & AUXILIARY SERVICES: No report

### MOSQUITO ABATEMENT: No report

FIRE COMMISSIONER: Mr. Walter Webster has resigned. The President submitted Resolution No. 256 appointing Donald G. Zielstra as Fire Commissioner for a term of three years. Trustee Krumlinde moved to confirm the President's appointment of Mr. Zielstra - seconded by Trustee Gross and passed unanimously.

#### **CIVIL DEFENSE:** No report

**BOARD OF APPEALS:** Mr. C. F. Mitchell Jr. has resigned for personal reasons. The President submitted Resolution No. 254 appointing Richard E. Johnson as liaison member between the Plan Commission and Board of Appeals. Trustee Forrest moved to confirm the President's appointment of Richard E. Johnson seconded by Trustee Schulke - and passed unanimously.

The President submitted Resolution No. 255 - to appoint a chairman, vicechairman and secretary of the Board of Appeals. Trustee Jablonski moved to confirm the President's appointment of Dr. Elwood F. Caldwell as chairman, Ray B. Weber as vice-chairman, and Phyllis Tull as secretary - seconded by Trustee Davis and passed unanimously.

LAW: The Landwer Case is still to be decided - possibly within the next couple of weeks - at the Supreme Court level.

#### TRUSTEES COMMITTEE REPORTS:

## FINANCE & LAW: No report.

The President reported that the census shows 1,245 residents - with 20 families not yet reported.

POLICE, FIRE & PUBLIC SAFETY: The President reported in connection with the current police study that he, with Chief R. E. Svacha, had a second meeting with the Village Manager of Barrington, the Chief of Police and two lieutenants, and is very encouraged by the proceedings so far. There are still minor details to be investigated within the next week and then the findings can be presented to the Finance Committee and the Police Committee.

A proposed curfew ordinance and a proposed litter law have been submitted to the trustees committee for consideration at the next board meeting.

**BUILDING REGULATIONS - HEALTH & SANITATION:** Trustee Gross advised that Building Officer Milton Schwartz is working on revisions and updating of the building code. This is a long drawn-out project and it will be some time before a report and recommendation is made.

Discussion on the proposed trash and garbage service will be deferred to a later time when there is a lighter agenda.

ROADS & PUBLIC UTILITIES: No report.

PARKS & AUXILIARY SERVICES: No report.

**PLANNING & ZONING:** Trustee Forrest advised that the subdivision on Indian Trail Road has not as yet been accepted by the county.

Trustee Krumlinde read in full letter of agreement with Paul J. Levin, Professional Sanitary Engineer, for a retainer of \$1,200 per annum payable quarterly. After discussion Trustee Krumlinde moved to authorize the President to execute the agreement with Mr. Levin - seconded by Trustee Gross -

By roll: AYES: Trustees Davis, Forrest, Gross, Jablonski, Krumlinde and Schulke. NAYS: None ABSENT: None

The President declared the motion carried.

The President submitted Resolution No. 253 - appointing Edmund R. Weaver to the Plan Commission for a five year term commencing September 23, 1968. Trustee Forrest moved to confirm the President's appointment of Mr. Weaver - seconded by Trustee Krumlinde and passed unanimously.

<u>PLAN COMMISSION:</u> In the absence of Chairman R. E. Johnson, Secretary B. M. Jaremus read Mr. Johnson's letter, dated September 19, 1968, addressed to President Anderson, outlining the Plan Commission's consideration of petition of Kenneth V. Schmid for planned development of his property, consisting of 33.5 acres, and recommending acceptance and approval of the petition. The planned development would allow 10 building sites, varying in size from 2.0 to 4.3 acres in a 5 acre zone, with the "average" lot being 3.0 acres.

Mr. Jaremus then read Mr. Johnson's letter of September 19, 1968, to which was attached summary of the comments and deliberations made at the September 18, 1968 Plan Commission meeting, which resulted in the recommendation that the petition be approved. Mr. Jaremus read the summary in its entirety.

Mr. Johnson's letters were entered into the record with the Village Clerk. The board expressed appreciation for the thoroughness of the report and commended the Plan Commission for its untiring and sincere efforts.

President Anderson said that in the interest of an orderly review and discussion all trustees would have an opportunity to speak in turn, after which visitors would be heard.

Trustee Forrest, Chairman of the Trustees Committee on Planning and Zoning, said that for Mr. Schmid's petition to be considered fairly the whole scope should be reviewed. He then asked Mr. Jaremus what hardship was involved by Mr. Schmid. Mr. Jaremus advised that no hardship was involved; that Mr. Schmid has complied with the requirements for consideration under this ordinance.

Trustee Forrest then said that copies of the letters from school board officials and others, opposing the petition - mentioned in Mr. Johnson's letter to the President - had not been transmitted to the trustees and asked that this be done. The letters from the various school boards et al, including the letter received at this meeting, were entered into the record with the Village Clerk.

Trustee Forrest then said he felt approval of this petition would set a precedent. He said the Oaksbury Subdivision referred to in the summary did not establish a precedent as that was a pre-annexation agreement, which prevented certain property in another municipality from being developed into lots of 12,000 sq. ft., and did not result from consideration by the Plan Commission.

Trustee Forrest then commented on the summary - paragraph by paragraph - and reiterated the philosophy of the Village for low density planning.

Trustee Jablonski said he felt the trustees must view this petition realistically and legally. The Village has a Planned Development Ordinance, and he felt sure that when the ordinance was adopted consideration was given to the feelings and the interest of the various people. He then said he had been on the Plan Commission for a number of years and is well aware of the amount of time and sincere effort put forth by the members of the commission. He said he felt the comments made by Mr. Johnson could not be improved upon.

Trustee Schulke then pointed out that the planned development regulation is not mandatory, but rather is permissive - and acceptance is voluntary on the part of the Board of Trustees.

President Anderson then read the planned development section of Zoning Ordinance No. 88 for the edification of all present.

President Anderson then advised he had just received and had read a copy of the Barton-Aschman report, prepared for the Barrington Area Development Council, of which the Village of North Barrington is a participating member. He said none of the trustees has as yet seen the report, which will be available officially on October 15. He said the report is very interesting, gives a fine review of the Village of North Barrington Zoning Ordinance, and is important with respect to any change in zoning.

Trustee Jablonski said that judging by the audience there had evidently been a lot of solicitation and campaigning for opposition to the petition. He said he felt the petition should be judged on its merits.

Mr. David Baldwin said he had attended the public hearings and did not wish to be redundant, but he did wish to reiterate his ppposition. Mr. Baldwin then read a prepared statement, which is attached to these minutes.

Mr. Hans Huning said he would like to go on record as a resident of the Biltmore-North Barrington area for 16 years, and strongly supports the views of those opposing the petition. He said in any issue, starting from the very top, there is campaigning. He said that - campaigning or not - he would like to feel that he could make up his own mind. The trustees are here, not only to listen, but to represent the public interest - - so - - he being the public, he felt he must voice his opinion to the Board of Trustees in opposition to the petition.

Mr. Arthur Rice Jr., said - "I live within a mile of the perimeter, and am president of the North Barrington Association, but do not necessarily voice the opinion of all people of the area. We all owe a great deal to R. E. Johnson

# PREPARED STATEMENT READ BY MR. DAVID BALDWIN AT BOARD OF TRUSTEES MEETING 9/23/68 - (GS)

I speak for myself as well as a great many residents in North Barrington; varying numbers of whom have attended the preceding Plan Commission meetings pertaining to the Schmid petition. I believe even the Plan Commission will agree the great majority of these people are opposed to the Schmid proposal.

In order of importance our objections are:

1. A conviction that any breakdown of the present zoning will lead to deterioration of the community as we know it.

2. The heavier tax burden to support an already crowded school situation.

3. Traffic congestion more serious than it already has become. Out of the Plan Commission deliberations on the Schmid case, has come a summation which Mr. Johnson read at the last Plan Commission meeting, and which he subsequently distributed to you Trustees. In it, Mr. Johnson states there are two key questions raised by the Schmid petition, the first of which is in two parts -- so let's call them three questions. They are --

1. Does the petition meet the requirements of the zoning ordinance?

2. Will approval set a dangerous precedent?

3. Is it, or is it not, a provision that should be in our zoning ordinance.

By "it", we refer to the Planned Development concept.

As regards the first question -- I think we agree Mr. Schmid has in excess of 20 acres, and that the proposed number of homesites is within the two per five acre allotment. However, another clause in the ordinance says, "In the case of every Planned Development, the Plan Commission shall find such development is for the purpose of promoting an orderly transition from one District to another". We say the petition does not comply here and the Plan Commission has misread, or does not understand the intent of the Planned Development clause.

The Schmid property is in District R-1 ( 5 acres), and is not adjacent to another District of lesser tract size within this village, and it is this village/which the Commission should be concerned -- not Lake Barrington or Crystal Lake, or Rolling Meadows. To be sure, there are lots across the road from Schmid that are under 5 acres -- just as there are lots across from us that are under 5 acres. Indeed, North Barrington has some very small lots -- but the main reason for incorporating in the first place was to upgrade the community and have a better chance to maintain that upgraded level. The founding fathers had to start somewhere, and we believe they di d an outstanding job of making this community unique. The Plan Commission, in its self appointed role as arbit where of the population explosion, now recommends that you begin nibbling away at this great achievement.

Mr. Johnson's second question -- will approval set a precedent? We say, "yes", it will definitely set a precedent. He already claims a precedent, Oaksbury, but it was born or planned prior to annexation to our village. The annexation of Oaksbury with its present layout was not just accepted, but eagerly sought in order to keep it from being annexed to Lake Zurich with approximately a 12,000 ft. minimum lot size.

The third question -- Should the Planned Development provision be in our zoning ordinance at all?

We agree with Mr. Johnson that it should be in, so long as it gives us maneuvering room for the Oaksbury's and other large properties outside the village that we would like to pull in. Paragraph 13.03-1 in the zoning ordinance says "Planned Developments shall be permissible --" They are not stated to be an inalienable right to every large property owner. In other words, gentlemen -- at your discretion.

Mr. Johnson's final comments pertain to the inevitability of change, and the resulting increase in population density. Again, we agree, but we submit that it was to avoid this becoming a problem in North Barrington that we incorporated, adopted a strict zoning ordinance, and appointed a Plan Commission. We, therefore, request that the Schmid petition be denied, and that the Plan Commission be better indoctrinated with the reasons for their existence.

# Post Script --

In the course of these proceedings, I've been somewhat surprised by the number of people who are very much opposed to the Schmid petition, but who do not always show up at the meetings to voice their objection. Upon checking into this more closely, we find that many of these individuals own less than 5 acres, so therefore feel ill at ease in speaking out against a property owner

with 33.5 acres. This fact led me to check the individual Plan Commission Members and Village Trustees insofar as their land holdings were concerned. The majority of these individuals do reside in R-2 or R-3 Districts. I point this out because the psychological implications are obvious. Therefore, I think it's important to point out that the owner of the smallest lot in North Barrington has just as much at stake here as do the very large property owners. It is much akin to the person owning one share of a large corporation. Certainly he has the same interest in the success of that corporation, as does the owner of 1000 shares. We respectfully ask that the Village Trustees deny this petition.
