#### **PUBLIC COMMENTS**

President Abboud opened a thirty-five minute session for public comments at 7:55 p.m.

President Abboud praised Julie McKevitt for all her hard work He said that next to the Police Department, Roads & Bridges has the largest expenditure and Trustee McKevitt did a fine job. The Village Board now needs to consider an appointment to the empty Trustee seat that will last until April of 2009.

President About nominated Elaine M. Ramesh, Village Clerk, to the Trustee position. A motion was made by Trustee Smithe to appoint Ms. Ramesh as Trustee and Trustee Gohl seconded that motion. All present said aye. Trustee Ramesh then joined the board table to finish the meeting.

#### **Motion Approved**

President Abboud and Chief Murphy honored Tracy Morey for her accomplishments with the Barrington Hills Police Department. The Illinois APCO (Association of Public Safety Communications Officials, Inc.,) awarded Tracy Morey a plaque for 2007 Telecommunicator of the Year, 1<sup>st</sup> Runner Up, in the State of Illinois at the APCO-NENA-ICC conference in Springfield.

<u>Frank Cools:</u> Advised the Village of large pot holes on the northeast corner of Haegers Bend and Spring Creek and on Spring Creek east of the red barn. Mr. Cools said there should be 4 NO U-TURNS signs on Haegers Bend at Spring Creek. Waste Management companies trucks disregarding rules and driving around island. Motorists are using Naumann's driveway, at 11241 Haegers Bend Road, to back up as there are no "NO U-TURNS" signs up.

<u>Kathy Soeder</u> – 25 Little Bend Road – was concerned about recalculating South Barrington's impact fee. President Abboud stated BACOG is in charge of this as a regional issue for the Barrington area. There will be more about EAV (equalized adjusted value) in an upcoming Newsletter.

<u>Dave Hollein</u> – 101 Old Dundee Road (Neighborhood Watch Captain) Mr. Hollein wanted to thank Chief Murphy and Julie McKevitt for all their hard work this past year in getting Old Dundee Road cleared of brush. He also presented Chief Murphy with a letter requesting the speed limit around Rts. 59 & 68 be reduced from 55 mph to 35 mph to avoid accidents; place signs advising the lower speed limit and a 10 second delay on the lights. He suggested speed cameras at all three Rt. 68 intersections. Chief Murphy is concerned about the cost of administration for this photo enforcement and he will work with IDOT to reduce speed limit at the intersection of Rt. 68 and Old Dundee.

Also, many fire grid signs are missing from residents homes. Chief Murphy will undertake a coordinated sweep of the Village.

Trustee Schueppert stated that there is very poor accounting and generally sloppy work on the Police Pension Fund. Lauterbach not consistent with figures and reports are not reliable. President Abboud said we, as the Village, provides all funds through our budget and requested a review by the Village Attorney of its authority over the professional service contracts by the Pension Board.

#### **ROADS AND BRIDGES - Fritz Gohl**

Monthly Report – Trustee Gohl indicated that the 2008 Road Program will start with 2.4 miles to be patched and/or resurfaced from Ridge to Old Hart on Oak Knoll and portions of Buckley Road and Cuba Road. Presently a 10 year increment is used to repair roads with an extension to 12 years. Smaller roads will be done every 12 to 14 years, however, through roads such as Ridge would remain at 10 years. Asphalt prices are approximately \$65.00/ton. Bid packages will be taken in May for work to be done in June and July.

Trustee Gohl met with Tom Gooch, Cuba Hwy. Commissioner, regarding the call outs on snowplowing.

# PLANNING - Steven E. Knoop

Monthly Report – Trustee Knoop reported other business as:

<u>Development Committee</u> – Trustee Knoop reported that the members requested that this Commission to disband. If the need presents itself in the future, we can re-commission. Trustee Knoop motioned to disband and Trustee Gohl seconded. Attorney von Meier questioned disbanding. He was informed that Commission members have achieved their goals and as it was an ad-hoc commission. Trustee Knoop motioned again to disband. Trustee Gohl seconded. All present said aye.

Otis Woods Lake Subdivision – Trustee Knoop motioned approval of Resolution 08-02, approving the final plat of subdivision for Lake Otis Woods Subdivision. Trustee Smithe seconded. The former von Paulous property forms a four lot subdivision according to this plat. Trustee Schueppert proposed that Trustee Knoop be given the authority to approve or disapprove the Surety Bond. All present said aye.

Trustee Knoop wants to update our Comprehensive Plan to include such references to Dark Sky, light pollution, landscape lighting and other conflicts with the character of the Village.

Trustee Schueppert brought up the subject of barns used as businesses. Trustee Schueppert will prepare a position paper regarding boarding of horses.

President Abboud requested that Mr. Kosin update him on the house on Oak Knoll Road that has the Frank Lloyd Wright style. Mr. Kosin will report at next meeting.

CN/E J& E Matter – Trustee Knoop motioned approval of Resolution 08-03 objecting to the proposed acquisition of the E J & E West Company by the Canadian National Railway Corporation. Trustee Smithe seconded. Roll Call.

#### PUBLIC SAFETY - Fritz H. Gohl

<u>Monthly Report</u> – Trustee Gohl deferred to Chief Murphy who presented the Police Report for activity in the month of December, 2008. Members of the police department completed 24 hours of training during the past month. Chief Murphy said tickets issued due to new speed limit in 2006 were 2,569 vs. tickets for 2007 of 3,442.

Major Crash Assistance Team Intergovernmental Agreement - Trustee Gohl motioned approval of Resolution 08-01 authorizing an intergovernmental agreement between Barrington Hills and members of the major crash assistance team. Trustee Smithe seconded. The agreement will allow cooperative investigation of major traffic crashes occurring within the jurisdiction of one of the members of the major crash assistance team. All present said aye.

President Abboud thanked Chief Murphy for all his hard work regarding Peter Hommerson in the matter of the January 23, 1996 murders of Marvin and Kay Lichtman, Hommerson was found guilty of four counts of First Degree Murder.

# BUILDING AND ZONING - George L. Schueppert

<u>Building Permit Report</u> – Trustee Schueppert reported that five building permits had been issued during the month of December 2007. They included permits for one detached garage, two additions and alterations, one septic repair and one site development.

ZBA Report – Trustee Schueppert deferred this report to next month.

<u>Cell Tower Amendment</u> – Trustee Schueppert motioned approval of Ordinance 08-02, regarding radio communication towers. Trustee Smithe seconded. The Zoning Board of Appeals voted unanimously in favor of recommending the ordinance to the Village Board. Several public hearings were held on this matter, and public comments were taken into consideration in the production of the ordinance recommended by the ZBA. Roll Call.

<u>Strategic Plan for Village Building</u> – Trustee Mallen reported that modifications of the Lock-up area in the Police Department have been completed. Department of Corrections needs to do final inspection, but the facilities can be used in the meantime. Meanwhile, a new sliding glass door was installed in the Communications area, so that the second dispatch area could be more accessible.
