Mrs. Hansen noted that the purpose of the meeting was to pass a resolution indicating the Village's intent to apply for Federal Emergency Snow Relief and to appoint a representative of the Village to apply for said relief. Mrs. Hansen then presented a resolution authorizing and directing Trustee Louis J. Klein, Jr. (Trustee/Roads and Bridges) to represent the village, and asked for a motion to pass this resolution. Mr. Tucker motioned for the passage of the resolution, and Mr. Kempe seconded. Roll call.

#### RESOLUTION

WHEREAS, the President of the United States has declared the six county Chicago Metropolitan Area an Emergency Snow District Relief Area; and

WHEREAS, said six county area consists of Cook, Kane, Lake, McHenry, Will and DuPage Counties; and

WHEREAS, Federal emergency/disaster funds are available for said area on a 2:1 matching basis for emergency snow removal activities performed during a certain specified period of time; and

WHEREAS, the Village of Barrington Hills is located in the counties of Cook, Kane, Lake and McHenry; and

WHEREAS; the Village of Barrington Hills has undertaken emergency snow removal activities during the period of time presently specified, 12:01 a.m. January 16, 1979 to 11:59 p.m. January 20, 1979, as well as during periods preceding and subsequent to said specified period:

NOW, THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Barrington Hills, Cook, Kane, Lake and McHenry Counties, Illinois, as follows:

- (1) That the facts as contained in the preamble hereof are true and correct;
- (2) That the Superintendent of Roads and the Chairman of the Finance Committee of the Village of Barrington Hills are hereby directed to prepare a "Schedule of Emergency Activities and Costs Thereof" relating to emergency snow removal activities performed by the Village of Barrington Hills during the emergency period, as now is or as it may hereafter be specified, and attach said Schedule hereto as Exhibit A;

- (3) That the Village of Barrington Hills hereby indicates its intention to apply for Federal Emergency Snow Relief in compliance with applicable Federal regulations; and
- (4) That the President and Board of Trustees hereby authorize and direct Louis J. Klein, Jr. to apply for such Federal Emergency Snow Relief as aforesaid.

This Resolution shall be in full force and effect from and after its passage and approval, pursuant to law.
