Year-end Building Report There were a total of 115 building permits issued in 1990. There were 4 building permits issued from December 12th thru December 31st, as follows; 1 single family resident, 1 residential addition, 1 tennis court, 1 satellite dish antenna. There were 43 meetings and inspections.

## HEALTH AND ENVIRONMENT - Lorraine H. Briggs

<u>Insurance</u> Trustee Briggs called the Board's attention to an article in the January Illinois Municipal Review which states that an Illinois law is now in effect which enables IMRF employees to elect to continue the health insurance coverage, that is provided by the Village, when they retire or become disabled. Ralph Jensen, our insurance broker, has been asked to consult our current carrier, The New England, to clarify this law's application to our policy.

<u>Recycling</u> - Trustee Briggs stated that the December report of Browning Ferris shows that the percentage of households recycling in the Village of Barrington Hills has gone up from 20.9% to 35.8%.

## ADMINISTRATION - James A. Kempe

<u>Stationary</u> - Trustee Horne reported on the results of his committee to amend the Village stationary to include the phrase, "A Home Rule Community" which was accepted as presented to the Board.
