ROAD AND BRIDGES - R. Townley Rose

<u>Warning Signs</u> - President Kempe reported a request by the Barrington Hills Riding Club to place portable caution signs on the right-of-way when riders are in the area for special events. President Kempe referred the request to the Village Attorney.

<u>Road Tour</u> - Trustee Fossler reported that she participated in a road tour with the Village Engineer, John Utz, and the Director of Administration, Robert Kosin, on June 2, 1998.

<u>Local Runs</u> - Trustee Briggs requested that sponsors of runs that use roads through the Village publish and notify the Village of their intended routes and dates.

PLANNING - Lorraine H. Briggs

<u>Horn Subdivision</u> - Trustee Briggs reported that both the Plan Commission and the Board of Health have recommended approval of the final plat for the 5-lot Horn Subdivision on Ridgecroft Lane. Trustee Briggs motioned for approval. Trustee Horne seconded. All present said aye.

BUILDING & ZONING - Theodore L. Horne

<u>Building Report</u> - Trustee Horne reported that 14 building permits had been issued between May 15 through June 14, 1998. These include 2 single-family residences, 1 residential addition, 1 residential alteration, 1 inground swimming pool, 1 storage building, and 1 septic system repair. There were 80 inspections completed and 4 meetings attended during this time period.

<u>Special Use/Cummings</u> - Trustee Horne reported that the Zoning Board of Appeals had granted a special use for an artificial lake at 6 Bellwood Road as a shallow "water garden feature". Trustee Horne motioned to grant a Special Use Permit. Trustee Fossler seconded. All present said aye.

HEALTH, ENVIRONMENT AND INSURANCE - Lorraine H. Briggs

<u>Solid Waste Management</u> - Trustee Briggs reported that the May, 1998 recycling report showed that 3.4 truckloads of recyclables had been diverted from landfills.

<u>Workers' Comp Insurance</u> - Trustee Briggs reported that the audit for our Workers' Comp policy was completed, and that no new recommendations had been made.

Employee Medical, Life and AD&D Insurance - Trustee Briggs distributed insurance proposals for employee medical, life and AD&D coverage for July 1, 1998 through June 30, 1999. Trustee McManus motioned to acknowledge our gratitude by sending a letter to the President of the Garden Club of Barrington. Trustee Briggs seconded. All present said aye.
