PLANNING - Lorraine H. Briggs

<u>Hurstbourne</u> <u>Subdivision</u> - Trustee Briggs reported that the new owners are working on a preliminary plat. The Plan Commission will be visiting the site on October 3, 1998.

BUILDING & ZONING - Theodore L. Horne

Building Report - Trustee Horne reported that 12 building permits had been issued between August 17 through September 15, 1998. These include 2 single-family residences, 2 residential additions and alterations, 1 tennis court, 1 private horse stable, 2 accessory buildings, 2 septic systems, 1 septic system repair, and 1 building demolition. There were 82 inspections completed and 2 meetings attended during this time period.

ZBA Report - Trustee Horne stated that the ZBA had met and continued its consideration of an appeal to the next meeting.

HEALTH, ENVIRONMENT AND INSURANCE - Lorraine H. Briggs

<u>Solid Waste Management</u> - Trustee Briggs reported that the August, 1998 recycling report showed that 3.64 truckloads of recyclables had been diverted from landfills, which represents 72,980 pounds collected from an average of 791 homes serviced per week during that month.

BUILDING AND GROUNDS - Francine R. Fossler

Monthly Report - Trustee Fossler announced that the generator had been delivered. She deferred to Don Sadzeck, who is advising the Village in this matter, to outline the scope of problems associated with its installation. Mr. Sadzeck explained that the pre-existing condition of the main distribution panel board was found to contain unforeseen limitations, which necessitate an additional expense of \$6,000 and a two-week delay in completion of the project.

Trustee Fossler motioned to approve the additional cost of \$6,000 to make necessary improvements to the main electrical panel prior to installation of the new generator. Trustee Sweet seconded. Roll Call.
