PUBLIC SAFETY - Brian J. McManus - Chief Robert D. Lamb

Chief Lamb briefly reviewed the December police report.

<u>O. W. Amend Ordinance</u> - The Board of Trustees concurred that further study be given to the ordinance amending the regulations for overweight vehicles. An exemption during the period in the Spring that the 10-ton load limit is in force will be considered by Executive action for moving vans delivering household goods.

<u>Hilltop</u> <u>Kennels</u>- Chief Lamb stated that after January 1, 1992 Hilltop Kennels will no longer accept any stray dogs that may be brought to them. Chief Lamb is looking for a new location and is looking into the County animal shelters regulations.

<u>IDOT</u> <u>Permit</u> - Trustee McManus motioned to pass a resolution for the annual permit from the Illinois Department of Transportation for village construction, if and when it may occur, on state highways. Trustee Klein seconded. All said aye.
