The meeting was called to order at Countryside School at 8:03 P.M. The minutes of January 13, 1975 were approved as read.

The guests introduced themselves and most were horse owners. A possible stable ordinance was discussed. Mrs. Lyons letter of 1-10-75 to Trustee Hansen was read. There followed discussion on these questions: Should there be a limit of one horse per 40,000 sq. feet? Does acreage not used as pasture count? Should drainage be covered? What about contamination of water and streams? Should adequate shelter be covered?

Because of numerous complaints this problem has now come before the Plan Commission at the request of the village trustees. Self-policing action amongst the horseowners has not come about. There was interest about comparable ordinances on the East coast. Some local objections were- boarding by non-residents, over-crowding and polluting.

A guest indicated he has four horses on approximately three acres (pasture and barn). Should residents of Barrington Hills be allowed to board horses? Another guest stated that a notification of violation should be made. Also that some stables can maintain 5 or 7 horses quite adequately, some not.

Trustee Hansen had six complaints last week. These were:

many of these complaints were

boarding horses for profit and pollution (12 horses on 5 acres with excessive manure next to a lake).


The possible ordinance was fully discussed. Those present were requested to make suggestions for a stable ordinance.

Trustee Hansen discussed Barrington Hills Plan that was previously adopted. The Plan was adopted at the same time as the Sub-division Ordinance. Mr. Schultz had preliminary discussions with Barton-Ashman in regard to costs, etc.

Member Galloway discussed an article that appeared in the Wall Street Journal in regard to a village Plan. It was suggested that our ~~real~~ protection is B.A.C.O.G.
