The meeting came to order at 8:35 P.M. and the roll was called. Discussion of the so-called "Horse Ordinance "was moved to a later date. Material on this was distributed to the members, but some was missing making discussion difficult. -- Member Moseley reported on the status of certain areas which are not incorporated into the Village. Sidney Craig, Village Attorney, had advised him that the Dan Donahue Property is non-contiguous to the village.

Mr. Konicek, owner of another area, has not given a specific response to a petition regarding incorporation of his land. He is obtaining further legal advice, it was reported. Ginna Reinhart is reported as not interested in incorporation. Further follow up is required,

Trustee Hansen explained in detail the problem involving the Fred Klein sub-division, Lake Flint Estates. She has been requested to contact Mr. Willett of Wight Engineers and advise him to follow the correct procedure spelled out for the Village Engineer. She will also help Mr. Klein get started on solving his problem. He has to follow the procedure established in the sub-division ordinance. Once again the situation regarding Wight was discussed. His dual function is involved.

Trustee Hansen, who has devoted much time to the BACOG program, brought the commission up to date on the early July meeting of BACOG. She and member Secretary Garre have transmitted comments from the Plan Commission and Village Board regarding the proposed plan. Material covering three memos frome Garre to BACOG (Mr Nelson Forrest, Chairman, BACOG Comprehensive Planning Committee) was distributed to our members for their review and files. These detailed the points and comments regarding changes proposed to BACOG. Trustee Hansen assured members of her comments and concern for proper wording of those recommendations that she had transmitted. In general she expects Barrington tecommendations to be favorably considered. Indications were that the Fox Valley Freeway was to be outside the Village. Service centers and Public picnicing areas were also covered. BACOG is now having the revised material printed and will be distributed to each Village. She has requested 50 copies for Barrington H, or use of Village officials and interested citizens. After review of the material, there must be a public hearing. Sub-sequently we are to report our recommendations to the Village Board.

The matter of attendance was brought up by of Trustee-Observer. Continued failure to attend was felt to be a serious problem and Chairman Cassell gractously agreed to review the matter with those concerned.

There being no further business, the meeting was duly adjourned at 9:50 P.M.
