The funeral of Mr Leonard Vieh took place at the St. Paul's church, Monday afternoon. Rev. Heinrich of Lake Zurich officiated. The deceased was born in Germany, emigrated to America about 1834. After living a few years in the east, he moved to this vicinity living on the Dan Bergmann Farm near Lake Zurich and other places. He was a shoemaker by trade. Owner of Repair Shop Here Past 20 Years

The Rev. William W. Vehe, 83, a retired minister, died at 12:45 o'clock Wednesday afternoon in the home of his daughter, Mrs. Chester Steward, 427 Euclid Avenue, following a year's illness.

The Rev. Vehe for the past 20 years had conducted a general repair shop in Cherokee and was located most of the time in the basement of the Kiwanis theatre building. Failing health forced him to give up the work last August.

Funeral Saturday.

Funeral services will be held at 1 o'clock Saturday afternoon at the home and at 2 o'clock from the Evangelical Reformed church in Brooke township. The Rev. A. Brady will officiate and burial will be in Brooke cemetery. Appleyard & Boothby Funeral home is in charge of arrangements.

Surviving are four children, Mrs. Chester Steward, Cherokee; Mrs. Anna Neisner, Kimball, S.D.; Henry Vehe, Hinton, Ia., and Mrs. Emma Gross, Chicago, Ill.; a daughter-in-law, Mrs. Freda Vehe, Chicago, and a brother, Charles Vehe, Chicago.

The Rev. Vehe was born at Palatine, Ill., September 25, 1855 and came to Iowa in 1892. He was married on Oct. 4, 1878 to Miss Julia Heisenfeldt of Germany at Chicago.

Coming to Cherokee March 1, 1908, the pastor, then retired, opened a shop here and was in business continuously until shortly before his death. Mrs. Vehe died three years ago.

She was confirmed in the St. Peter's Ev. Church in Chicago by the Rev. C. Lambrook, where she was later also joined in marriage to her husband by the same pastor.

On October 6, 1878, she joined hands in holy wedlock with Rev. William Vehe, side by side with Rev. Vehe's sister, Emma, who was given in marriage to Rev. Gottlieb Stanger. Mrs. Vehe was privileged to work with her beloved husband in the ministry in Kansas, west Missouri, north Illinois and Iowa districts for a period of 31 years, when upon her husband's retirement from the active ministry they moved to Cherokee in 1909 where they have lived ever since. They were married almost 57 years.

Her health began to fail when on March 31, 1928, she had a stroke from which she rallied. She broke her hip on August 8, 1931, when she became bedfast and a year later suffered another stroke. She suffered much, while her youngest daughter, Amanda, so much devoted to her mother, was ever ready to lift, feed and wash her, being ably assisted by her husband, Mr. Chester Steward and family and by her father. On May 21, this year, after suffering a severe sinking spell she partook of Lord's supper with her father and daughter, Amanda. Again she rallied, her memory seemed better, she sat up in a chair and was able to eat by herself for several weeks. She fell quietly asleep on July 30 at 4 o'clock p. m. attaining the age of 83 years, 7 months, and 25 days.

She leaves to mourn her departure from life her beloved husband and five children, Mrs. Anna Nitzman of Kimball, SD, Daniel Herman and Mrs. Emma Grove of Chicago, Henry of Sioux City, and Mrs. Amanda Steward of Cherokee; two sons-in-law and two daughters-in-law, 22 grand children, and 10 great grandchildren, and other relatives and many friends. Coming from a family of four sisters and two brothers, she is the last one to depart this life from her parental home and the first one to depart to the great beyond from her immediate family.

Funeral services were conducted Friday afternoon, August 2, at her home where her pastor, Rev. August Beck, had charge of the service. Mrs. Olson, her neighbor, rendered a hymn. The following pastors served as pall bearers at the home: Elmer Ott, Paul M. Wuerthen, John Peril, Carl E. Gables, F.W. Rudy and Otto J. Engleman. Rev. John Fischer substituted for Rev. Paul M. Wuerthen at the church.

Funeral worship service was continued in the St. John's church near Peterson, where Rev. August Beck spoke in the German language, while Rev. P. W. Rudy spoke words of consolation in the American language. They were assisted in this service by the other pastors who had charge of the liturgical service. A double sheet by ladies sang three hymns: *Lass mich geben, Jesus Lover of My Soul* and *Be thou— — — meine Hande*.

Committal service was in charge of the resident pastor, Rev. John Peril offering prayer. All pastors present spoke short committal verses. She was laid to rest in a lot adjoining Mrs. John Sherman in the St. John's Ev. Cemetery near Peterson. Submissive to her Lord in all her suffering, a loving and humble wife and mother has gone from us and as we confidently hope to be at home with the Lord.

A. E. LUNDQVIST

One of the leading business interests of Brink is the implement house of A. E. Lundqvist, an enterprising merchant who belongs to that class of representative citizens that Sweden has furnished to this state—a class that has done much toward the upbuilding and material development of South Dakota. He was born in Sweden, July 8, 1860, his parents being Magnus P. and Emma Lundqvist, also natives of Sweden, born in 1841 and 1843 respectively. Coming to the United States in 1880, they settled in Day county, Dakota territory, where the father secured a homestead claim which he owned and occupied throughout his remaining days, winning success in the upward of the industry and determination which he displayed in the conduct of his business interests. He died in 1887, while his wife survived until 1911. They were members of the Lutheran church and in his political views Mr. Lundqvist was a republican. To them were born four children, three of whom survive, namely: Peter, an agriculturist residing in Brink; A. E., of this review; and Emma, who gave her hand in marriage to Albert Ziegenhagen, a farmer living in North Dakota.

He also owns two farms in Day county and his property is the evidence of a life of well directed energy and skill.

In 1907 Mr. Lundqvist was united in marriage to Miss Emma Veltz, a native of Day county, South Dakota, and a daughter of John L. Veltz, who is a retired agriculturist residing in Brink. Our subject and his wife have two children: Rowanella, who is attending school; and Lloyd.

ROBERT VEHE, SPEED-SKATING BOOSTER

Robert Richard Vehe, 75, a 40-year resident of Mt. Prospect, was a retired manager of contract administration and vice president of sales for Kleinschmidt Corp., Deerfield, a computer service company. Mr. Vehe, who was born in Evanston, died July 9 in Wisconsin.

Mr. Vehe was a nationally recognized volunteer for speed skating and cycling organizations.

Mr. Vehe attended Armstrong School in Rogers Park and graduated from New Trier High School in 1940. He got a bachelor's degree in history in the 1940s from Duke University, where he was a member of the basketball team. In 1953 he earned a certificate in industrial management from the Industrial Management Institute at Lake Forest College.

Mr. Vehe served on a Navy troop ship in the Pacific during World War II. After the war he earned a bachelor of science degree in mechanical engineering from Northwestern University in 1958.

He retired in 1971, after 21 years with Kleinschmidt Corp., where he had been vice president of sales since 1957. After retirement from Kleinschmidt he worked as a real estate agent for George L. Basso and Co., Mt. Prospect, for several years.

In 1994 he was inducted into the U.S. Amateur Speedskating Union Hall of Fame, Newburgh, N.Y.

"Mr. Vehe's contributions to the sports of speed skating and cycling have been equalled by no one," said William Markland, a friend and chairman of the short track speed-skating committee of the International Skating Union.

Markland said that although Mr. Vehe was not a skater, he became interested in the sport when his son began skating and was one of the organizers of the Mt. Prospect Skating Club in the early 1970s.

"He was the coordinator of the Mt. Prospect speed-skating competitions for 20 years," said Markland. Markland said that Mr. Vehe was also instrumental in helping develop a summer cycling event in Northbrook into a major North American cycling competition.

Mr. Vehe compiled, and for the last 25 years published handbooks for both speed-skating and cycling competitions. He was also editor for the past 10 years of *Racing Blade*, the magazine of the Amateur Speedskating Union.

"He did it all on his own, with very little assistance," said Markland. "He was a fighter for the sport of speed skating. His contributions will be missed."

"He had the old-fashioned virtues that are missing today," said his wife of 49 years, Ruth, whom he met at Armstrong School.

Other survivors include a daughter, Constance Sims; two sons, Robert E. and Dr. Richard E., a sister, Ruth Robinson; and five grandchildren.

A memorial service will be held at a later date.

A longtime Mount Prospect man known for his contributions to the sport of speed skating died July 9 at the age of 75.

Robert Richard Vele spent more than 40 years in Mount Prospect, where he got his start in the promotion of local speed skating, said his son and former speed skater Richard K. Vele.

Richard and his brother both were speed skaters, so to support his sons, Vele volunteered his time for the Mount Prospect Speedskating Club, serving various positions including as president, Richard Vele said.

From there, Vele moved to the Amateur Speedskating Association of Illinois, where he served as vice-president and put-out their publications.

A similar progression landed Vele in with the Amateur Speedskating Union of the United States, producing its newsletter, "The Racing Blade." Richard Vele said his father transformed the newsletter into a full magazine with a glossy cover, all from his basement office toward the end of his real-estate career.

"Really, his accomplishments were well beyond his kids' accomplishments (as skaters) in the sport, and we had some accomplishments," Richard Vele said. "It was an honor to have a father like that."

Vele's work reached a pinnacle in 1994, when he was elected to the Speedskating Hall of Fame of the Amateur Speedskating Union of the United States.
