
The only reply to date is from Adenca and a copy of their proposal is attached. The other two firms were not interested.

Attached please find copies of letters from Consoer, Townsend and Associates and Attorney Braithwaite, as well as the Agreement which was prepared by the County of Cook.

I agree with the engineers that this may be minimal in character and does not provide for curb and gutter and sidewalks. In reviewing the file and conferences with State and County officials, I find this is the only improvement we can make at this time unless it is your wish to increase the estimated cost, probably four or five times, and the redrawing of plans and specifications. The County could not schedule any additions to existing program prior to 1971. To provide curb and gutter, sidewalks and drainage, we would have to provide the following to meet state specifications.

- 1. Acquire additional right-of way from Lake to Main Street. This is improved property.
- 2. Remove trees from parkway.
- 3. Provide minimum of 30 foot street width.
- +. Remove at least one home on the corner of Dundee Avenue and Main Street.
- 5. Provide underground storm drainage.
- 6. Install 9,480 lineal feet of curb and gutter.
- 7. Install and replace approximately 4,000 lineal feet of sidewalk.

In view of the afore-mentioned requirements, it is my recommendation that we accept the present Agreement as written with existing plans and specifications.

Our share of the cost, which is \$20,000.00, will be used as follows:

- 1. Cost of excavation.
- 2. Provide top soil.
- 3. Certain drainage controls.
- 4. Repair and replace portions of sidewalks at intersections.
- 5. Certain curb and gutter installation.
- 6. Landscaping.

In order to expedite and assure early completion of this project, I further recommend that our share be paid from M. F. T. funds in two installments of \$10,000.00 each. Dear Mr. Heninger:

Pursuant to your letter request of February 3, 1968 and in accordance with subsequent conversations held with the writer, we have reviewed and return herewith the plans and specifications transmitted by the Cook County Highway Department for the improvement of Dundee Avenue from Hawthorne Road to Main Street.

Generally, the proposed improvement is minimal in character and provides only for widening and resurfacing together with incidental construction. There will be no improvements to existing drainage facilities and no curb and gutter construction. The existing pavement is 18 feet wide, and the plans call for widening to a 22 foot width between Hawthorne and Lake and to a 22 foot and variable width between Lake and Main.

We understand, from conversations with County officials, that this project is scheduled for construction this season. It is anticipated that the project will be advertised to receive bids as soon as the Village has complied with and executed the agreement.

Also, we did not prepare an estimate of the cost of proposed construction. A brief review of the quantities as set forth in the specifications reveals that the project cost will be in the neighborhood of \$100,000. Therefore, we are of the opinion that this is a very acceptable offer from the County in view of the fact that the Village portion of the total cost is only \$20,000.

February 26, 1968 -2-Mr. Robley D. Heninger If the Village desires a special assessment for curb and gutter and drainage improvements, proceedings could be initiated sometime in the near future, i.e., two to five years. This special assessment may also include any necessary further widening of the pavement if parking is to be permitted on the street. In this connection, since Dundee is a County Highway, any width of improvement face to face of curbs proposed by the Village will probably require approval by the County or the State. Although we can anticipate regular increases in construction cost, we feel that additional negotiations with County officials at this time could possibly "rock the boat" and delay the entire project indefinitely. Blanke President Village of Barrington Village Hall 206 South Hough Street Barrington, Illinois Dear Mr. Blanke: With regard to the application by the Whitney Realty Company to construct a four-family apartment building in the southwest corner of Lake and Spring Streets: 1 As I understand it, the application was originally denied by the Building Commissioner because in his opinion granting it would involve a violation of the Zoning Ordinance. An appeal from this decision was taken to the Zoning Board of Appeals, and the Board of Appeals reversed the Building Commissioner's decision and directed that the permit be issued. Under the Zoning Statute, the Board of Appeals has the authority to review any decision of the Building Commissioner involving an interpretation of the Zoning Ordinance; an appeal from its decision may be made to the court. The Village Board has no jurisdiction to overrule or change the decision of the Board of Appeals. If the Board of Appeals has directed that a permit be issued under these circumstances, and this decision of the Board of Appeals has not been appealed to the Circuit Court under the Administrative Review Act, it is the duty of the Building Commissioner to issue the permit. The courts on those facts would issue a writ of mandamus to compel the issuance of the permit. I recall that this matter was discussed some time ago, and I recall making the same statement as to the jurisdiction of the Board of Appeals previously. On the question of granting variations, the Board of Appeals merely recommends. But on the question of interpreting the Zoning Ordinance, the statute gives it semi-judicial jurisdiction, and its decision cannot

be reversed by the Village Board of Trustees.

Cite Home Shortage In Lake Zurich

LAKE ZURICH — The lack of adequate, low-priced housing in Lake Zurich is hurting the development of industry and is causing a serious shortage in manpower, but home-builders insist that the day of the \$15,000 home is over and that industry is living in a Utopia.

Industry spokesmen have said that if proper housing and rentals are not provided, "There is very little we can do to encourage industry to settle here. Our plant personnel come from surrounding communities and they go back to their homes to spend their money." INFORMATIONAL

The loss of income, they maintain, to local merchants is significant.

The industrial community reports that the shortage of help is being felt here severely and "unless there are more people available for the jobs we have created there does not seem to be much sense in bringing other industries into the area."

One spokesman said, however, that he did not favor "cheap housing," because there is really "no need for it."

Asked if he thought a laborer earning \$2.10 an hour can afford a \$20,000 home, he answered, "Most of our employes are earning a secondary paycheck—they are not the prime wage earners."

Industry's point-of-view was made in a letter to the Lake Zurich village board in September and the debate on the pros and cons of the housing problem has been raging since.

In addition a pre-annexation agreement entered into by the village trustees for the land surrounding the Northeast Industrial Park stirred up the fires of controversy again.

controversy again.

The 235-acre tract is to be used for an industrial - apartment building complex, if and when the village's zoning and planning commission approves the agreement.

Builders strike back with, "Industry would love it very much if we put up an apartment building with two or three bedrooms and rent it for about \$125 a month."

But the builders insist that prices for this type of rental housing starts at \$165 and "builders who want a fair return on their investment, (6 per cent is the figure most give) want to lessen the gamble, not in-

The large size of incoming industry and the apparent reluctance of plant management to settle in the Lake Zurich area are other reasons, builders and

real estate agent said are creating problems.

"Besides," one building contractor added, "housing is no longer cheap. The high cost of land precludes automatically the low-priced house. If industry wants that type of housing — let the government build them." Another said that good housing starts today at \$22,000, and with the cost of the lot, development of the property and compliance with village subdivision costs and codes "its surprising the good-house cost is not higher."

They said it costs between \$15 and \$20 a square foot to build. It has been accurately estimated that a three - bedroom home requires a minimum of 1,200 square feet and at \$15 a square foot and a \$4,000 improved lot it comes to \$22,000.

Nobody, another builder said, wants government barrack - type housing. "Who wants to move 35 miles from Chicago to live on a 'Chicago lot' — which is 25 to 35 feet wide."

Still another critic of industry said, "They are living in their own little Utopia and they figure that builders have a magic ward or the village board can solve all their housing and labor problems for them. They are complaining that they have to go to Round Lake Park or Round Lake Beach for laborers."

Others said that the smaller the industry, the higher the skills and earning power and therefore the better able the worker is to afford the \$20,000 to \$22,000 homes.

'What we need are small plants that employ from 10 to 25 people — these are the plants that do us the most good. Plants that can fit onto the two to 10 acre plots," another said.

As of the moment, however, there are no builders contemplating any large-scale building in the Lake Zurich area.

One industry spokesman, Thomas Cox of Clayton - Mark and Company, said, "We as a group are not going to build anything. Our feelings are that restrictions on the available labor market are due to the shortage of moderate - income housing."

He added that the industrial community has informed the board about the situation, "So as to build a communications link between them relative to any expansion plans being contemplated for industry and problems involved with labor and housing shortages."

Consolidation Study Merited

A proposal to consolidate 10 northwest Cook County communities into Illinois' second largest city has, understandably, captured widespread attention.

The plan is breathtaking in its scope; it would open for reconsideration every accepted economic and political fact of life in each of these communities, and their neighbors.

The proposal was made by John G. Woods, village president of Arlington Heights, to other members of the Northwest Municipal Conference. Many months of preparation went into Woods' presentation, which he said was based on an awareness that "the wellbeing of these individual communities, from both political and economic viewpoints would be substantially advanced by consolidation of these communities into one municipality."

Woods specifically cited "economies of operation possible in such areas as fire, police, health, flood control, water and sewer service, garbage disposal and street maintenance."

We agree with Woods that consolidation of the communities of northwest Cook County makes sense. The communities, especially along the North Western Railway, represent a continuation of development in which

boundaries in many respects are lacking in any non-political significance. Driving from one community to another, it is difficult and sometimes impossible to distinguish them.

Still, wholesale consolidation of these communities is not a project likely to be accomplished in the near future. Political boundaries in some cases do represent aspirations of citizens.

Many came to the suburbs to "get away" from the big city. So many came, in fact, that they built another big city—a city of 250,000 people, expected at least to double itself before its growth is spent. The small, independent suburb may be growing into a myth, but it is a myth many will want to cling to for many years.

Economic factors also separate suburbs. One which has a rich revenue base—in industry or commerce—is not likely to be eager to share this with its neighbors.

Another that has developed a reputation for prestige home developments is not likely to welcome loss of this identity.

Some who acknowledge the efficiencies of a larger unit of government will cling to their right to be less efficient to preserve what may be an emotional or political objective.

What, then, can an idealistic approach accomplish?

It has accomplished much already, by forcing residents and community leaders to look at the role of the suburban community today and by forcing awareness of the interdependence of the northwest communities.

If mass consolidation seems unlikely at the present, more limited action seems distinctly possible. A study of the problem—or is it an opportunity?—of interdependence at the very minimum might result in a simplification of community boundary lines. The quiet annexation warfare of the past decade has led to disgracefully complicated boundaries, with corridors of land uneconomical to service and with little real relationship to the home communities.

The study might also lead to more limited consolidations of two or more adjacent communities where advantages of a marriage are more discernible to voters:

A discussion of consolidation within the Northwest Municipal Conference might also lead to consolidation of some services. For example, new fire stations could be located where they would best serve the needs of the surrounding population, regardless of boundary lines. An area police force might be developed to deal with the growing problem of suburban crime. Garbage disposal might be provided participating communities through a compact arrangement. There is some precedent for this kind of joint action in the formation of a regional water commission several years ago.

Woods' proposal deserves serious consideration. Even if it does not lead to area consolidation, the study could be the catalyst for numerous improvements in local government organization and efficiency.

Suburb Merger Study Report Due March 27

The special Northwest Municipal Conference committee, formed to study and make recommendations on the proposal of Mayor John G. Woods that 10 northwest Cook County suburbs consolidate into one new municipality, will make its first report March 27.

The committee will recommend to the mayors of the 10 suburbs at their March 27 meeting that immediate steps be taken to begin all useful torms of co-operation as a first step toward ultimate consolidation.

Specifically the study group is the Committee on Intergovernmental Co-operation of the Northwest Municipal Conterence. It was appointed by conference president Ted Scanlon, Mayor of Wheeling, in February, Members are Mayor John G. Woods of Arlington Heights, Mayor Jack Pahl of Elk Grove Village and Village Manager Curt Olson of Wheeling.

ON FEB. 21 at a meeting of the Northwest Municipal Conference Woods proposed that 10 northwest Cook County suburbs immediately study the possibilities of consolidating into one municipality. The proposed municipality would have an immediate population of 250,000 to 300,000 and a potential population of more than 1,000,000. Such a municipality would become the second largest city in Illinois

Suburbs included in Woods proposal are Wheeling. Schaumburg. Rolling Meadows. Palatine. Prospect Heights. Mount Prospect. Elk Grove Village. Des Plaines. Bullalo Grove and Arlington Heights.

RECOMMENDATION from

public education. It is probable that there will be recommended a subcommittee on developing immediate cooperation between the villages on many common activities as possible.

A third recommendation will suggest that a grant be sought from a foundation with funds for municipal research in order that the consolidation study advance more rapidly and have the benefit of professional assistance.

ALREADY AGREED upon are several subject areas to be covered in a report to be placed in the hands of the northwest village mayors. These include:

Legal Aspects of The report Consolidation will reveal that village con solidation is not an action to be taken by village governments. Rather, under Illinois law, it is an action undertaken by citizens of villages. Citizens of any number of municipalities may institute consolidation action by presenting to a court peti tions bearing signatures of 10 per cent of the number of persons voting in the last municipal election. The peti tions would ask that consolidation be brought about Once the petitions have been filed, the court sets the date for a public referendum. The proposition must carry by a simple majority vote in each municipality. Consolidation action may involce two or more municipalities.

Types of Municipal

Government - The report will show that it is possible that a new municipality of 250,000 population could have a village form of government. At the time of consolidation the form of government would be chosen from one of the types - adlermanic, city manager or commission. Once the type of government selected was established, action could then be instituted to covert to a village type of government.

Retention of Local Identity Local identity, the report will reveal, is not only possible to maintain, but is required for a period of years. In a consolidation the former villages become boroughs. Municipal indebtedness of the previous villages remains the responsibility of the borough. Zoning regulations of the individual village would remain in effect for the borough for a stipulated period of time or until new comprehensive zoning for the new municipality is developed.

THE REPORT of the study group will include a list of the activities in which common effort, either through immediate co-operation or later consolidation, would be effective. Some of these will be termed urgent.

An example of immediate concern will be the role of the volunteer fireman. It is regarded possible by the study committee that volunteer tiremen will be found to be contrary to state regulations as has already been the case with voluntary police.

Pursuant to the request of the Village Board, we have investigated and submit herein our report on the preliminary estimate of cost for improving Commuter Parking Lot No. 2. Prior to commencing our study, the writer had a meeting with Village Manager Gaffigan who requested that we consider one-way traffic on Park Avenue with angle parking, and the possibility of relocating the passenger pick-up and drop-off area. Subsequently, we were also asked to include the estimated cost of landscaping the area abutting Park Avenue.

A detailed investigation of the existing parking facilities indicates that the disposition and physical arrangement of parking in Lot No. 2 on the west end, and also on Park Avenue, influences traffic flow in the area. Personal observations by the writer of conditions during the evening rush hour (5:30 PM to 6:30 PM) indicate that the proposed one-way system on Park Avenue and in the west parking area, as shown on Plates I and II, may actually help traffic congestion in this area by directing vehicles away from the Cook Street-Main Street intersection.

Inasmuch as the information requested of us was limited as to scope, we did not attempt to investigate the traffic pattern in the entire downtown section during said rush periods. However, we have indicated on Plates I and II the installation of "No Turns", "No Left Turns" and "Stop" signs at the intersections of Main Street with Cook Street and Lake Street with Cook and Grove Streets. In our opinion, this suggested sign installation will improve traffic flow in the immediate area and we submit it for your consideration.

Our preliminary estimate of cost for improving the west end of Parking Lot No. 2 is divided into Alternate Parking Plan A, as shown on Plate III, and Plan B, as shown on Plate IV.

Under Plan A, passenger pick-up and drop-off would be accomplished on the north side of Park Avenue in the first 160 feet east of Cook Street, with the remaining length to the west parking area ramp striped for angle parking. Angle parking would also be provided on the south side of Park Avenue, which would be one way to the east. The existing ramp to the west parking area would be widened for entrance and exit, and the Cook Street entrance would be barricaded. The 90-degree parking arrangement in the parking area would remain the same.

Under Plan B, the passenger pick-up and drop-off zone would remain as presently located but traffic in this area would move in an easterly direction away from the Cook Street and Main Street intersection. Park Avenue traffic would also move in the same direction and angle parking would be provided on the north side of Park Avenue, with unchanged parallel parking on the south side.

Following is our preliminary estimate of cost for Plans A and B. We have also included an updated preliminary estimate of cost for improving the east end of Parking Lot No. 2 in accordance with our plans of 1963 and, as an alternate, resurfacing and landscaping only.

Pursuant to the request of the Village Board, we have investigated and submit herein our report on the preliminary estimate of cost for providing sanitary sewers, water mains, and limited storm water drainage facilities for approximately 140 acres of sparsely developed land on the South side of the Village of Barrington. The area studied is bounded on the North by Illinois Street, on the South by Cornell Avenue, on the West by Barrington Road, and on the East by George Street. We have also included in the sanitary sewer study several lots north of Illinois Street on the east side of Barrington Road.

The area generally consists of rolling landscape with several water ponding areas and suspected unstable subsoil conditions in and around said ponding areas. The exact location and limit of development of all underground facilities will be dictated to a large extent by ground conditions. Soil explorations will have to be made prior to design of the detailed construction drawings to determine the exact nature and extent of unstable soil conditions. Part of the large ponding area in the vicinity of the intersection of Grove Street and Harvard Avenue may prove to be not feasible for building construction. However, for the purposes of this report, we have assumed that all lots shown in the subdivision are buildable.

Our preliminary calculations indicate that the lift station and force main, presently being constructed by the Southgate Development Company in Barrington Road, will be sufficient to serve this additional area, if developed entirely residential. Therefore, we have tentatively provided for a gravity sewer system to terminate at the intersection of Cook Street and Harvard Avenue. An additional lift station will have to be installed at this point to pump the sewage through a force main

south in Cook Street to the proposed Southgate 12" sanitary sewer in Cornell Avenue. This system will be adequate to serve all of the lots in the area. However, some residences in the Bakers Lake basin may have to be served by the installation of individual sewage ejectors. This matter will be more thoroughly investigated at the time of preparation of the detailed plans. The proposed sanitary sewer system is shown on Plate I.

The proposed water main system will consist of 6" and 8" internal diameter water mains arranged in a loop system as shown on Plate II. Connections to the existing Village system will be made on Illinois Street at Hough Street, Grove Street, and Summit Avenue. Connections will also be made to the proposed Southgate 8" water main in Cornell Avenue. No problems with water supply are anticipated in the initial stages of development.

The large ponding area centering at Grove and Harvard is presently drained by an existing 18" diameter tile pipe from a point on the east side of Cook Street approximately 300 feet north of Princeton Avenue, and then flows underground to a point on the east side of Barrington Road approximately 100 feet north of Cornell Avenue. An existing box culvert takes the storm water under Barrington Road into a watercourse that ultimately empties into Keene Lake. Obviously, this existing storm sewer outlet is not effective in eliminating the ponding of storm water in this large area. Development of the now empty spaces in the drainage basin will be hastened by the installation of sanitary sewers and water mains and this will increase the rate of runoff to the ponding area and compound the flooding problem.

Therefore, we recommend the simultaneous enlargement of the culvert under Barrington Road and the installation of a trunk sewer to at least the large ponding area. These facilities would be designed to accommodate the storm water runoff from the area under an ultimate developed condition and to serve as a trunk storm sewer to a complete storm sewer system that will eventually have to be installed throughout the drainage basin. The existing watercourse draining into Keene Lake may also require future deepening and widening to accommodate drainage from the completely developed area.

Following is our preliminary estimate of cost for providing sanitary sewers, water mains, and storm water drainage outlet for this area. Said estimate of cost includes legal and bond discount costs incidental to special assessment proceedings.

In accordance with the authorization of the Board of Trustees, we have started preparation of Plans and Specifications for additions to the Barrington Water Pollution Control Plant.

We have completed Basic Design Data, which is a document describing details of proposed plant units. We are enclosing ten (10) copies of the Basic Design Data.

We are also forwarding copies of the Basic Design Data to the Illinois Sanitary Water Board for their information and comment. A copy of that letter of transmittal is attached.

As we discussed in our letter to you of January 18, 1968, we are of the opinion that tertiary treatment can be accomplished at Barrington with automatically backwashed, rapid sand filters, instead of a two-day effluent detention pond as recommended in our Report of May, 1967. Further, we are of the opinion that rapid sand filters can be included within the original project budget.

The attached Basic Design Data, therefore, proposes automatically backwashed, rapid sand filters, and describes such facilities.

The Data also describes all other proposed units, and how existing tanks and buildings will be utilized. In certain details, there are variations from our original Report, which are the result of detailed design calculations and actual equipment layouts.

If there are any questions concerning this information, please advise us. We would be pleased to meet with you to review the information.

The Basic Design Data, including the proposed rapid sand filters, should receive at least the general approval of the Sanitary Water Board at this time, before detailed Plans are completed. We are, therefore, sending copies of the Data to the Sanitary Water Board. A copy of that letter of transmittal is attached.

Action involving acquisition of property for the previously recommended detention ponds should be held in abeyance pending comment on the rapid sand filters by the Sanitary Water Board.

- 3. On Page 8, in the tabulation describing sludge dewatering, the fourth item should read, "conditioning chemicals at 12% pounds per day."

I talked with Chief Muscarello and Attorney Braithwaite today and our compliance with Section 4 of proposed ordinance is as follows:

- 1. The badge of office for a Marshal will be a shield rather than a star.
- 2. Shirts of different color.
- 3. Arm patches of different design.
- 4. Campaign hats on Marshals, caps on Police Officers:

Mr. Braithwaite will, we hope, have the draft of the proposed ordinance in your hands by Friday, March 8, 1968, in order that Board action can be taken on March 11, 1968.

When this was set up, we advised that the Legislature was to meet in March and that if the Legislature could take action to allow for part-time policemen and auxiliary policemen within that sixty (60) day period, or within an additional sixty (60) day period, these appointments would suffice. However, we also pointed out that if the Legislature failed to act within a total of one hundred and twenty (120) days from the date of the appointments, we would suggest that marshals be appointed. We have now received from the Illinois Municipal League a Newsletter, No. 68-2 and draft ordinance, copies of which are enclosed. I wonder if you would discuss this with Harry Pillman and Chief Muscarello and let us know whether particular items of the draft ordinance are troublesome. One thing I especially call to their attention is the provision in Section 4 that uniforms and identification symbols be different and distinct from those of the regular police department. I do not believe that this language need be in the ordinance, at least in that form but the language does point to the desirability of having the differentiating uniforms or shoulder patches, etc.

My independent information confirms that contained in the League Newsletter that the Legislature is not likely to take any action in its March meeting. If this turns out to be accurate, then we should proceed with an ordinance establishing the position of marshals during the month of March, before the present sixty (60) day appointments expire.

Re: Municipalities operating under the Board of Fire and Commissioners Act

As you know, the First District Appellate Court (1st Division) recently handed down a decision in the case of Gasparas v. Gualano, as President of the Village of Justice, 231 NE 2d 669, in which the Court held all persons performing police duties under the Fire and Police Commissioners Act must be appointed by this Board, and that said Board can only appoint full-time paid police officers. The decision appears to have the effect of prohibiting special auxiliary or any type of police other than full-time paid.

The following committee of municipal attorneys was appointed by the Legislative Policy Committee of the Illinois Municipal League, to consider the problems presented by this decision:

Louis Ancel, Attorney for Municipalities, Chicago - CHAIRMAN Marvin Glink, Attorney for Municipalities, Chicago George Billett, City Attorney, Elmhurst Arthur Thorpe, Attorney for Municipalities, Chicago James Sneider, Village Attorney, Niles J. Edgar Kelly, Village Attorney, Glen Ellyn Frank M. Pfeifer, General Counsel - Illinois Municipal League

The Committee, after considerable study, was of the opinion Sections 3-7-1 and 3-9-4 of the Illinois Municipal Code authorized the appointment of municipal marshals by the governing body of the municipality, which appointments would be by the corporate authorities and would not be in contravention or violation of the decision of the Appellate Court.

A suggested ordinance to accomplish this result has been prepared and a copy thereof is enclosed. It is the feeling of this Committee the marshals appointed under the ordinance are separate and apart from the regular police department, and this distinction should be carried out. It is also felt the use of firearms by the marshals should be rigidly controlled by the municipality and issued to them only by the municipality.

The Committee also felt that it would be wise to have legislation specifically authorizing the appointment of auxiliary police and has prepared such a bill for presentation to the Legislature. It is planned to introduce this bill at the legislative session on March 4, 1968, but is our understanding that no action will be taken on bills introduced at this time, at least until the anticipated session in July of 1968.

If your municipality does adopt the enclosed ordinance, and thereafter, it is challenged in court, we would appreciate being advised of this as soon as possible after the challenge has been made.

In adopting this ordinance, your attention is called to Section 3-7-1 of the Municipal Code which requires a 2/3 vote of the Council for its adoption. You will note the ordinance does not prescribe any qualifications for the appointment of the marshals but instead, allows the Council to appoint those persons it desires. Qualifications could be spelled out in the ordinance if your municipality desires to do so.

It is the feeling of the Committee the enclosed ordinance will solve the problem until such time as legislation can be adopted.

AN ORDINANCE ESTABLISHING THE OFFICES OF (VILLAGE) (CITY) MARSHAL AND DEPUTY MARSHAL AND PROVIDING FOR THE OPERATION THEREOF.

BE IT ORDAINED by the (President and Board of Trustees)
(Mayor and City Council) of the (Village) (City) of
County, Illinois, as follows:

Section 1:

There is hereby established the office of (Village) (City) Marshal. The (Village) (City) Marshal shall be appointed by the (Village President) (Mayor) with the advice and consent of the (Board of Trustees) (City Council). The (Village) (City) Marshal, in addition to his duties as Marshal, may be appointed or employed by the (Village) (City) to act in any other capacity, provided that such appointment or employment is compatible with his duties as Marshal.

Section 2:

There is hereby established the office of Deputy Marshal. Deputy Marshals shall be appointed by the (Village President) (Mayor) with the advice and consent of the (Board of Trustees) (City Council) in such number as the corporate authorities shall from time to time deem necessary.

Section 3:

The (Village) (City) Marshal and the Deputy Marshal shall serve at the discretion of the (President and Board of Trustees) (City Council) and may be removed from office at the will of the (President and Board of Trustees) (Mayor and City Council). The (Village) (City) Marshal and the Deputy Marshals shall receive such hourly compensation for their services as determined by the corporate authorities.

Section 4:

The (Village) (City) Marshal when functioning as Marshal and the Deputy Marshals shall not be considered to be members of the regular police department of the (Village) (City) and shall not function on a full-time basis. Uniforms and identification symbols of the Marshal and Deputy Marshals shall be different and distinct from those used by members of the regular police department of the (Village) (City). The Marshal and the Deputy Marshals shall at all times during the performance of their duties be subject to the direction and control of the Chief of Police of the (Village) (City).

Section 5:

Deputy Marshals shall perform such duties as directed by the (Village) (City) Marshal or by the corporate authorities. Deputy Marshals shall not carry firearms except with the special permission of and when issued by the Chief of Police, and when in uniform and while in the performance of their duties.

Section 5:

The (Village) (City) Marshal and the Deputy Marshals shall be conservators of the peace and shall have the following powers and duties:

- (a) to arrest or cause to be arrested, with or without process, all persons who break the peace or are violating any municipal ordinance or any criminal law of the State;
- (b) to commit arrested persons for examination;
- (c) to serve and execute all warrants for the violation of municipal ordinances or the State criminal law within the limits of the (Village) (City);
- (d) all statutory and common law power of sheriffs;
- (e) to direct traffic and assist in traffic control;
- (f) to act as watchmen on special assignments;
- (g) to assist in parade control and to keep peace in all large gatherings in and about the community;
- (h) to assist in Civil Defense matters;
- (i) to assist in cases of riot, disaster and emergency control; and,
- (j) to perform such other related duties as directed by the Chief of Police of the corporate authorities.

Section 7:

The Marshal and Deputy Marshals so appointed shall at the time of their appointment execute to the (Village) (City) a bond in the amount to be established by the corporate authorities with sureties to be approved by the corporate authorities and conditioned as required by law.

Section 8:

That all ordinances or parts of ordinances in conflict with the provisions of this ordinance be and the same are hereby repealed.

Section 9:

That this ordinance shall be in full force and effect from and after its passage and approval and publication as provided by law.

On Monday, March 4, 1968, Village President and Mrs. John H. D. Blanke made a special trip to Vandalia, Illinois. They went on special invitation of Ralph G. Newman, chairman of the Illinois Sesquicentennial Commission and of the Honorable Forrest L. Barbee, Mayor of Vandalia, to be their dinner guests.

One hundred and fifty years ago Illinois became the 21st State in the Union, hence the Illinois Sesquicentennial Celebration in 1968. For about two years Illinois State government was conducted at Kaskaskia. The City of Vandalia became State Capital in 1820, until in 1839 Springfield became the capital city. During the 19 years in which Vandalia was the State capital, 43 Illinois cities were incorporated.

Mayor Barbee, in cooperation with the Sesquicentennial Commission and with the cooperation of city personnel, sponsored City Charter Day on March 4. Events included a tour of the former State House, a reception at Moose Hall, and a dinner with program at the Vandalia High School.

Approximately 135 municipalities of Illinois were represented at Vandalia's City Charter Day. There were about 119 mayors or village presidents, many with their wives; and other municipalities were represented officially by other persons. During the recognition program each municipality that was represented received two flags, each four feet by six feet in size. One flag contained 21 stars, reminiscent of the 21 States in the Union when Illinois became a State. The other flag was an official Sesquicentennial flag which also contains 21 stars, with the large star in the corner representing Illinois. Both flags were given to the dinner guest with instructions that they become the property of the municipality represented by the guest, to be displayed during the Sesquicentennial Year. Each official representative received as personal keepsake a Sesquicentennial Medallion 2½ inches in diameter.

The two flags given to the Village of Barrington have been mounted in the village board meeting chamber for all visitors to see.

DISCONNECTION FROM WATER AND SEWER MAINS (VILLAGE CODE AMENDMENT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois, that:

Section 1: Article I of Chapter 24 of the Municipal Code of 1957, as amended, is further amended to add Section 24.109 which shall read as follows:

"24.109 Disconnection. Upon any disconnection from the Village water or sewer mains, said water and sewer mains shall be sealed by a licensed plumber and shall be inspected by the Village Building Commissioner before being covered.

"A fee of \$50.00 shall be paid for each disconnection from a sewer main and each disconnection from a water main."

Section 2: This ordinance shall be in full force and effect from and after its passage, approval, and publication as provided by law.

RE: SPOTTED SURVEYS RELATIVE TO BUILDING PERMITS

At the request of the Village Manager, we enclose an amendment to Section 19.106 of the Municipal Code. The new language is found in the last two paragraphs of the Section and the effect of the amendment is to add a requirement that a plat of survey prepared by a registered surveyor showing certain information be filed with the application for building permit. In addition, within fifteen (15) days after the foundation has been completed, a recertification of the survey must be filed showing such foundation.

The request for amendment arose because there have been instances of the Village approving building permits where the building was being located in an area reserved for easements or within a set back required by Village ordinances. In addition, some buildings have not been actually constructed at the planned locations and the Village has been unaware of the contractor's error until long after an occupancy permit was issued.

AN ORDINANCE AMENDING SECTION 19.106 OF THE MUNICIPAL CODE OF BARRINGTON OF 1957 (VILLAGE CODE AMENDMENT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois, that:

Section 1: Section 19.106 of the Municipal Code of Barrington of 1957, as amended, is further **a**mended to read as follows:

"19.106 APPLICATIONS: Applications for such permits shall be made to the Village Clerk and referred to the Building Commissioner. Four copies of an application shall be filed for building permits in the Lake County area of the Village. Five copies of an application shall be filed for building permits in the Cook County area of the Village and each copy shall contain the Real Estate Index number for the land on which the building is to be placed. Each set of four or five copies of application for building permit shall be accompanied by two sets of plans and specifications showing the work to be done which shall also be accompanied by an executed certificate of notification as to underground public utility facilities; such plans and certificate shall be verified by the signature, either of the owner of the premises or by the architect or contractor in charge of operations.

"Said applicant must also file a plat of survey prepared by a registered Illinois land surveyor showing lot dimensions, total area, all existing improvements, all easements of record, and all building and setback lines required by the zoning ordinance or any recorded document.

"After the foundation for a new building or any addition to an existing building has been completed, the applicant shall furnish a survey prepared by a registered Illinois surveyor showing the location of such foundation; this may be shown upon

a recertification of the plat filed at the time the building permit was secured. In the event that such plat is not filed within 15 days after said foundation is completed, all further work shall cease until said plat is filed; if the further work has been completed, no occupancy permit shall be issued until said plat is filed."

Section 2: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.

When we recommended that the former special police officers be appointed as temporary police by the Fire and Police Commission, we noted that such appointments could be for two consecutive sixty (60) day terms. We also suggested that if the Legislature failed to act to relieve the problem when it met in March, the probable course would be to name these persons as marshals.

As you know, the Legislature met on March 4 and promptly adjourned until July. Therefore, we now recommend that the Village adopt the enclosed ordinance establishing the offices of marshals and deputy marshals. This appears to be the route which other Villages will use, as much of the ordinance was taken from a suggestion by the Illinois Municipal League.

However, the Illinois Municipal League draft ordinance provided that the marshals should be under the direction and control of the Chief of Police. We feel that such provision could be dangerous, as it would be subject to the attack that the marshals were merely appointed to circumvent the Illinois case which condemned special police. Therefore, we have suggested, in Section 4.1005 of the enclosed ordinance, that the marshals merely cooperate with the Chief and coordinate their duties with the 'Chief. We would invite your attention to the fact that the marshals are appointed to serve at the pleasure of the President and Board of Trustees, as is the Chief. In the unlikely event that the Village marshals would cease cooperating with the Chief of Police, the Village Board could take appropriate action.

I see no danger that there would be a conflict between marshals and the Chief of Police whereby the Village Board would be required to take sides, since, as noted above, the Chief also serves at the pleasure of the Village Board.

Section 4.1007 of the enclosed ordinance meets the requirement that, with certain exceptions, all Village officers be bonded.

It does not appear that this ordinance needs to be published in the newspaper. However, to avoid any possible question in this regard, we suggest that there be publication. It would become effective ten (10) days after such publication. Therefore, we suggest that if the Village President promptly signs this ordinance and if its publication can be arranged for on March 14th, it will become effective on March 25th. On that date you could appoint the marshal and deputy marshals, approve the corporate surety on their bonds and provide that their appointment shall be effective on the date which coincides with the expiration of their previous sixty (60) day temporary appointment by the Board of Fire and Police Commissioners.

AN ORDINANCE ESTABLISHING THE OFFICES OF VILLAGE MARSHAL AND DEPUTY MARSHALS AND PROVIDING FOR THE OPERATION THEREOF (VILLAGE CODE AMENDMENT)

BE IT ORDAINED by the President and Board of Trustees of the Village of Barrington, Cook and Lake Counties, Illinois, that:

Section 1: Chapter 4 of the Municipal Code of Barrington of 1957, as amended, is further amended to add thereto the following Article X, consisting of Sections 4.1001 through 4.1007:

"ARTICLE X -- VILLAGE MARSHALL AND DEPUTY MARSHALS

"4.1001 Office of Marshal. There is hereby established the office of Village Marshal. The Village Marshal shall be an officer of the Village and shall be appointed by the Village President with the advice and consent of the Board of Trustees.

"4.1002 Office of Deputy Marshals. There is hereby established the office of Deputy Marshal. Deputy Marshals shall be officers of the Village and shall be appointed by the Village President with the advice and consent of the Board of Trustees in such number as the corporate authorities shall from time to time deem necessary.

"4.1003 Appointment and Term of Office. The Village Marshal and the Deputy Marshals shall serve at the discretion of the President and Board of Trustees and may be removed from office at the will of the President and Board of Trustees. The Village Marshal and the Deputy Marshals shall receive such compensation for their services as determined by the corporate authorities.

"4.1004 Status. The Village Marshal when functioning as Marshal and the Deputy Marshals shall not be members of the regular police department of the Village and shall not perform services on a full-time basis. Uniforms and identification symbols of the Marshal and Deputy Marshals shall be different and distinct from those used by members of the police department of the Village in at least the following respects: shirts, shoulder patches, emblems and hats.

"4.1005 Duties. Deputy Marshals shall perform such duties as directed by the Village Marshal or by the corporate authorities. The Village Marshal shall cooperate with the Chief of Police of the Village and shall coordinate his duties and the duties of the Deputy Marshals with such Chief of Police. Deputy Marshals shall not carry firearms except with the special permission of the Chief of Police, and when in uniform and while in the performance of their duties.

"4.1006 Conservators of Peace -- Additional Duties.
The Village Marshal and the Deputy Marshals shall be conservators of the peace and shall have the following powers and duties:

- (a) to arrest or cause to be arrested, with or without process, all persons who break the peace or are violating any municipal ordinance or any criminal law of the State;
- (b) to commit arrested persons for examination;
- (c) to serve and execute all warrants for the violation of municipal ordinances or the State criminal law within the limits of the Village;
- (d) all statutory and common law power of sheriffs;
- (e) to direct traffic and assist in traffic control;
- (f) to act as watchmen on special assignments;
- (g) to assist in parade control and to keep peace in all large gatherings in and about the community;
- (h) to assist in Civil Defense matters;
- (i) to assist in cases of riot, disaster and emergency control; and,
- (j) to perform such other related duties as directed by the Chief of Police of the corporate authorities.

"4.1007 Bonds. The Village Marshal and Deputy Marshals so appointed shall at the time of their appointment execute and deliver to the Village a bond in the amount of \$500.00 with sureties to be approved by the corporate authorities and conditioned upon faithful performance of the duties of the office, as required by law."

Section 2: All ordinances or parts of ordinances in conflict with the provisions of this ordinance be and the same are hereby repealed. This ordinance shall be in full force and effect from and after its passage and approval and publication as provided by law.
