A special meeting of the Session of the Presbyterian Church of Barrington was held in the Manse at eight o'clock on the evening of November 29, 1960.

The meeting was opened with prayer by The Reverend Winchester. The minutes of the meeting of October 4th were read and approved.

The purpose of the special meeting was to consider recommendations of the Building Committee to purchase an additional five acres of land adjoining our building site for the following reasons:

"First, there is the location of the buildings on the site. This additional land will permit greater latitude by the architects in the general layout of the buildings on the master plan and permit more intelligent development of the site, taking into consideration driveways, parking area, gardens, etc. Several architects have confirmed this;

Secondly, in the long range planning the desirability of locating the Manse on the site is generally recognized as sound. The present zoning ordinance, requiring a five-acre residential site, would preclude any further addition of the Manse unless the additional five acres were purchased;

'Thirdly, this additional land would permit a better and safer entrance for both access and egress from Brinker Road. At present our land does not include the highpoint of the road to the south and this, in effect, creates a blind entrance for cars coming from the south and is an obvious hazard;

'Lastly, this land we understand is presently available. We are all aware of the great housing development throughout the countryside and know how rapidly building sites are being developed. It is reasonable to believe that this five-acre site would not normally be on the market for any extended period. Once sold to others, it would be highly unlikely that it would ever be available to our church again. In the long range planning, we believe this consideration to be most important.

A motion was made that the Session approve the Building Committee's recommend to go ahead with the purchase of the five acres. The motion was seconded and p by a vote of five to two with two abstentions.

A motion was made that a manse be included in the architect's drawings, if we have a twelve-acre site. This motion was seconded and carried by a voice vote

The trustees were then instructed to proceed to approach the Extension Board to authorize the purchase of the five acress and report back to the Session. It was the consensus that the property will not be purchased without further action by the Session.

The matter of the contract with the architects was discussed. Mr. Boand moved the Building Committee be authorized to recommend to the Extension Board that we enter into a contract with Faulker and Associates as drawn up in document dated November 11th, but only after negotiating such of the changes as pointed out in letter to The Reverend Winchester by Mr. Boand of November 28, 1960 as are practicable. The motion was seconded and unanimously approved.


istian Education Committee report was submitted by Mr. Rose, chairman:
