

HEARS RAIL CHIEFS

PRESIDENTS OF SIX BIG TRAFFIC COMPANIES PROTEST TO TAFT.

GO AWAY RATHER REJECTED

They Were Not Successful in Bringing President to Their Way of Thinking—Message to Congress Will Be Divided.

Washington.—The visit of the presidents of six of the railroads to the White House Monday to enter a protest against the proposed changes in the railroad law was not a success, neither successful in bringing the president to their way of thinking, nor to Congress to have a vote in the measure to come on the subject.

The presidents, rather defeated when they left the White House, and it was inferred, in their minds, that the president's special message was concerned was a failure.

President Taft announced a change of program to a meeting of his cabinet and with railroad leaders and anti-trust law advocates to the White House. Washington and Robert E. Lee were invited.

The message will be voted on partly.

The section dealing with railroads will be submitted to Congress. The section dealing with the interstate steamship traffic will be introduced, he will defer until Friday noon.

As far as the railroads, the railroad presidents it was said only a few verbal changes would be made in the bill, and the bill will go with the interstate commerce law and that would be only to the end of clarifying the railroad nominations.

President Taft found the railroad men more conciliatory in presenting their views. While departing the White House, he said: "I think at this time when they declared, conditions in the railroad and industrial works are right, and I think they will be for years or more or less depression, they did not seek any date when they would come to the White House." They devoted themselves to more or less negotiations with Attorney General Wickham, whom forms the text of the message. The railroad leaders were not in any attempt to force the Wickham or any other bill up Congress.

LARGEST MERGER IN U. S.

Interests Now Controlled by J. Pierpont Morgan Aggregate \$1,800,000,000.

New York.—Sixty million dollars were added to the combinations of capital of the railroads when a merger by a merger with the Thomas P. Ryan and Levi P. Morton trust companies was completed, making the banking unit under Morgan's direction up to \$1,800,000,000.

The railroads in this transaction are the New York Life, Fireman's Fund, and Capital and the Equitable, purchased December 1, 1895, with \$162,000,000.

The merger, which by Morgan's New York and Morton hands in New York and by the Ryan and Morton hands in Boston, in a triple combination, bringing the Florida Trust Company, the 50% owned Trust Company, all of this city under one roof, was completed by the Morgan trust company. Morgan owned the Guaranty Trust Company. The merger was the largest of its kind in the United States.

MORSE IS NUMBER 2,814

Former Banker Reaches Atlanta Prison Will Be Assigned to State.

Atlanta.—Charles Wm. Morse, former "the king" and millionaire banker, Monday began his sentence in the state prison at Atlanta federal prison for violating either of the national banking laws.

LEE'S STATUE TO BE FIXTURE

WILL REMAIN IN STATUARY HALL DESPITE PROTESTS.

No Effort Will Be Made to Have It Removed or Altered by Congress.

Washington.—The marble statue of Gen. Robert E. Lee in the hall of the House of Representatives will stand in Statuary Hall at the capitol, and probably will remain there until the end of the session, despite the protest of those men who dislike such honor being conferred on the great rebel.

It has been definitely determined that the statue formally accepted by Congress, and no ceremony will be held to mark the removal of the statue having been done long ago without services of any kind.

The statue, which is not to be allowed to place two statues of its most distinguished son in Statuary Hall, was accepted by Congress and proposed to donate statues of Lee, Washington and Robert E. Lee.
