NOTICE is hereby given that the said Collector of Cook County will apply to the County Court of Cook County on the 17th day of December, A. D. 1933, for judgment against lands and lots hereinafter described as being delinquent upon which taxes remain due and unpaid, or personal property taxes charged thereon as such, and in said advertisement, remain due and unpaid, for said taxes, and the costs, and for an order to sell said lands and lots for the satisfaction thereof according to law (excepting from said judgment and order of sale the cases where the taxes on the advertisement for sale only under former unexecuted judgments and orders of sale as may be noted in this advertisement.)

Notice is also given that payment under protest is not required in this return and that an application will be made to the court at the same time for judgment fixing the correct amount of such taxes paid under protest and for judgments and order of sale on such payments in accordance with law.

Notice is further herein and hereby given that on the Second Monday next succeeding the 17th day of December, A. D. 1933, to-wit, the Nineteenth day of December, A. D. 1933, at the hour of 8 o'clock A. M. all said lands and lots hereinafter described for sale of which an order shall be made, or has heretofore been made, but not executed as noted, will be exposed to public sale at the County Building of Cook County, Illinois, in and for the amount of the interest and costs due thereon respectively.

The following is a list of delinquent lands and lots for which the County Court is held in said County for the amount of the interest and costs due thereon respectively.

EXPLANATORY NOTE - In this list in all parts and in no other notation is made the figures in the column headed "Acres" (meaning dollars) and "Cts." (meaning cents) represent the taxes due and unpaid for the year 1933. Payments under protest are indicated by (P) in front of amount said. Where the amount is placed to the left of the figures in this column it is intended for an abbreviation of the word "Forfeiture," and denotes that the amounts set down to the left of the figures are the amounts due and unpaid on said lands and lots hereinafter said lands and lots have been previously forfeited to the state. When such taxes are due for one year or years for which such taxes are placed to the left of the amount.
